Warranty Coverage

Watchdog warrants the Covered Product as shown in the Coverage Details (Attachment A) from start date _____, for any failure that is proven to be a failure in material or workmanship under normal use during the applicable warranty period that is not otherwise attributable to a warranty exclusion as set forth in this agreement. This warranty extends to the original buyer only.

Any part or parts thereof replaced during the base warranty period assumes the remainder of that warranty period or the parts warranty period, whichever is greater. The warranty coverage for the PRODUCT is continual from the original date of purchase and does not restart upon the replacement of any part or complete unit. This coverage is limited to parts and labor. The warranty for replacement parts is limited to direct replacement only with no allowance for freight or transportation charges.

Reimbursement of labor charges to replace a defective part within its warranty period will be limited only to authorized Watchdog service centers and then only if the authorized service center installs the replacement part. Travel time and expenses are not covered, authorized, or reimbursed.

Watchdog reserves the right to repair or replace any part, component, or assembly at its option. Watchdog may request defective parts be returned for examination before the issuance of credit. Any item that is replaced under warranty becomes the property of Watchdog.

Warranty Exclusions

THIS WARRANTY SHALL NOT APPLY TO ANY PRODUCT OR PARTS THEREOF THAT MUST BE REPLACED BECAUSE OF NORMAL WEAR; THAT HAS BEEN SUBJECT TO ALTERATION, MISUSE, NEGLIGENCE, ACCIDENT OR COLLISION, NATURAL DISASTER OR ACTS OF NATURE; THAT HAS BEEN DAMAGED DUE TO

SHIPPING, TRANSPORT OR HANDLING; ANY FLUID CONTAMINATION OR DEGRADATION; THAT HAS FAILED DUE TO MISAPPLICATION OR USE OF THE PRODUCT IN A MANNER INCONSISTENT WITH SUCH PRODUCT'S DESIGN OR INTENDED PURPOSE, INCLUDING BUT NOT LIMITED TO DAMAGE CAUSED BY CONNECTION TO OR OPERATION OF ELECTRICAL EQUIPMENT AT VOLTAGES OTHER THAN THE RANGE SPECIFIED FOR THE PRODUCT; OR THAT HAS BEEN SUBJECT TO ANY OTHER ACT, OMISSION (INCLUDING PROPER MAINTENANCE) OR CIRCUMSTANCE BEYOND WATCHDOG'S REASONABLE CONTROL INCLUDING BUT NOT LIMITED TO CORRECTIVE WORK NECESSITATED BY REPAIRS MADE BY ANYONE OTHER THAN A WATCHDOG AUTHORIZED SERVICE TECHNICIAN

USE OF ANY PRODUCT OR REPLACEMENT PARTS OTHER THAN WATCHDOG AUTHORIZED REPLACEMENT PARTS PURCHASED THROUGH WATCHDOG OR AN AUTHORIZED WATCHDOG DISTRIBUTOR OR DEALER SHALL VOID THIS WARRANTY.

Disclaimer of Consequential Damage and Limitation of Implied Warranties

THIS WARRANTY, AND WATCHDOG'S OBLIGATION HEREUNDER, IS IN LIEU OF ALL OTHER WARRANTIES, EXPRESS, IMPLIED, OR STATUTORY, INCLUDING ANY WARRANTIES OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE, AND ALL OTHER OBLIGATIONS OR LIABILITIES INCLUDING SPECIAL OR CONSEQUENTIAL DAMAGES OR CONTINGENT LIABILITIES ARISING OUT OF THE FAILURE OF ANY PRODUCT OR PART TO OPERATE PROPERLY.

WATCHDOG DENIES ANY RESPONSIBILITY FOR LOSS OF TIME OR USE OF THE PRODUCT, TRANSPORTATION, COMMERCIAL LOSS, OR ANY OTHER INCIDENTAL OR CONSEQUENTIAL DAMAGE INCLUDING BUT NOT LIMITED TO SPECIAL OR INDIRECT DAMAGES WHETHER ARISING FROM CONTRACT, TORT, OR WARRANTY BEYOND THE WARRANTY STATED HEREIN FOR PRODUCTS OR PARTS. ANY IMPLIED WARRANTIES ARE LIMITED TO THE DURATION OF THIS WRITTEN LIMITED WARRANTY.

NO PERSON IS AUTHORIZED TO GIVE ANY OTHER WARRANTY OR TO ASSUME ANY ADDITIONAL OBLIGATION ON WATCHDOG'S BEHALF UNLESS MADE IN

WRITING AND SIGNED BY AN OFFICER OF WATCHDOG.

How to Obtain Warranty Service

The buyer must notify Watchdog by calling the toll-free number 833-4-THE-DOG (833-484-3364) of any defect, malfunction, or nonconformity promptly upon discovery. An authorized representative shall respond to the call within 48 hours of receipt of the call.

Watchdog shall in its sole discretion based on the information provided by the buyer determine whether the warranty applies. Watchdog reserves the right to revise its determination of the applicability of this warranty at any time.

If Watchdog determines the warranty applies Watchdog shall in its sole discretion either:

Direct the Buyer to return the defective COVERED PRODUCT or Part to Watchdog for repair or replacement. In such instances, Watchdog recommends that the buyer insure the shipment and send it return receipt requested as Watchdog accepts no liability for products lost or misplaced in shipment; **or**

Direct the Buyer to take the PRODUCT to an authorized Watchdog service center, who will do one of the following:

1. Service or repair the Covered Product in accordance with this warranty; or
2. Direct the buyer to an independent repair or service facility to perform service or repair in accordance with this warranty; or
3. Replace the Covered Product with goods that are identical or reasonably equivalent to the warranted goods.

Registration Card

We recommend that the buyer fill out and send in the registration card included in the original package of the Covered Product. This will facilitate any warranty repairs or service, if needed. It is not required that the buyer send in this registration card for this warranty to be effective.

Notice to Buyer and Dispute Resolution

This warranty gives you specific legal rights, and you may also have other rights which vary from state to state.

Pursuant to this warranty, if the buyer disagrees over the performance under the terms of this warranty, the buyer agrees to submit the matter for resolution to Watchdog Equipment Corporate, at 702-460-2638 or 702- 445-3753. The buyer agrees that it is required to submit any dispute for resolution under this paragraph before pursuing any legal remedies to which he or she may be entitled.
