## Information and Regulations

**SHOW LOCATION:** New Grace Apostolic Temple, 2898 Packard Rd., Ann Arbor, MI 48108

**DATE:** Saturday, October 17, 2020 **TIME:** 10:00 am –4:00 pm

**SPACE SIZE/COSTS:** Various space sizes are available (see Application Form). Limited electricity will be available for an additional \$10.00 charge. *If you desire electricity, please request electricity on your application form.*

**SET-UP:** Early set -up on Friday, Oct.16<sup>th</sup> is available between 6:00 pm - 8:30 pm. Saturday, Oct. 17<sup>th</sup> set up begins at 7:00 am. All set ups must be completed by 9:45 am. The show begins promptly at 10:00 am. Carts and volunteer staffing is available to assist with unloading.

**EXHIBITS:** Exhibitors must bring their own table(s) or booth set up that will fit in the requested space & leaving appropriate seating & exit space within the allotted space measurements. Most 3' deep spaces are against a wall and do not allow room for your seating behind your table. Seating would have to be on the side. Tables must be covered to the floor on all three sides (no plastic covering please). Keep aisles always clear . If using electricity, bring a heavy- duty 12-14-gauge extension cord and a **power strip/surge protector with an internal circuit breaker & plastic external case.**

**EXHIBITOR:** Work must be the exhibitor's own original design and execution. All work must be hand-made. We do not allow items made with kits or resale items. This is a juried show allowing quality work only. Exhibitors are responsible for their own Michigan Sales Tax. **Absolutely no exhibitor raffles, specials, or price reductions allowed during the show. Exhibitors must not tear down or begin to pack up until 4:00 pm when the show closes. No resell or exchange of booth locations with other exhibitors.**

**EXHIBITORS LIABILITY:** Exhibitors **must** accept full responsibility for any loss, injury, or damage to persons or personal property that may be sustained while on said property. New Grace Apostolic Temple will exercise every possible care and precaution but will assume **no** responsibility whatsoever for any property in the exhibit areas, on the premises, or in any of the parking areas.

**BOOTH RESERVATION:** Payment must accompany signed contract at time of applying. Payments can be by check, money order, or VISA/MC. Make out all checks and money orders payable to: **New Grace Apostolic Temple or NGAT.** Mail to PO address listed below along with the application. **Applications deadline is July 1st, 2020 and notifications sent to you upon acceptance.** Pending vacancies, **late applications are accepted after July 2nd until show is full but must accompany a \$20.00 late fee.** Absolutely no refunds or credits issued after acceptance to the show. Refunds and credits not issued for cancellations or no shows.

**FOOD:** Free complimentary continental breakfast furnished for exhibitors during set-up on Saturday morning. Lunch and Beverages can be pre-ordered in advance and paid at check in. These lunches are delivered to your booth. Menus will be included in your final information packet. Complimentary beverages (coffee, tea, water, juice) will be available during the show. Other concessions and baked goods are available for sale.

**Children:** There is no childcare and adults must always accompany their children and stay with them during the children activities. Please do not bring young children with while you are participating as an exhibitor at this show.
