Robert Bridges has a story to tell after 20 years of cleaning homeless encampments under contract with the California Department of Transportation. The company is seeking a movie deal to share its roadmap for ending homelessness in America, one that could serve as a model for the entire country.

With the company being Black-owned, discriminatory practices at Caltrans led to a lawsuit filed in the Superior Court of California, County of Sacramento. The outcome of the case is still pending.

On March 6, 2025, the Honorable Judge Richard K. Sueyoshi, in the Hall of Justice, denied Caltrans' request to quash the case and be released from default. The case was later transferred by the Honorable Judge Steven M. Gevercer to Civil Home Court Judge Julie G. Yap. On May 5, 2025, the court granted relief from default.

A hearing on the demurrer was scheduled for December 15, 2025 has been continued to February 5, 2025 following the reassignment of Judge Julie G. Yap to Civil Home Court. She is replacing the Honorable Judge Richard K. Sueyoshi in the hall of justice.

24 Plaintiff **Robert Bridges** ("Plaintiff") respectfully submits the following **Opposition to Defendant California**  
25 **Department of Transportation's** ("Caltrans") Demurrer to Plaintiff's Complaint.

26 This Opposition is based on this Notice, the accompanying Memorandum of Points and Authorities, the Declaration  
27 of Robert Bridges, all pleadings and papers on file in this action, and any oral argument presented at the hearing.

28  
19 MEMORANDUM OF POINTS AND AUTHORITIES

20 I. INTRODUCTION

21 Defendant Caltrans' Demurrer should be **overruled in its entirety**. Plaintiff's Complaint sufficiently states causes  
22 of action under California law. The Demurrer is procedurally and substantively defective because it **ignores well-**  
23 **pleaded factual allegations**, improperly requests factual determinations at the pleading stage, and fails to construe  
24 the Complaint liberally as required for a self-represented litigant.

25 This case arises from Caltrans' pattern of **discriminatory contracting practices** that resulted in Plaintiff — a long-  
26 established, qualified Black contractor with over 46 years of experience — being **unlawfully excluded** from  
27 continuing business with the agency after demonstrating success in prior projects.

2 **II. STANDARD OF REVIEW**

3 On demurrer, **all properly pleaded material facts** in the Complaint must be **accepted as true**. (*Blank v. Kirwan*  
4 (1985) 39 Cal.3d 311, 318.) A demurrer tests the **legal sufficiency** of the complaint, not the truth of the allegations  
5 or the ability to prove them. (*Hahn v. Mirda* (2007) 147 Cal.App.4th 740, 747.)

6 Further, courts are required to **liberally construe pleadings** with a view toward **substantial justice**. (Code Civ.  
7 Proc. §452.)

9 **III. ARGUMENT**

10 **A. Plaintiff Has Properly Stated Causes of Action**

11 Plaintiff's Complaint alleges facts sufficient to support causes of action including **discrimination, retaliation, and**  
12 **interference with contractual relationships**. Plaintiff detailed specific conduct by Caltrans management that  
13 hindered his ability to continue contracting with the agency — including withholding opportunities, failing to  
14 provide required documentation, and interfering with previously approved work.

15 Under **Government Code §12940 et seq. (FEHA)**, such acts constitute unlawful discrimination and retaliation  
16 based on race and protected status.

18 **B. Plaintiff Is a Member of a Protected Class**

19 As stated in the Complaint and as acknowledged by Defendant, Plaintiff is a **member of a protected class** under  
20 California's Fair Employment and Housing Act (FEHA). The Complaint clearly alleges that Plaintiff's exclusion  
21 from Caltrans contracting opportunities was **motivated by race and retaliation**, which is actionable under FEHA  
22 and federal civil rights laws (42 U.S.C. §1981).

24 **C. Defendant's Arguments Go Beyond the Face of the Complaint**

25 A demurrer cannot rely on facts outside the four corners of the pleading. (*Donabedian v. Mercury Ins. Co.* (2004)  
26 116 Cal.App.4th 968, 994.)

27 Defendant's attempt to introduce factual disputes — such as alleged procedural compliance or internal

1 administrative processes — are **improper at the demurrer stage** and should be addressed, if at all, at summary  
2 judgment or trial.

3

4 **D. Any Deficiencies Can Be Cured by Amendment**

5 Even if the Court finds that any cause of action is insufficiently pled, **leave to amend must be granted**. California  
6 law strongly favors resolving cases on their merits. (*Aubry v. Tri-City Hospital Dist.* (1992) 2 Cal.4th 962, 970–  
7 971.)

8 Plaintiff, appearing in **pro per**, has alleged substantial facts demonstrating misconduct by Caltrans and should be  
9 granted the opportunity to amend if necessary.

10

11 **IV. CONCLUSION**

12 For all the foregoing reasons, Plaintiff respectfully requests that this Court:

13 1. **OVERRULE Defendant's Demurrer** in its entirety;

14 2. Alternatively, **grant Plaintiff leave to amend** the Complaint to clarify or supplement any factual  
15 allegations the Court deems insufficient; and

16 3. Award any further relief the Court deems just and proper.

## Robert L. Bridges History

I started out as a painting contractor in 1976 at 20 years old. I was a union painting contractor with 20 employees. At that time, there were only three Black union painting contractors: Robert Bridges Painting, Owen Smith (Mr. Smith), President of Anzalone & Associates, and Sam Brown Painting. Mr. Smith was also the treasurer of the painters' union.

Mr. Smith was a very soft-spoken but powerful man. I remember when we met — I was painting the Santa Barbara Main refurbishment project, and Mr. Smith was working on a large project in the area. He called me to see if I was having any trouble with the Santa Barbara Local Union and told me that he was preparing to file a lawsuit. I couldn't help but feel I was getting the red-carpet treatment, likely because of Mr. Smith's pending lawsuit.

On one occasion, all the union contractors had a meeting in a large auditorium, with approximately 900 contractors present. The workers, rank and file, wanted a raise or they would strike. In attendance, there were only two Black contractors: me and Mr. Smith, who was on stage conducting the meeting with two other white men. The first vote, 'let them strike,' was taken, and Mr. Smith and the other two men had a conversation. The second vote, 'let them strike,' was taken, and again Mr. Smith and the men on stage had a conversation. On the third vote, 'no strike,' Mr. Smith and the other men said, 'Meeting adjourned.'

Mr. Smith retired around the age of 80. He said his last project was painting the Hyperion sewage treatment plant, where the inspector kept requesting additional coats of paint due to the mil thickness. The requests didn't stop until the paint manufacturer sided with Mr. Smith. Mr. Smith said he lost \$1 million. Thankfully, in appreciation for his many years of service, the general contractor, Tutor-Saliba, gave him \$500,000.

What I intend to prove with the Mr. Smith story is that there is a pattern: when Black public works contractors start to get too large, they are torpedoed at some point. The only reason Mr. Smith survived so long was because he was well-connected to Tutor-Saliba, one of California's largest contractors, and the union.

## **CENTURY FREEWAY AFFIRMATIVE ACTION COMMITTEE, Named Robert Bridges Prime Housing Contractor Year. I-105 Freeway in 1988a**

The Century Freeway Affirmative Action Committee (CFAAC) was established in part to a federal court consent decree in which Caltrans agree to build affordable housing for displaced residents. Minorities - and woman-owned businesses received were to receive a percentage of the contracts and services from the construction of the I-105 freeway. The I-105 freeway cut through Hawthorne, Inglewood, South-Central L.A., Downey, and Norwalk. A significant portion of the population in Inglewood and South-Central L.A. was Black during this period. Caltrans, under the consent decree, was ordered to comply with CFAAC.

After being a subcontractor working for both union and non-union general contractors, I felt it was time to become a general contractor. My first project with Caltrans was to refurbish a house in Inglewood. While I understood the contracting process, the only trade I was proficient in was painting. I soon realized that I also needed financial help in order to fully capitalize on the I-105 project. So, I reached out to Homer Dunn Painting Inc. Mr. Dunn was a competitor at the Los Angeles Unified School District and Southern California's largest non-union painting contractor. Mr. Dunn was also a neighbor to Barry White, the famous Black singer. We agreed to a joint venture: Dunn, Bridges, Leonard — Mitch Leonard, Mr. Dunn's field superintendent — and we formed D.B.L. Refurbishing Co.

With Mr. Dunn's financial backing, Mitch's taskmaster attitude, and my bidding and project management skills, we quickly capitalized on bidding opportunities in South-Central, Inglewood, and Hawthorne. Then I received word of a white woman in Downey trying to enter the process. I reached out to Nina Tate, the owner of Nationwide Construction, and we formed Nationwide Construction JV. Ms. Tate, now deceased, was the CPA for Franklin Steel, an I-105 freeway supplier. I began consulting Ms. Tate on the bidding process to relocate housing from Inglewood to Downey, provided subcontractors, and handled all the painting.

Sacramento sent an inspector named Phil—I don't remember his last name. Phil was a very demanding inspector. I remember painting a house for Nationwide JV in Downey, and Phil drew circles all over the interior after the painting. Then I received word that Phil was inspecting in South-Central L.A. and was punched in the mouth. That was the last I heard of Phil inspecting in South-Central L.A. I'm not sure what took place between Ms. Tate and Phil, but when the housing project ended, Nationwide Construction sued Caltrans and settled out of court. Ms. Tate complained that most of the settlement went to attorney fees.

The housing project was ended by the Caltrans housing project administrator because all housing bids were being submitted by my company. I met with the director in his Inglewood

office, and we agreed that I would keep 50% of the existing bids prior to the termination of the housing project, and I accepted.

At the end of the housing project, I bid and won a contract for an addition at the VA hospital. I hired a white union man as my superintendent to oversee the project, which was under one million dollars. During the project, an inspector from a foreign country tried to give me a hard time. My superintendent stepped in, shut him down, and the project was completed on time with no issues. Homer Dunn moved on without DBL Refurbishing and hired the white union superintendent. He obtained \$10 million in contracts to perform construction for LAUSD. I remember him saying, 'Bob, I'm going to make millions of dollars.' Then, months later, I received notice from his bonding company that Homer Dunn was filing for bankruptcy and asking if I was involved. Homer and his family took it hard, losing everything. His father took his own life, and a few years later, Homer Dunn died at under 50 years old.

My take on Homer Dunn was that he did not understand construction politics. He entered the organized union labor market as a non-union Black contractor.



## **REBUILT L.A. PROGRAM-1991**

After the Rodney King riots in 1991, the City of Los Angeles initiated the Rebuild L.A. program. It was partly comprised of major contractors who were willing to collaborate with smaller contractors. The riots caused more than \$1 billion in damages. I was invited to attend a committee meeting where I met the president of Dinwiddie Construction. At that time, Dinwiddie was one of California's largest contractors, responsible for building the Getty Museum. We met and agreed to form Team to help rebuild L.A.

Von's Market was bidding on a \$5 million project to construct its largest supermarket in the state, located in Inglewood, CA. I met with Dinwiddie's president, and we agreed to bid on the project, with Robert L. Bridges acting as a mentor partner.

During the closed-door bidding process, I was also able to negotiate a deal for the community to perform \$1 million worth of work with my own company and local work force the work included masonry, reinforcing, and painting.

After completing the masonry work on Von's Market, I secured additional contracts with Amoroso Construction to handle the masonry on two projects for First AME Church, called Fame Manors. These were multi-million-dollar low-income housing projects, along with other projects in South Central Los Angeles. I became the largest small business employer of Black workers in Southern California, employing four project managers and 80 construction workers, all earning prevailing wages comparable to union wages.

In August 1995, Robert Bridges received the 1995 BAPAC Community Service Award for his outstanding service to the young people in the community, providing training and employment opportunities. United States Senator Dianne Feinstein wrote, "Robert L. Bridges demonstrates how one person can truly make a difference.


## Black Contracting Firm Learns, Grows in Rebuild L.A. Program

INGLEWOOD — Robert Bridges' biggest project has caused him plenty of sleepless nights and stressful days, but the South Los Angeles contractor isn't complaining.

His RLB Construction Inc. got its largest contract to date through Rebuild L.A.'s mentor program — building the Vons market at 100 E. Manchester Blvd. in a joint effort with Dinwiddie Construction Co.

The mentor program puts together large firms like Los Angeles-based Dinwiddie with smaller, often minority-owned companies like RLB to bid for a job as a team. The idea is that the smaller firm will work, learn and grow with the help of its mentor.



About 25 percent completed, a new Vons market is expected to open in Inglewood next March. The market is being built by the minority-owned firm RLB Construction Inc. in conjunction with Dinwiddie Construction Co.



In 2001, RBPAC and Lorraine Bridges were under contract with the California Department of Corrections in Region III to provide residential abuse services for adult male offenders exiting the prison system on parole. In 2003, the Department of Corrections provided notice that the services had been satisfactory for 2.5 years.

In 2002, BF, also known as Robert Bridges Group Home, established a positive working relationship with the California Department of the Youth Authority. Under contract with the agency, they provided job training, housing, and drug and alcohol counseling.

Black Foundation Alcohol and Drug Program Licensed by the State of California Department of Alcohol and Drug Programs. Provided individual sections for recovery, treatment planning, group sections and educational sections.

Robert Bridges and the Black Foundation Food Bank, in agreement with the Los Angeles Regional Food Bank, participated in the Emergency Food Assistance Program. The Black Foundation distributed food weekly to those in need in the local community.

In August of 1993, then-Councilmember Nate Holden of the 10th District paid tribute to the Black Foundation for its outstanding citizenship and contributions to enhancing community betterment.




