Hello Cabin Branch Forest Neighbors,

A proposal has been submitted to the board to amend the current protective covenant regarding the use of pools in the community that are not permanent in ground pools. The article up for amendment is protective covenant #10 and it reads as follows:

"Patios, In-ground Pools & Major Landscaping —While there are no hard and fast rules for these types of modifications; they will almost always be allowed in the rear quadrant of the lot. Architectural Change Requests will be reviewed for suitability with the surrounding architecture, compliance with existing Covenants & Rules and interference with or hardships caused to the surrounding neighbors. Above ground pools are specifically prohibited, however small toddler wading pools are permitted."

The proposed change would allow for "storable pools" that are placed in an owner's back quadrant for the summer months, but stored from the beginning of fall through the end of spring, and are kept in sanitary condition (no stagnant water). **STORABLE POOLS** ARE THOSE THAT ARE CONSTRUCTED ON OR ABOVE THE GROUND, AND ARE CAPABLE OF HOLDING. WATER TO A MAXIMUM DEPTH OF 42 INCHES (1.0 M), OR A **POOL** WITH NON-METALLIC, MOLDED POLYMERIC WALLS, OR INFLATABLE FABRIC WALLS REGARDLESS OF DIMENSION.

The proposal would change the scope an allowable non inground pool in the back quadrant of the home in the following ways:

- Allowable Depth
 - Currently 18 inches as is defined by Loudoun county as a toddler wading pool
 - Proposed new allowable depth up to 42 inches
- Typical volume: 26 gallons (typical kiddie pool) to 3380 gallons (free standing storable pool)
- Allowable deployment timeframe

- Currently daily use assumed
- Proposed Seasonal use allowed potentially 99 contiguous days between
 Memorial Day and Labor Day (not sure if it is greater than that based on some hot months before and after but up to discussion)
- Note that seasonal use only applies to storable pools and the proposal only looks to limit the date range for storable pools not toddler wading pools which could be used year round
- The Virginia Code, Section 305.5 of the 2015 Virginia Swimming Pool and Spa Code STORABLE SWIMMING, WADING OR IMMERSION POOLS; OR STORABLE/PORTABLE SPAS AND HOT TUBS - Those that are constructed on or above the ground and are capable of holding water with a maximum depth of 42 inches (1067 mm), or a pool with nonmetallic, molded polymeric walls or inflatable fabric walls regardless of dimension.

- These are **not** exempt from barrier or fencing requirements created by the law. This requires a 48" fence with latches @54" high and any doors opening into the area barrier area have alarms. This is intended to keep small children from wandering into the pool unsupervised.
- Any and all storable swimming pools must adhere to the safety and regulatory requirements of the 2015 International Swimming Pool and Spa Code, Chapter 3
 (https://codes.iccsafe.org/content/ISPSC2015/chapter-3-general-compliance) and Chapter 7 (https://codes.iccsafe.org/content/ISPSC2015/chapter-7-onground-storable-residential-swimming-pools) **
 - ** The 2018 International Swimming Pool and Spa Code goes into effect
 1 July 2021 (https://codes.iccsafe.org/content/ISPSC2018/effective-use-of-the-international-swimming-pool-and-spa-code)

The Board would like as much community feedback as possible on this issue. Please note that your feedback will be kept strictly confidential, and only shared with the Board and the Covenants Committee.
