Rotherwood Apartments: Check with Devlon if rebate for water heater installed

Old Business:

*Daycare Discussion: Shad met with Loy, Ivanhoe school Superintendent, and contractors to look at the school area for development of a daycare. There is the possibility for two daycares to operate in the space available. The contractors will make a proposal of cost estimates, Loy will check with Fire Marshall, and once information is gathered the EDA would begin to advertise for interested daycare providers before they would make an investment.

*Hendricks Elevator: Have current lease of the land through August 15, 2024. The Henricks Elevator plan to purchase the property and plan to put a scale and shack on the property in 2024, and eventually build an elevator on the land. The lots to be purchased are 2,3,10, 11, at \$25,000 with TIF district development. A formal development plan includes a floor plan, blueprint, and approval from the city attorney and City of Ivanhoe zoning and ordinance for approval. The development agreement would be signed by both parties. The development agreement would include that the property could not be assigned to another person without the written consent of the EDA

Jeanne Bednarek made a motion to approve the sale of Lots 2,3,10,11 for \$25,000 to the Hendricks Elevator with the approval of the City Attorney a development plan, and with zoning and permits approved by the City of Ivanhoe, seconded by Callie Velazquez and unanimously carried.

*Skorbinski Customs: Would like to purchase Lots 1,2 of Block 2 of the Railroad Addition. A 40 x 80' building with stud walls, in 2 tone steel (white or grey) to match the roof and would like to begin before winter. A formal development plan includes a floor plan, blueprint, and approval from the city attorney and City of Ivanhoe zoning and ordinance for approval. The development agreement would be signed by both parties. The development agreement would include that the property could not be assigned to another person without the written consent of the EDA.

Dennis Klingbile made a motion was made to approve the sale of Lots 1,2 of Block 2 of Railroad addition to Wayne Skorbinski with the approval of the City Attorney a development plan, and with zoning and permits approved by the City of Ivanhoe, seconded by Callie Velazquez and unanimously carried.

*Cafe: Robert Coleman of Arlington, SD has presented a business plan, which would include laundry facilities, apartments, and possible food establishment. The EDA discussed the \$40,000 (forgivable loan for 5 years with specifics to be developed. The loan funds would be available for reimbursement by invoice only, could not be used for labor, can be used for materials, are subject to inspection, and is not assignable without written consent of EDA. The property could not be sold. The development agreement would be signed by both parties with the approval of the City Attorney to enter into an agreement of sale.

*Lots on the west side of town: Shad contacted James Carr regarding development of the properties (housing). The city is working to find a engineering company to give estimates on developing the land.

Advertising: The Ivanhoe Community Club is working on getting signs purchased by business for out at Gislason Field for \$250 each.
