Rotherwood Apartments:

a. FMV rent is needed for 51% of tenants at Rotherwood Apartments to meet SCDP loan requirements. This will be the requirement for the loan term of five years. The FMV is \$714 a month, and eight tenants will need to be at the FMV for rent. The FMV is adjusted annually.

Old Business:

- a. Daycare: Plan is to share on social media; share with community members to get more information that a licensed daycare provider is needed to get the daycare started. Kyle will plan to attend the next school board meeting to get an update on where the school is, with the remodeling, and support of the daycare.
- b. Café: A new roof is being put on where the fire took place.
- c. Westside Development: DSI is working on completing the grant application.

*Dianne contacted Kalea Swenson, local realtor, to come and give ideas about marketing the lots. She will attend an EDA meeting to discuss her ideas with the EDA. She was sent the plots to review.

New Business:

Growth on Main Street: The Mulder building is for rent, and the Tax building is for sale. The VFW will be meeting to discuss their plans. They are looking at downsizing.

Proposed Data center near Toronto: Keep this development on the radar. It has the potential to employee 200 people.

Discussed there will be wind towers developed in the areas of Arco, Tyler, and the need for housing, temporary housing, and they will build a maintenance shop.

Other Business:

- a. Greater MN Housing Infrastructure Grant Program DSI is finishing the grant application.
- b. Rental Rehab Loan Program- Applications are in process with DSI.
