- vi. Received a portion of the 2025 local government aid (LGA) on March 20. This is not supplemental funding but rather an advance on the LGA payments cities would normally receive in July and December. A deposit in the amount of 9.402% of a city's certified 2025 aid. This is a one-time advance payment and will not occur again next year unless there is a change in the law. The remaining 90.598% of LGA will still be distributed as usual, split equally between July 20 and Dec. 26 payments.
- vii. Trees: Dale Sterzinger and they have 42 4' foot bare root Lindon trees for \$6 and tubes are \$4. Jim from Public works will be talking with Dale to get trees ordered.
- viii. TIF Development for Westside Development (EDA Property)

The EDA will be applying for the Greater Minnesota Housing Infrastructure Grant Program to assist in developing the Westside Development project.
