### PARTICIPATION AGREEMENT RELEASE OF LIABILITY WAIVER OF CLAIMS AND ASSUMPTION OF RISK.

By signing this document, you may be waiving certain legal rights, including the right to sue.

To the RINK, PMMA, D/B/A THE RINK ON THE BEACH, and their owners, officers, directors, agents, employees, and/or personal representatives.

ASSUMPTION OF RISK: I am aware that ice-skating involves certain inherent risks, dangers, and hazards, which can result in serious personal injury or death. I am also aware that the ice-skating arena contains potential dangers to the ice-skating public. As such, I hereby freely agree to assume and accept any and all known and unknown risks of the injury while participating in ice-skating activities. I further recognize and acknowledge that the risks inherent in the sport of ice-skating can be greatly reduced by taking lessons, abiding by the Skater Responsibility Code (now known as "your Responsibility Code") and using common sense.

RELEASE AND WAIVER OF CLAIMS AGGREMENT: In consideration of allowing me to participate in THE RINK'S ice-skating activities at THE RINK, I hereby agree as follows TO WAIVE ANY AND ALL CLAIMS that I have or may in the future have against THE RINK and/or PMMA resulting from THE RINK'S activities at THE RINK.

TO RELEASE THE RINK from any and all liability for the loss, damage, injury or expense that I may suffer, or that my next of kin may suffer, as a result of my participation in the activity described in this Agreement due to any cause whatsoever, including the negligence or breach of contract on the part of THE RINK's activities at THE RINK.

ARBITRATION in further consideration of allowing me to participate in the Host's ice-skating activities in the Arena. I hereby agree to submit to binding arbitration and any and all claims which I believe I may have against the Host arising from the Host's activities and Arena the arbitration shall be pursuant to the rules of the American Arbitration Association. The arbitrators shall apply the Federal Rules of Evidence to all proceedings.

Arbitration shall be commenced within one (1) year from the Date on which any alleged claim first arose further, the arbitration shall be held in town where the Host is located unless otherwise mutually agreed to be all parties. The submission to the American arbitration association shall be unlimited and any court of competent jurisdiction may enforce the arbitration award.

BINDING EFFECT OF AGREEMENT: In the event of my death or incapacity, this Agreement shall be effective and binding upon my heirs, next of kin, executors, administrators, assigns and representatives.

ENTIRE AGREEMENT: In entering into this Agreement, I am not relying upon any oral or written representations other than what is set forth in this Agreement.

I HAVE READ AND UNDERSTAND THIS AGREEMENT AND I AM AWARE THAT MY SIGNING THIS AGREEMENT I AM WAIVING CERTAIN LEGAL RIGHTS, INCLUDING THE RIGHT TO SUE THE ARENA AND THE LEAGUE.
