



STUTIGART COUNTRY CLUB HOUSE RULES

1. MEMBERSHIP

Candidates for club membership shall submit a formal application accompanied by a check for the required fees for approval by the Board of Directors. Each candidate must be sponsored by two members in good standing.

2. CLUBHOUSE

The Clubhouse is maintained for the exclusive use of Club Members and their guests, subject to the established policies on guests.

Damage to and/or abusive use of the Clubhouse and premises by a member and/or his guest shall be the responsibility of such member. Failure to compensate the Club fully for any resulting damage shall be cause for revocation of the membership of said member. Members are responsible for damages by their minor children.

The Club house shall be open every day except Monday and designated holidays.

Management has the right to ask unruly or abusive members to leave and have authority to call police.

OFFICE HOURS: Tuesday - Friday 8:30 - 5:00 PM

RESTAURANT HOURS:

Winter Hours - November 1 until March 31

Lunch 11:00 AM - 1:30 PM Tuesday - Friday and Sunday. Not open for lunch Saturday. Dinner 6:00 PM - 8:30 PM Weekends 6:00 PM - 9:00 PM Tuesday - Saturday. Not open Sunday night.

Summer Hours - April 1 until October 31

Lunch 11:00 AM - 2:00 PM Tuesday - Sunday.

Not open Monday or Saturday lunch.

Dinner 6:00 PM - 9:00 PM Tuesday - Saturday.

Not open Sunday and Monday night

BAR HOURS: Bar hours after 9:00 subject to managers discretion.

3. NO SMOKING

The Clubhouse is a non smoking facility. The Arkansas Clean Indoor Air Act 8 went into effect on July 21,2006. This act prohibits smoking in the country club. Violators will be fined, 1st offence \$50, 2nd Offense \$100, 3rd Offense Revocation of club membership. The above fines will be in effect unless the Club receives a fine from the state then which ever fine is greater - the club fine or the state fine will be charged to the member in violation of Act 8. If the fine is not paid then membership privileges will revoked until fine is paid.

3. ATTIRE

All diners must be properly attired in the Hearthside room after 5:00 PM, with casual diners to be served in the main dining room only.

Bare feet, swimming suits and/or trunks are not permitted in the Clubhouse at any time.

4. BROWNBAGGING

No food, beverage (alcoholic or otherwise) may be brought on the Club house premises by any member, guest or employee. (The Arkansas Beverage Commission expressly prohibits such practice relative to "spirits" of any kind and violation of such ruling could result in the loss of the Club beverage permit.)

Wine may be brought into the club, but a corkage fee will be charged.

All alcoholic beverages are strictly prohibited from leaving club premises.

5. MINORS

You must check out pool balls and sign for key from the bartender or manager in order to use the pool room downstairs. There will be a clean up fee of \$100 if room is not left in good condition.

After 5:00 PM children less than 14 years of age must be accompanied by a member parent or adult member who will be responsible for their conduct and demeanor. The Club will not be responsible for injuries to such minor children. After 5:00 PM persons under the age of 16 are not allowed in the bar - even with their parents. Children over 16 must be accompanied by an adult 21 years or older. Identification will be required if there is a question of age.

6. PAYMENTS AND DUES

All dues and charges incurred for food, beverage, fees or services are due and payable upon receipt of members' monthly statements. Special function charges are due when bills are received. A 10% late charge will be assessed on all bills over 30 days. After 30 days you are not allowed to charge and are put on a credit card or check basis only. After 60 days full payment is expected or your club privileges will be revoked. Accounts unpaid after 60 days shall be deemed delinquent and shall be posted on the club bulletin board. Delinquency in the payment of unpaid accounts after 90 days shall be cause for revocation of membership.

7. CHARGES

All members shall sign a ticket and indicate their membership number for all purchases, fees, or services incurred by them or their guests.

Only those who have been duly authorized by a member in good standing may sign such member's name on any bill and such signature shall be binding on said member.

8. PARKING

All vehicles shall be parked in the proper parking areas. Lawns, driveways, weather canopy and loading zones are NOT proper parking places.

9. GUEST POLICY

RESTAURANT ONLY - Guests regardless of their residency are welcome to use the club facilities for eating lunch, dinner, or use of the bar, so long as they are accompanied by a member host. The member is responsible for all charges of his or her guest(s). This does not apply to business meetings or conferences.

Reservations for private parties and/or functions cannot be made by non-members. A member must make the initial contact with the manager when having a party and/or function with a non-member. This does not apply to business functions or conferences.

10. EQUIPMENT AND CLUB PROPERTY

Members shall not remove furnishings, fixtures, equipment, china, or silver or any other property of the Club for loan or rental without the express permission of the General Manager. Loss or damage on said property shall be fully compensated by the member responsible for the same.

11. MANAGEMENT AND EMPLOYEES

The performance, conduct and discharge of duties by all personnel are the responsibility of the General Manager. Any discourtesy, poor service, etc. shall be reported to management.
