## NOTICE

Due to the recent fuel increases, there has been increased costs to the industry.  
As a result, fuel surcharges have increased and are being reviewed regularly.

### Transport Conditions

- Quotes remain valid for 30 days unless stated otherwise.
- Dates in quotes are tentative and serve only as an estimate of transit times.
- Transit times are always approximate. (Please allow 2 days' notice for metro collection and 3+ days for other areas)
- All windows must be intact, with no limiting damage or alterations to the vehicle's dimensions.
- Vehicles must be operable with functional hand and foot brakes, unless special conditions have been pre-arranged.
- Notify if ground clearance is under 5cm.
- Vehicles must be devoid of personal belongings, unsecured spare parts, tools, or hazardous materials.
- Inform us if the vehicle's value exceeds \$500,000.00 before booking.
- Inform us if the vehicle is over 30 years old before booking.
- Any claims for loss/damage due to negligence during road transport must be reported prior to receipt of goods.
- Claims are evaluated individually. Sea transport does not include warranty coverage.

### NON-DRIVABLE CONDITIONS (PRIOR ARRANGED)

- Notification required before booking.
- Vehicle must be steerable, equipped with a driver's seat, and capable of rolling.
- Vehicle must possess functional hand and foot brakes.
- Vehicle must be prepared for transport, free from loose parts, shattered glass, or leaks.

### ITEMS IN VEHICLE (PRIOR ARRANGED)

- Pre-arranged items are uninsured and carried at the owner's risk.
- Items should be securely packed in suitable containers or luggage. Total weight of items must not surpass 60kg.
- Transport of heavy machinery, perishables, plants, or hazardous materials is prohibited.
- All items must be securely fastened within the vehicle and items must not interfere with the driver's seat.
- Visibility through windows must not be obstructed.
- For unsecured/personal effects please advise prior as a specialised quote may be required.
- An itemised list may be requested.
- Transport may be refused if items are determined to not be packed securely or not prior advised.

### ADDITIONAL CHARGES (MAY APPLY)

Applicable when alternative arrangements or services are necessary, for instance:

- If the vehicle or persons are not at the specified location.
- When the vehicle is non-drivable or contains items not previously arranged.
- In cases of a flat battery or winching – the vehicle may be jump-started or towed during loading/unloading – with fees incurred per jump start or tow.
- For unexpected issues – including but not limited to, replacing flat batteries, tyres, or addressing mechanical failures – service charges apply.
- For vehicles not collected – storage time commences on the second day after the arrival date – fees depend on the space occupied and duration.
- Quarantine fees may apply during transport to WA and TAS if the vehicle is not in a clean state.
