



# Relationship Between MODAPTS & Ergonomics

A special workgroup made up of IMA Board members, the IMA Certification Committee, Ford Union staff and an ergonomic trainer met December 8th and 9th in Louisville to design a special ergonomic class for Ford Union Ergonomic Professionals. The new class called Relationship Between MODAPTS and Ergonomics will be offered in the Spring Conference in Florida for a small initial group. This first offering is designed to Beta Test the one-day introductory class for Union Ergonomic Professionals to learn about MODAPTS® relationship to Ergonomics. It will explore how the two tie together, the importance of certain codes along with their corresponding body parts and their relevance to the production floor. The class will include group discussions, group exercises, and will encourage group participation from the Union perspective. This first class will help refine the learning objectives and presentations to meet the training objectives of Ford UAW. The group worked with jimmy Ford to help with the design of this new class. A certificate of participation will be offered for this class.

In addition, the group helped to identify the general parameters in redesigning the ergonomic class that will also be presented at the Spring Training Conference. This new upgraded ergonomic class will be a belt elective that will cover ergonomics and how it applies to MODAPTS. Many common ergonomic issues found in manufacturing will be covered and how to mitigate them with PPE's, ergo modified tools, job modifications, etc.

### Relationship Between MODAPTS & Ergonomics (Cont.'d)



This one-day class with Jimmy Ford being the lead instructor will have very specific learning objectives. Participants who want certification for the class will have to pass a test covering the class's content.

After the work group concluded its business, the Certification Committee worked on the agenda for the Spring Training Conference. The instructors and assistant instructors were identified for the various classes along with their registration fees. A new feature this year will be a general meeting for attendees who are not taking the Practitioner training to learn more about the Belt certifications and the various electives offered at the conference. Every effort will be made during registration to help people with any questions about their training or previous classes they have taken.

The dates, class descriptions and the new venue for the conference will be posted on the IMA website later this month. Please make plans to attend and don't forget to spread the word to your colleagues about this excellent training opportunity.

# Hospitality Industry Housekeeping MODAPTS Manual

The data is special purpose, predetermined time data designed to improve housekeeping operations. When properly applied, the data will help:

Provide an understanding of the actual work involved in various housekeeping tasks.

Assist in labor cost analysis and rate setting.

Improve effectiveness through better planning and scheduling.

The MODAPTS supplementary housekeeping data was developed from three sources; from the original MODAPTS data, the supplementary Janitorial data, and from extensive field analysis of housekeeping operations in various sites. The data is sufficiently comprehensive to allow substantial reduction in time needed to analyze with MODAPTS a housekeeping site. Its use leads to consistent, reliable standards. Development of the data began in 2019.

It has been tested in the field on various sites.
