# Letter from the Editor

Take What You Like...

My introduction to Alateen was at AA Area 33's 2010 March Roundup where I listened to young people talking about how they handled being around people whose drinking bothered them. At the time, I was new to Al-Anon and still thought my story was "an epic, technicolor movie" that could be topped by no one else; I was humbled, then, when I heard the Alateen panel. While I had grown up in a relatively stable home environment and, as an adult, had many options regarding my situation, here were individuals who, through no choice of their own, had been thrust into the dynamic of living with an alcoholic and did not have the autonomy to make decisions about all aspects of their lives. They did, however, know that they had control over what goes on in their minds, and I knew that I was learning from the best of those who practice Recovery.

If you attended the State Convention in Bay City this past May, you were able to appreciate the wisdom of young people in recovery during the Alateen/MCYPAA Panel.

Like many other things, Alateen was affected by the Pandemic. Through the efforts of Al-Anon, Alateen sponsors and, of course, the Alateens themselves, the program is working on getting its footing back. 

# Did you know...?


Did you know that the earliest Al-Anon groups had names like Women's AA Auxiliary, Wives Meetings of AA, AA Family Club, and even Non-Alcoholics Anonymous (NAA)? The MIAFG

Archives contains the meeting notebook of one such group. The by-laws written on the first page of the notebook state: "1. The name by which we will be known is to be the Ladies Auxiliary of A.A." The notebook opens with the line, "On Wed. the Oct 5-1949 the first meeting of the A.A. Auxiliary was held at the club rooms at 47 Michigan." The last entry is dated "Jan 12-1955."



References to Division Street, a label on the inside front cover showing that the notebook was sold by an office supply company in Grand Rapids, and a notation about "our bus trip to Muskegon" indicate that this was a Grand Rapids group.

The entries describe the topics discussed, the mention of new members present at the meetings, treasury reports, the name of the hostess for each meeting, election of service positions, and numerous events such as picnics, dinners, dances, parties and regional gatherings the group was involved in.



Several features of this group show how Al-Anon has grown and changed since the emergence of the first groups. A note in the by-laws of this group states, "Any help the AlAno Club need for any affairs have been agreed to be helped by the ladies of the Al-Anon who are willing to work for them." Further by-laws state, "Dues to be 50c ..." and "All members to be notified by mail of the coming meetings." In other entries, the secretary records details of a "hospital project" undertaken by the group, and mention is made of using selections from the Big Book for topics. There are references to a "Central Committee," apparently an AA committee, and descriptions of the various tasks undertaken by the group for the benefit of the Central Committee. For example, "Central Committee let us know that the Women's Auxiliary should sponsor the Halloween Dance."

This notebook records the frequent efforts this group was involved in to assist in the formation of other groups and to participate in fellowship with members across West Michigan. It is an important document recording the early development of Al-Anon by members who endeavored "To assist our husbands by practicing our own 12 Steps" (item 2.b. from the By-Laws).

# Michigan Donations

Donations to WSO from Michigan groups, January 1 thru June 30, 2023, was **\$12,681.36**. With 365 active groups in our area, this averages out to **\$35 per group**. You may remember the presentation at Spring Assembly about our 7th Tradition for each group to be Self-Supporting. The amount was \$300 per year, per group donation to WSO.

# WSO Chairperson of the Board Letter Presentation

I watched the WSO Chairperson of the Board Letter Presentation on Webex on August 20. The live presentation was on August 12, during our AWSC Meeting. Here is some of the information I learned from this meeting recording.

# Revenues (Income)

Revenue consists mainly of literature sales and contributions. Other revenue sources include magazine sales and investment gains or losses.

# Expenses

WSO continues to monitor all expenses and reduces them wherever possible. The largest categories of expenses consist of WSO Staff salaries and benefits, technology support, Conference costs (including interpretation), and postage.

# Net Increase/(Decrease)

A change in net assets resulted in a net increase of \$324,721, which is higher than the projected budget.

# What a Great Start to the Year!

- The Mobile App subscriptions remain very close to budget.
- Our contributions, literature and magazine sales are all coming in above budget.
- WSO is on track to exceed the Literature sales budget even before the daily reader was introduced at the 2023 International Convention!
- On page 145 of *Reaching for Personal Freedom* (P-92), it says, "It takes the commitment of each individual working together to achieve the desired goal." We need to continue to encourage the members to keep up their support of the efforts of the World Service Office through their contributions and purchase of Conference Approved Literature (CAL).

The 2024 WSC will be held in person, Thursday, April 18 through Sunday, April 21, 2024, at The Founders Inn in Virginia Beach, Virginia. As previously reported, the Board approved a three-year trial to determine if shorter weeks would attract more world service participation by decreasing the amount of time off required to be a Delegate or Trustee. This will be the second year of the three-year trial. It is WSO's intention to have a discussion at WSC regarding the four-day conference. Delegates are scheduled to arrive on Wednesday, April 17 and depart April 22.

In 2023, World Service Conference (WSC) members began a conversation about the financial feasibility of holding the WSC in New York every third year, a tradition established to allow each panel to visit Stepping Stones. Since the WSC is "the effective group conscience of our society in world affairs," members were asked to weigh concerns about the financial feasibility of our world services with the benefits of this link to Al-Anon history.

# **DELEGATE** (Continued)

The Board decided to host the 2025 WSC in New York or a surrounding area and, as a trial, invite Delegates who would be attending to form a Delegate team. This team's charge will be to organize, coordinate registration, and handle all logistics for one optional add-on visit to Stepping Stones, arranged to occur either immediately before or after WSC, for all interested Conference members.

The Board, Executive Committee, and the WSO Conference Staff participated in the Annual WSO Al-Anon Member Involved in **Alateen Service Training** conducted by Group Services.

Alateen Feasibility Update: An update on the Alateen Feasibility Strategic Plan Strategy was presented. A motion passed to approve the Strategic Leadership Team (SLT) identifying next steps for a project to create an Electronic Alateen Safety & Behavioral Requirement (EASBR) for Areas within the WSC Structure and an international EASBR for international structures.

**Audit Committee:** A motion was passed to engage a different company for audit services for the fiscal year ending December 31, 2023, and the following four consecutive years, with retention review to be completed annually by the Audit Committee.

The Board continued a generative discussion on **Diversity**, **Equity**, and **Inclusion** (**DEI**) by reflecting on the Trustees' participation in the 21 Day Challenge, a program of various resources to gain insight into Trustees as individuals and our biases. The program focuses on the following actions: read, listen, watch, notice, connect, and engage. They are committed to continuing these conversations. They made several suggestions for next steps for the October Board Meeting.

The Policy Committee discussed a question from the membership: "Is the gendered language in the Steps and Traditions in alignment with Al-Anon's Legacies?" The fellowship has been discussing similar questions for many years. This one was worded in a way that supported starting a Policy Committee conversation. The discussion was spiritual, robust, and powerful. We looked at this question through the eyes of our Legacies and the spiritual principles that are woven within them. Engaging in this conversation does not alter the boundaries established in the Al-Anon World Service Conference Charter. The conversation will continue in the future.

Wow! Three years in service as the Panel 61 Alternate Delegate for MIAFG, Inc., is all but done. I cannot express how much I feel I have changed [for the better] during this Panel. I truly enjoy service work.

So, a little synopsis of the last three years (+/- a year):

January 2020 was the start of the last year of Panel 58 and our introduction to COVID. Our world was changed. The Area World Service Committee meeting for March 14, 2020, was cancelled as was the 2020 Michigan Al-Anon / Alateen State Convention. Spring Assembly was done virtually – our first of many Zoom Meetings. Panel 61 began in January 2021 and still a virtual world. We were all learning how to cope and how to use Zoom.

The 2021 Michigan Al-Anon / Alateen Convention at Great Wolf Lodge in Traverse City was to be the last three-day Convention MIAFG was to have before converting to the one-day format as mandated by our membership. Again, due to COVID it was cancelled. We had a one-day virtual convention via Zoom. All the meetings MIAFG held in 2021 were virtual. We continued with virtual meetings until the August 13, 2022, AWSC meeting which was in person. Since that time, we have used the virtual meeting platform for most meetings other than Assemblies or AWSC meetings, i.e., budget, board updates, DR and GR orientations.

We as Al-Anon have embraced and adopted procedures to allow Electronic and Hybrid meetings to exist and function. My concern is and will be losing the fellowship of the Al-Anon program.

The United States North Central Regional Delegate's Meeting (USNCRDM) held in March every year was a virtual meeting in 2021. In 2022 it was an in-person meeting held in Indianapolis, Indiana and the 2023 in-person meeting was held in Bloomington, Minnesota. I was astounded at the impact the physical meeting was to me. While I learned some things from the 2021 virtual meeting, I learned an amazing amount of information from the 2022 and 2023 physical meetings. Not just from the meeting itself but from all the conversations at breaks and meals with people from the surrounding States. Fellowship.

Participating in the operation of Michigan AFG, Inc., has been challenging and fun. I feel I have done the best job I knew how to do and can't think of any regrets due to failings on my part. Did I make mistakes? Absolutely. Progress not perfection. There is always more to do and I feel good about doing my part.

I can't possibly thank everyone who helped me in my service position; fellow Board members, Coordinators, District Reps, Group Reps, my Service Sponsor, and people from the general membership willing to help as needed. Have I mentioned fellowship?

# TREASURER

Our account balances, based on bank statements, as of July 31, 2023 are:

Our primary income so far this year continues to be from member and group donations. We have received \$10,141, however that is lower than a year ago (\$11,593). To supplement our income, we have had *Serenity Sentinel* subscriptions, State Convention, In-Kind donations from our officers and coordinators, and love basket donations at both March AWSC and Spring Assembly. Our Total Income is \$12,859, which is almost 10% higher than 2022. Our expenses in 2023 continue to increase as we are now meeting in person and other events are back on the calendar. Expenses are \$10,403 and that is an increase of over 44%. The Net Ordinary Income is \$2,457 compared to \$4,483 in 2022, reflecting a change of -45.2%. This information is in the Profit Loss Report.

Today we will also look at the proposed 2024 budget. The current year Budget v Actual report is also available for reference.

- 2. Update on previous reports My focus was on physical materials the past two years. Now I am addressing electronic records. This will be the biggest area of growth for the archives going forward.
- 3. Money spent none
- 4. Research requests Kristine G wanted to know when the UP split from MIAFG to join Wisconsin. I could not find the answer in AWSC or Assembly reports for 1974-1976, though 4 sets of AWSC minutes are missing. The answer was provided by the WSO Archives.
- Additions to the collections the banner and sign carried by MIAFG members in the Love Parade at the International Convention in Albuquerque. Also, one of the tee-shirts designed by MIAFG members and worn during the parade.

# 6. New Business

- Formed the Archives Committee in February the newly-formed Archives Committee met for the first time. The Committee consists of 5 members: Kate A, Chair and Archives Coordinator, Hugh W (former Archives Coordinator), Marte D (former Alateen Coordinator), and Lynn Q and Linnea O (District 32 members). The Committee met weekly in February and March to work on writing a collecting policy. Joe T, WSO Archivist, attended one of the meetings to discuss archiving electronic documents. The Collecting Policy draft was finalized in May and sent to the Policy Committee for review.
- Archiving electronic documents has presented questions of process and protocol that have not been fully solved. Denise S, Digital Coordinator, and I had several conversations to figure out carefully defined service authority on this issue and came to the conclusion that a Thought Force would be needed to address all the issues of moving the Archives from the physical age into the digital age.

# 7. Fun Discoveries

• A report mailed from the clearinghouse in 1958 to Al-Anon members titled: Report to the Groups Concerning Al-Anon Activities During the AA Conference in New York, April 23-27, 1958. It puts forth the idea of Al-Anon holding its own stand-alone conference in the future. Our copy was mailed to Carroll R in Williamston, MI. There is a 1-cent stamp on it and a post office stamp stating that 2 cents is due on the postage.

The materials in the Archives continue to enlighten me about the growth of MIAFG by the hundreds of trusted servants who have carried the message of hope in Michigan. The selfless service evident in the work of these Al-Anon members is inspiring, and I am grateful to be able to witness, in retrospect, the natural growth of the love and help that shape our program.

This was followed through in the development of the drafts and the design of the result. When compared to the regular print editions of our previous daily readers, there is a noticeable difference.

# Alateen

Fourteen Michigan Alateens attended KOMIAC (Kentucky Ohio Michigan Indiana Alateen Conference) at Northern Kentucky University in Highland Heights, Kentucky July 21 – 23, 2023.

Michigan will be hosting KOMIAC 49 next year. According to MIAFG Alateen Coordinator Sheryl SR, the contract still needs to be signed, but it looks like the conference will be held at Southwest Community College in Niles the last weekend in July 2024.

What's the best way to help Alateens? Sheryl thinks Public Outreach is key and says that, in addition to having meetings in conjunction with other 12 Step Meetings (those attendees are usually from Recovery families), initiating meetings at schools is also important.

Sheryl also urges Al-Anon members to be mindful about welcoming and encouraging young people to attend Al-Anon meetings. In her words:

## DIFFICULT TRANSITION

In my short experience with Alateen, I have noticed that the transition from Alateen to Al-Anon seems difficult.

### SHARING EXPERIENCE

So, I shared this thought with a long-time Al-Anon member about the transition from Alateen to Al-Anon, and SHE shared her experience first attending Al-Anon meetings in her twenties:

"The problem was," she said, "that I felt like I was sitting across from my mother and father. But," she went on to say, "I kept on coming back and I started to see the common ground with the people at the table, regardless of our age or time in life."

### TRUST

So, I am choosing to TRUST that our Alateen members will keep their programs in their heart as they make that difficult transition to adulthood.

# HOPE

I HOPE that they remember that Al-Anon meetings are a place where they can continue to find serenity.

# **EXPERIENCE**

And my experience has taught me that I just have to SHOW UP to see the Al-Anon/Alateen magic work.

# From the Alateens:

Telling this story about 1,000 times never makes it any easier. I find myself struggling to find the words to best explain my background because I have suppressed many traumatic events in the past. But that is something I have been working on relentlessly. Here's my backstory.

My mother was a functioning alcoholic for around 15+ years and addicted to pills and opiates for around 5+ years. I lived through many disturbing scenarios: Witnessing my mom not being able to leave her bed for days to worrying my teachers because "mom wouldn't wake up again today" to take us to school on time, I took on the role of parent by having to raise my little sister starting at the age of 10. My family didn't have money for food, clothes, or for our house because finances were primarily focused on fueling my mother's addiction.

I felt lost and didn't know where to turn. Parents are supposed to be a role model to their children and while my mom was struggling with addiction, I didn't see her in that light. So I started going to Alateen when I was 14. I didn't know what it was or what it was about, but after one meeting, I knew it was the place for me. It helped put my problems into perspective and made me realize I wasn't the only one affected by this horrible disease. It also gave me an outlet for my emotions, tools to properly handle living with an alcoholic and ways to move forward with the change in the family dynamic as a whole due to her illness.

Fast forward to today, I am 23. Since graduating, I haven't always attended consecutive Al-Anon meetings, but I have continued to work the program. I found the teachings relevant in multiple aspects of my life. The trauma of the past seems to come up in unexpected ways when you least expect it. It is crucial that you continue to work the Al-Anon program, regardless if the alcoholic is drinking or not. You may never know how the addiction has shaped every aspect of your life, even into your adulthood.

I am thankful every day that I have this outlet and this opportunity to help others the way this program helped me when I needed it the most.

# VERIFICATION OF ATTENDANCE

Sue P, WSO Associate Director – Group Services, sent Kristine G an email discussing information regarding Verification of Attendance. Recently, WSO has received multiple contacts requesting signed proof they had participated in a specific Al-Anon meeting. Reasons included requirements for school assignments and legal purposes. WSO explained that it cannot provide such verification as it may come only from the individual group visited.

These requests are relatively new to Al-Anon, whereas in AA they are more common. WSO does understand that members may wish to remain anonymous and choose not to sign their full names on any legal forms, nor are they expected to do so. However, according to Sue, "In the spirit of cooperation and attraction, consider these ideas to support observers and potential members requiring this proof of attendance:

- Create a group email address that can be used to send to the participant. The email can contain a standard message created by the group and then sent by the trusted servant who manages the group email inbox.
- Consider designating regular members of the group to sign any sheets that may be presented. Discuss as a group how those papers will be signed.
- Consider creating a self-inking pad that has the name, address, WSO ID number, and blank line to add in a date for attendance. This idea was shared by a group and appears to be working well. Any member of the group can use the stamp to provide as the signature."

WSO's information and suggestions give our groups much to ponder and then discuss at Group Consciences. GRs, this is something to seriously consider bringing to your group's attention. As each group is autonomous, it is free to handle this situation as its Group Conscience decides.

In closing, Sue invited everyone to share their group's ideas so that all could continue to grow in Al-Anon's work supporting families and friends of alcoholics.



# Service Position Guidelines

# **Area Treasurer**

MIAFG - SP004

The Treasurer is voted in at the Election Assembly to a three-year panel. The position should have District Representative (DR) or Alternate District Representative (ADR) experience.

### Basic skill requirements;

- Knowledge and experience using the Twelve Traditions, Twelve Concepts, and the Service Manual
- Proficient computer skills including but not limited to QuickBooks, Word, Excel, presentation software, Internet and e-mail accessibility
- Effective math and accounting skills
- Effective written skills
- Oral and electronic communication skills
- Ability to multi-task
- Good time management and organizational skills

### Responsibilities:

- Attends Assemblies, AWSCs, Executive, Policy, and Budget Committee Meetings and conference call meetings as needed
- Opens a P.O. Box at the beginning of his/her panel in a convenient location for MIAFG donations

- Attends Local Al-Anon/Alateen events when invited by local Group, District or AIS.
   Expenses are paid by inviting party except when they are not able, then expenses are paid through the Treasurer's Budget
- Works closely with the Delegate, Alternate Delegate and Area Chairperson
- Submits a written report for each AWSC and Assembly meeting. Often, this same report is submitted to the newsletter coordinator
- Prepares and presents detailed financial reports for AWSC and Assembly
- Handles all Assembly and AWSC collections and expenditures
- Prepares Fall and Spring Appeal letters seeking membership contributions to support MIAFG
- Collects and records donations
- Prepares documents for annual tax filing
- Prepares, submits and confirms completion of MIAFG Inc 501 (c)(3) tax-exempt status document each September
- Supports the annual financial review
- Maintains contact with the Chairperson and Delegate
- Creates annual budget for review and acceptance by members

- Pays all bills for approved expenditures; checks require two authorized signatures; debit card payments require at least two authorized concurrences via email
- Ensures a completed
  MIAFG reimbursement form is
  submitted before any payment is made
  to a member of MIAFG.
  Original/Electronic receipts are to be
  attached to this form for all purchases
  except for mileage reimbursement,
  which is paid at the current published
  IRS reimbursable rate.
- Reconciles monthly bank statements against internal accounting documents
- Retains all documents related to donations and payments per Federal Tax Laws
- Supports MIAFG Convention Host Committee with seed money and final reconciliation of convention
- Stays current with the AFG Connects website




