

Letter from the Editor

Take What You Like...

If the WSO were a restaurant, I would be washing dishes for not paying the tab for my meal.

When I first entered the rooms of Al-Anon, my Al-Anon experience was pretty much limited to, well, the rooms. The group, especially my home group, was my Al-Anon world.

When it came to Tradition 7, I figured our group's primary concern was taking care of our rent and purchasing literature and coffee. When we discussed appeal letters from the AIS, MIAFG or WSO, I thought we were doing these service arms a *favor* by contributing – if we had the funds.

When I agreed to serve as a Group Rep, I started to gain an understanding of Al-Anon beyond the Group level. Later, as a member of the Detroit AIS/LDC Service Board, *I* was writing those appeal letters. My idea of what Tradition 7 should mean to groups was changing.

At the June 11 Assembly, a report was given on the WSO's finances, including how Michigan measures up to other Areas when it comes to contributions. In recent years, Michigan has been below average and well below what the WSO spends per group. (See chart on page 4.) Reviewing this information, I realized that my understanding (and practice) of Tradition 7 had not yet expanded to support of the WSO. Sending contributions to the WSO should not be an afterthought or considered a favor; it's doing what you can to pull your own weight and make Al-Anon available for others who suffer from the family disease of alcoholism.

I'm sure much more will be revealed to me as I grow in Al-Anon. In the meantime, I appreciate the patience of others who love me (in a very special way) when I'm slow to catch on to an Al-Anon principle.



Did you know...?

Did you know that one of the earliest pieces of Michigan Al-Anon history in the MIAFG Archives is a small composition notebook containing the group minutes of the Chesaning Al-Anon group?

The opening entry is dated August 10, 1959. It records the names of the Chairman, Secretary and Treasurer and records brief minutes of the meeting including the topic ("first 3 steps") and the closing prayer.



The Secretary is the link between the Clearing House and the group. She receives all Headquarters bulletins as well as the monthley Forum and sees that every member has a chance to read them.

She keeps an up-date list of names, addresses and telephone numbers of all members and sees that they are notified about meetings.

She orders sufficient Al-Anon literature, not only for the group's use but enough to hand out to guests, ministers, dector and welfare workers. She sees to it that the literature is o display at meetings. Nakes announcements during intermission and the seed of the seed

The notebook lovingly records the activities of the group's meetings including literature purchases and refreshment costs. The November 23, 1959, entry records "cash on hand \$3.38." In August 1983 the treasury recorded \$10.80. The journal also records the following:

- ➤ "Paid \$1.00 Lights for Health Center" leaving a balance of .70
- ➤ "Sent 4.00 for Spring dues to Headq."
- "Meeting opened in the usual manner with Aims & Purposes"
- "Motion made & seconded that we might host the Flint Area Al-Anon Council in October"
- "Tonight a new member joined the group. The reading was on how people change their attitudes on the alcoholic problem."
- Starting in 1961 the meeting was held in different locations "Meeting held at Velma C's" and "Meeting held at Kate R."
- Several pages constitute a 'lending library' list of books going out and being returned

It is interesting to note how often newcomers are recorded in this record book. Even before the internet, Michigan family groups were carrying the message effectively so that newcomers heard about meetings.

Meetings are recorded irregularly from 1959 to 1963. For unknown reasons, the records then skip forward to 1980. The final entry of the notebook records the meeting for June 11, 1984. A typed sheet entitled "The Secretary and Her Duties" is stapled onto the last sheet of the notebook. Inside the back cover is the group's phone list.

The notebook shows water damage on a few pages, is somewhat soiled, and has acid deterioration throughout. Nonetheless it is a beautiful memento of our important early history. It is a fascinating glimpse of the workings of an Al-Anon group, physical evidence of the commitment of members to keep the group growing and thriving.

Concept One

The ultimate responsibility and authority for Al-Anon world services belongs to the Al-Anon groups.

DELEGATE

After my first in-person World Service Conference (WSC), I have much to share with you!! First, thank you for the cards, love gifts, texts and emails before and during WSC. You were all in my thoughts and heart during the week.

Our theme for this WSC (which was in Tarrytown, NY the week of April 25) was *Enhancing our Recovery through Abundance, Unity and Understanding.* Since it was a trilingual conference, the theme was also in French and Spanish.

Attendees at WSC included: Delegates from the United States and Canada; the Board of Trustees; the Executive Committee which includes some At-Large members; and World Service Office (WSO) personnel – both voting and nonvoting members. There were 87 voting members.

During this busy week we:

- voted on several motions after discussions
- talked with all outgoing Panel 60 delegates
- saw presentations by the WSO, the Policy Committee, some delegates, and some task and thought forces
- discussed Chosen Agenda Items and other issues
- went to Stepping Stones
- had the chance to attend Al-Anon meetings at 6 a.m. and 8:45 p.m. every day
- connected with other delegates, board members and staff during meals and breaks


Some of the highlights I wish to share with you:

The Global Electronic Area

- Our first motion was to admit into our WSC structure a new Area – the Global Electronic Area. The last time a new Area was admitted was in 1987 (Alaska). The Global Electronic Area delegate, Ozzie, waited outside the room while we discussed, amended, and voted on this motion. The motion passed. When Ozzie returned to the room, he was greeted with a standing ovation!
- Electronic meetings have been around for more than 15 years; because of our motion, they are now Electronic Groups (EG) and are represented in our Structure. There were 674 EGs as of March 2022.
- After a new EG registers with WSO, they will decide if
 they want to be in the Global Electronic Area or a
 Geographic Area (like MIAFG). If they want to be a
 part of the Geographic Area, that Area must have a
 process in place and let WSO know they are ready and
 willing to accept EGs.
- A group can NOT have a physical location and an electronic location, meaning a physical meeting – faceto-face – one day and an electronic meeting another day. A group can only have one location.

- A physical group CAN have, however, a face-to-face meeting with an electronic component – a hybrid. WSO is working on updating their database to include EG, PG and Hybrid Groups in one database (currently hybrid info is entered in the meeting information spot).
- Electronic Groups no longer need to request permission to quote CAL.
- What does this mean for MIAFG? We need to get a process in place so that we can receive Electronic Groups that request to join us.





WSO Finances


- The independent audit of the WSO finances achieved the desired clean opinion.
- According to the Statement of Financial Position for 2021, WSO's revenue was \$5,173,609 with Literature sales at \$1,906.751 (still less than the pre-pandemic year's \$2.9M in 2019). Contributions were \$2,623,242.
- Expenses were \$5,249,675 resulting in a deficit of \$76,066 better than originally predicted and largely due to level of contributions, and cost cutting at WSO.
- Our reserve fund NET value was \$3.6M, which covers 8.5 months of operating expenses.
- The WSO staff is working hard to provide the services we expect as well as forging ahead to provide future needed services. They have been working 150% at less than 100% capacity.
- ALL Al-Anon Family Groups use WSO's services (CAL, registration, website, PSA, etc.), but only 52% of all groups contributed to WSO in 2021.
- While the WSO spends approximately \$280 per group, the average contribution per group is \$175. Michigan's average of \$95 is the lowest of all areas. All groups are encouraged to do what they can when practicing gratitude and Tradition 7.

Concept Eight

The Board of Trustees delegates full authority for routine management of Al-Anon Headquarters to its executive committees.

WSO Cost Per Group (\$281.89)




Chosen Agenda Items

The following Chosen Agenda Items (both also selected by MIAFG via the March survey) were discussed at WSC.

- 1. Helping Members Recognize that Service Participation is Vital to Personal Recovery and to the Future Availability of Al-Anon to Family and Friends of Alcoholics: Historically, many members attend Al-Anon meetings for relief, rather than recovery, not recognizing that service is an integral component of this program. Two years of limited access to seeing service in action presents us with a unique opportunity to re-emphasize the necessity of participating in service for healthy personal recovery and to provide for the long-term stability of Al-Anon Family Groups as an organization. How can we see Concept 9 come to life?
- 2. Rebuilding Alateen Meetings after the Pandemic and Alateen's 5th Tradition: Alateen attendance decreased dramatically during the pandemic. The absence of seasoned members creates a void for new members who are lacking recovery experience. How can we support Alateen as it rebuilds after the pandemic in keeping with Alateen's 5th Tradition? Each Alateen Group has but one purpose: to help other teenagers of alcoholics. We do this by practicing the Twelve Steps of AA ourselves and by encouraging and understanding the members of our immediate families.

Concept Two

The Al-Anon Family Groups have delegated complete administrative and operational authority to their Conference and its service arms.



Annual Report and Updates

- The Annual Report will be available soon at https://al-anon.org/for-members/wso/annual-report/
- Besides summarizing all of the activities within the last year, the report also contains the updated Strategic Plan. As Vali F, the WSO Executive Director, stated, "Think of this plan not as a road map but more of a GPS; it's dynamic and changes as we go along – 're-calculating!"
- Sarah S of Missouri has joined the WSO as Director of Programs.
- There is an opening for Associate Director International.
- WSO is continuing to update the guidelines and is exploring other payment and contribution options
- They have made significant changes to the database, receiving criticism, constructive and destructive (at times, the spirit of Al-Anon kindness was missing).

Concept Eleven

The World Service Office is composed of selected committees, executives and staff members.

Alateen

There were three different sessions regarding Alateen.

- Chosen Agenda Item about rebuilding Alateen. (See "Chosen Agenda Items."
- Presentation by Alateen Electronic Group Feasibility Work Group. There are six (6) members, and this work is ongoing. It is no small matter to figure out how to keep Alateens safe, especially when laws are different across states and provinces. For now, Alateen is not included in the Global Electronic Area.
- Group Services update on the Alateen Recertification Process. Last year, 11 areas missed the recertification deadline. As a result, they were decertified and could no longer use the Alateen name, conduct Alateen meetings or have Alateens at events. Those areas then had to start from scratch, develop Behavioral and Safety Guidelines for approval by legal counsel and by WSO a very laborious and challenging process. Again, some members were less than kind some even hateful toward the WSO staff. What a sad commentary.

DELEGATE (continued) <u>Trustees</u>

- The **Mega Issue** discussed at WSC was Trustees these are the volunteer members who serve on the Board and are the guardians of the Traditions. We have Regional Trustees and Trustees-at-Large. There are several vacancies. There are just not enough people submitting resumes for these positions! While you do not have to have been a delegate to be a Trustee, it is still a rather rigorous application process.
- We discussed whether a skill-based description for the trustee role would be more helpful than the current resume application.
- The Board Chosen Agenda Item was to discuss the advantages and disadvantages to having Regional Trustees AND Trustees at Large.
- Here in our North Central Region, Jean L was affirmed for a second, three-year term as the Regional Trustee.
- If this is a service position you are interested in, please contact me, and I can help you start the process.


Miscellaneous from WSC

- The **Diversity Today Thought Force** presented a skit that brought up many questions to think about.
- The **Maintaining a Sustainable Future** Thought Force presented ways to practice the Seventh Tradition with spiritual principles.
- Three Delegates were asked to present their experience on giving last year's workshops, including one on clarifying Social Media in the Service Manual.
- We passed a motion on updating the Conference Charter, found on page 224 in the Service Manual, regarding the new Global Electronic Area.
- Thursday morning, April 28, we all boarded buses and traveled to where Al-Anon started Stepping Stones. You can explore it yourself at steppingstones.org

Happy Summer, Everyone! The following information was provided at the Spring Assembly meeting on June 11.

Our total income for 2022 to date is \$8,986.05 and expenses to date are \$4,858.52. This leaves us with net income of \$4,127.53 to date. We are slightly ahead compared to 2021 related to our income. Our donations are better than this time last year. However, our expenses compared to last year are higher. Therefore, our net income is currently lower than last year. This year we participated in the NCRDM that was in Indiana. This was an expense that we have not incurred for the past two years.

Our State Convention was held virtually again this year. We received 3 individual donations totaling \$80.00 that were posted as of the 31st of May. If you made a donation but did not note that it was for the Convention, please let me know. It would have been counted in the general donations.

A big thank you for all Group donations through May 31 totaling \$8,986.05. During the same period last year, our group donations were \$6,747.64. Thank you very much to all the groups who included their WSO number and Group name on their check, this assures that your donation will be correctly documented. When using our website, you can either use PayPal or a Credit/Debit card. Both options have the ability for you to add special instructions to the payment. This is where you can put your group information or anything else that is relevant to the donation.

Major expenses so far have been for 2 editions of the *Serenity Sentinel* (Winter and Spring), 2021 tax filing, payment for rental of the church facilities for the year, along with the cost of the NCRDM trip for our delegate, alternate delegate, and immediate past delegate. 2021 Financial Records were provided to Yeo and Yeo for tax preparation and to our internal financial reviewer. Federal taxes were filed in March.

Final 2021 Group Donations were \$17,533.33, Total Income \$18,056.40, and Total Expenses \$10,710.91, which gave us a Net Income of \$7,345.49.

Literature Shortage (Suggestions from Tom C, WSO Associate Director, Literature): As you know, since the Covid 19 pandemic began, there have been many challenges in ordering Conference Approved Literature from the World Service Office and from local Literature Distribution Centers. The WSO recently received the following suggestion that provides something members can possibly do to help:

- When groups stopped meeting in person due to pandemic concerns, many groups still had supplies of CAL stored at their meeting sites. These boxes, bins, and cupboards full of CAL became unavailable to those who really needed them.
- Let's begin a discussion about the CAL we left behind. By retrieving stored CAL and getting it to those who need it including newcomers we carry the message of hope. This is the Twelfth Step in action, and we can do our part to distribute this "lost" literature to help alleviate supply problems.

SHARE

There are times when I'm struggling that talking on the phone or picking up some literature is not possible. The phone is not my first choice for redirecting myself to the program; I have always found it awkward. Growing up in an alcoholic family I learned to read facial expressions as a way of gaging upcoming behavior so I could protect myself. When I'm talking on the phone, I can't see the other person's face and it makes me feel vulnerable. Also, I may be waiting in a doctor's office when I start to feel fear, and I can't easily make a phone call, or I don't have any CAL in my purse. So, I hit on the idea of texting my higher power. I have entered a generic number in my contacts list, one I know is not a real phone number. So, when I need a quick spiritual boost, I text my HP. Even something as simple as "I'm feeling vulnerable" or "HP, please watch over me" helps to relieve my anxiety.


