OWNER AGREEMENT

By signing below, I acknowledge and agree to the following:

- My pet will remain **leashed at all times** while on camp property.
- My pet will be walked **only by an adult owner or designated adult**.
- My pet is **not permitted** in the following areas:
 - Dining Hall
 - Dormitories
 - Faithful Lodge
 - Tabernacle
 - VBS areas or children's programming
 - Any other designated community buildings
- I understand that Green Mountain Bible Camp reserves the right to require removal of any pet that is aggressive, disruptive, excessively noisy, or poses a safety concern.
- I accept full responsibility for my pet's actions, behavior, and any damage or injury caused by my pet.
- I agree to clean up after my pet immediately and properly dispose of waste.
- I understand that failure to comply with camp pet policies may result in my pet being removed from camp property.

LIABILITY WAIVER

I understand that Green Mountain Bible Camp, its board members, staff, volunteers, and affiliates are not responsible for injury, illness, loss, or damage involving my pet. I assume all risks associated with bringing my pet onto camp property and agree to indemnify and hold harmless Green Mountain Bible Camp from any claims arising from my pet's presence.

CAMP AUTHORITY AND PET REMOVAL POLICY

Green Mountain Bible Camp reserves the right, at the discretion of the Official Board, camp leadership, and in accordance with the camp's insurance requirements and recommendations, to refuse permission for any pet to enter or remain on camp property for any reason deemed necessary for the safety, health, welfare, and enjoyment of campers, guests, staff, volunteers, or other animals.

Green Mountain Bible Camp further reserves the right to require the immediate removal of any pet from camp property, or to ask the pet owner and any accompanying guests to leave camp property, if camp policies are violated or if the pet is determined to be disruptive, aggressive, unsafe, unsanitary, or otherwise inconsistent with the camp's mission and operations.

Approval of a pet registration form does not guarantee continued permission for a pet to remain on camp property. Permission for pets may be revoked at any time by the Board of Directors or camp leadership. All decisions regarding pets on camp property are final.

By signing this agreement, the pet owner acknowledges and agrees to abide by all camp rules and understands that failure to comply may result in removal from camp property without refund.
