Introduction

1. AnewTrek™. AnewTrek™ is an educational business but is not accredited. AnewTrek™ shares valuable knowledge and information, primarily the Opportunity System™, in the form of products and services. The intent of AnewTrek™ is to help people gain knowledge, to live better.

2. AnewTrek™ People. The people who work for AnewTrek™ are not consultants, counselors, therapists, psychologists, psychiatrists, social workers, addiction experts, health experts, or financial experts. The AnewTrek™ Owner, Instructors, Presenters, Knowledge Officers, Knowledge Guides, Information Guides, Planners, Researchers, Employees, and Representatives shall be referred to in this Agreement as simply “Guides.”

3. Products and Services. AnewTrek™ products include, but are not limited to, published books, booklets, pamphlets, and clothing. AnewTrek™ services include, but are not limited to, in person and online, live and recorded, classes, presentations, seminars, webinars, workshops, growth groups, videos, research, and interviews. AnewTrek™ products and services are educational in nature, for informational purposes, and referred to in this Agreement as “products” and “services.” AnewTrek™ products and services include, but are not limited to, the fields of personal growth, professional growth, leadership growth, and business growth.

4. New Knowledge. The Information Age has empowered societies like never before. The growth of any group of people depends on the growth of individuals, which often starts by gaining new knowledge. AnewTrek™ helps people gain knowledge, primarily with the Opportunity System™ that includes planning, and productivity.

5. Opportunity System™. All core areas of growth have the same Opportunity System™, with three areas of focus, a foundation of strength, the art of purpose, and the science of momentum. Prices and Refunds

6. Prices. AnewTrek™ currently offers a two hour presentation and a six hour workshop. Services will be prepaid, and AnewTrek™ reserves the right to adjust prices in the future.

If AnewTrek™ services are not completed as planned, AnewTrek™ will consider whether to provide a refund or finish services at a later date. AnewTrek™ is not responsible for any inconvenience, damages, or loss of time or resources, or expenses, due to unforeseen or unfortunate incidents or occurrences, the weather, or responsibilities of shipping or delivery businesses.

8. Expectations of AnewTrek™ Guides. AnewTrek™ Guides primary responsibility is to provide AnewTrek™ products and services. AnewTrek™ Guides may have a faith-based identity which can influence them. I accept that neither AnewTrek™ or AnewTrek™ Guides are liable, or responsible for, results or outcomes of my future use or application of the products and services, in any way.

11. Expert Help. If I think I might need expert advice or help in a specific area of growth, especially health, relationships, or finances, I will consider a certified expert for that specific issue, for my specific situation.

18. Group Representative. As the representative a group of people getting products and services, I accept responsibility to make the group aware of this Agreement, and their use of products, or attendance of services, is acceptance of this Agreement. If I am a member of such a group I accept this Agreement.

20. Applicable Law. This agreement shall be governed and construed in accordance with the laws of the State of Colorado, without giving effect to any conflicts of law's provisions.

21. Indemnification. I agree to indemnify and hold harmless AnewTrek™ and AnewTrek™ Guides, free from fault, liability, and expenses, arising out of, or related to, any of my application or use of information I receive.

22. Disputes. If a dispute arises, I agree to immediately notify AnewTrek™ by email or physical mail with an initial dispute notice that includes detailed information about the dispute. I will try to resolve the dispute directly with AnewTrek™, in good faith, for at least 30 days from the delivery date of my initial dispute notice. If dispute negotiation does not resolve the issue, I agree to mediation with an organization determined by AnewTrek™. If mediation does not resolve the issue, I agree to arbitration with an organization determined by AnewTrek™.

23. Severability. If any provision of this Agreement is deemed invalid or unenforceable for any reason, the remaining provisions shall continue to be valid and enforceable. The failure of either party to enforce any provision of this Agreement shall not limit that party's right to subsequently enforce the remaining provisions.

24. Agreement Changes. I accept that AnewTrek™ reserves the right to change this agreement.

25. Acceptance. I accept the provisions in this Agreement.
