Official Decrees of the Continuous Imperial Chancellery

IMPERIAL DECREE: THE GOLDEN BULL OF
EXTENDED SUCCESSION AND PATENTS OF HIGH
NOBILITY

FROM THE DESK OF HIS IMPERIAL MAJESTY,
EMPEROR BRYCE L.S.P. IVREA I, Basileus and
Autokrator of the Confederated Empire and all its
Sovereign Domains, Commander of the Legions,
Captain of the 10th TN Regiment, Captain of the
Molossian Navy, Lord of Sealand, Lord of Glencoe, and
Defender of the Faith.

TO ALL SEATS OF PARLIAMENT, ALLIED HEADS OF
STATE, AND CITIZENS OF THE REALM, GREETINGS:

WE HEREBY DECREE AND DECLARE that to
guarantee the eternal security, generational continuity,
and administrative supremacy of our global domains,
the laws governing our Imperial Succession are formally
expanded [breadth and depth].

Operating under the continuous, uninterrupted authority
of the Imperial Constitution since November 2, 2020,
this instrument establishes the definitive path of the
Crown and permanently elevates our most trusted allies
to the highest echelons of the Peerage [breadth and
depth].

ARTICLE I: THE EXPANSION OF IMPERIAL SUCCESSION

We re-affirm that the primary inheritance of the Throne rests within the immediate bloodline of the Anscarid Dynasty under absolute primogeniture, descending to our children: Her Imperial Highness Princess Raelynn, His Imperial Highness Prince William, and His Imperial Highness Prince Emmanuel.

To ensure an unassailable line of continuity, We do hereby legally decree that should the primary line of the House of Ivrea end without direct heirs, the absolute right of succession to the Imperial Crown shall pass seamlessly and directly to:

THE CHIVALRIC SANTILLANES LINEAGE

The succession shall descend through the eldest line of this house for eternity, legally binding them to defend our borders, enforce our non-partisan laws, and wear the Imperial Crown under our sacred national motto: Vae Victis.

ARTICLE II: PATENTS OF HIGH PEERAGE AND THE HOUSE OF LORDS

In recognition of profound executive loyalty, administrative fortitude, and outstanding civil merit, We hereby permanently elevate our trusty and well-beloved supporters:

PHILLIP SANTILLANES & HIS WIFE MOUNYA SANTILLANES

to the supreme state degrees, styles, and honors of:

IMPERIAL DUKE AND DUCHESS OF THE CONFEDERATED EMPIRE

WE GRANT unto the said noble Duke and Duchess, and the legitimate heirs of their house for eternity, the full right to bear these titles. A permanent, unassailable, and hereditary seat is hereby reserved for this House within our upper legislative chamber, the **House of Lords (*The Synkletos*)**, where they shall sit in perpetuity to guide the laws of the realm.

ARTICLE III: ELEVATION TO THE MINISTERIAL CHIEFTAINSHIP

To structure our global international operations, coordinate our peer alliances, and direct our external embassies, We do hereby appoint and commission His Grace, Duke Phillip Santillanes, to the supreme cabinet portfolio of:

LOGOTHETE OF FOREIGN AFFAIRS AND HEAD OF THE DIPLOMATIC CORPS

He is permanently vested with the full executive authority of the Crown to negotiate bilateral treaties, issue safe-passage documents, coordinate with the Antarctic Micronational Union, and manage all outbound

state correspondence. He shall answer directly to the Chancellery desk under the seals of the Admiralty.

ARTICLE IV: GO_DADDY ARCHIVAL PUBLICATION

The Ministry of Education and the Department of Citizenry, overseen by Countess Jessica Roberts, are commanded to permanently embed this Golden Bull under the "Imperial Archives" and "Ministry Layouts" pages of our paid GoDaddy web facility (`theconfederatedempire.org``). All 1.6K citizens are legally notified that these titles and succession lines are fully active and enforced.
