DOCUMENT 1: THE SUPREME STYLE AND PROTOCOL
OF THE SOVEREIGN EXECUTIVE

FROM THE DESK OF HIS IMPERIAL MAJESTY,
EMPEROR BRYCE L.S.P. IVREA I, Basileus and
Autokrator of the Confederated Empire and
all its Sovereign Domains, Commander of the

Legions, Captain of the Molossian Navy,
Lord of Sealand, Lord of Glencoe, Defender
of the Faith, and Sovereign Grand Master of
the Knights of Napoleon.

TO THE SYN KLETOS, ALLIED WORLD POWERS, AND
ALL CITIZENS, GREETINGS:

WE HEREBY DECREE AND DECLARE that the
official executive style, titles, and
honorifics of the Sovereign Head of State
are permanently unified and locked within
the State Ledger. Operating under our
continuous, uninterrupted Constitution
since November 2, 2020, this instrument
strikes all previous titles from regional
iterations, establishing the unalterable
monarchical style of the Crown for all
legal, naval, and diplomatic dispatches:

ARTICLE I: THE EXCLUSIVITY OF EXECUTIVE COMMAND

The supreme executive and legislative
authority of the realm resides solely and
completely in the person of the Emperor.
Factionalism, partisan divisions, and
foreign political parties are banned. The
lineage of the Throne is permanently bound
to the bloodline of the Anscarid Dynasty of
the House of Ivrea.

ARTICLE II: COMPILATION OF TITLES

Let it be known throughout the international community that the full, legal styling of the Crown is permanently ratified as: HIM Emperor Bryce L.S.P. Ivrea I, Basileus and Autokrator of the Confederated Empire and all its Sovereign Domains, Commander of the Legions, Captain of the Molossian Navy, Lord of Sealand, Lord of Glencoe, Defender of the Faith, and Sovereign Grand Master of the Knights of Napoleon.

DOCUMENT 2: THE CODIFICATION OF ORGANIC
LAWS AND CIVIC JUSTICE

BY ROYAL CHRYSOBULL OF HIS IMPERIAL
MAJESTY, EMPEROR BRYCE I, Commander of the
Legions, Captain of the Molossian Navy,
Lord of Sealand, and Sovereign Grand Master
of the Knights of Napoleon.

TO ALL SUBJECTS, PARLIAMENTARY OFFICERS,
AND CITIZENS OF THE REALM:

WE HEREBY DECREE AND DECLARE that the
Organic Laws and Civil Codes of the
Confederated Empire remain active,
unyielding, and operational. Our legal
system has maintained continuous
sovereignty since its ratification. To
preserve the safety, visual integrity, and
historical honor of our people, the
following statutes are permanently
codified:

ARTICLE I: THE MANDATORY ADMINISTRATIVE
EDUCATIONAL STANDARD

To ensure a disciplined and intellectual
civil service, Abide University and
Institute (AUI) is codified as the sole

accredited university of the Empire. It is an requirement for all government officials to receive a degree or be actively enrolled in an educational track from AUI. The Ministry of Education shall blend classical Grecian learning with Dudeism philosophy, recognizing "The Big Lebowski" as the official cultural masterpiece of the Cabinet.

ARTICLE II: THE ABSOLUTE ANTI-FACTIONAL MANDATE

To insulate our state from division and civil unrest, political parties are strictly prohibited within the Empire. Governance rests solely upon the Emperor, the Nobility, and the Citizenry working in a unified, non-partisan framework. Anyone wishing to claim citizenship or enter our Class A passport registries must permanently abandon all foreign partisan labels.

ARTICLE III: CIVIL LIBERTIES AND NATURAL RIGHTS

The government shall make no laws abridging or limiting a citizen's natural right to keep and bear arms, in accordance with the Second Amendment principles of our Constitution. No business taxes or forced financial sharing formats shall exist for corporate entities registered within the realm. The Treasury accepts year-end

voluntary contributions in livestock, gold dollars, or physical trade goods.

ARTICLE IV: PENAL LAWS AND SECURITY SENTENCING

The Ministry of Justice is authorized to moderate all public state forums.

Desecrating, destroying, or tearing down the National Flag is a high civil offense.

Any individual found guilty of flag defacement, forgery of physical travel passports, or impeding the authorized passage of allied heads of state shall be sentenced to 25 years of hard labor within our designated penal lands.

ARTICLE V: THE LAWS OF HONORS AND COMBAT

Noble peerages pass directly to the eldest child by hereditary right, while younger children retain membership in the Nobilitas under the titles of Lord or Lady. Citizens retain the legal right to face their accusers in trial by combat. Dueling remains a recognized legal option to settle grievances of personal honor if executed before two witnesses using pistols or swords.

DOCUMENT 3: THE IMPERIAL CODIED BOUNDARIES
AND GEOGRAPHIC SECTORS

FROM THE DESK OF HIS IMPERIAL MAJESTY,
EMPEROR BRYCE L.S.P. IVREA I, Basileus and
Autokrator of the Realm and all its
Sovereign Domains.

WE HEREBY DECREE AND DECLARE that the global, decentralized territorial footprint of the Confederated Empire stands permanently codified and protected under our continuous, uninterrupted Constitution. In accordance with the 16th Constitutional Amendment, the Empire retains absolute administrative jurisdiction over all lands on which its citizens reside and stand upon and wherever our flag is planted. The unalterable boundaries mapped by the pioneering leadership of our late, trusted friend, Marquis Aron Kalaii, encompass the following official state territories:

ARTICLE I: THE AFRICAN HEARTLAND THEME
The foundational 795-square-mile desert quadrilateral of Bir Tawil, located between the borders of Egypt and Sudan, remains the eternal, immovable terrestrial seat of power for the Crown. This theme houses the Imperial Capital District of Anscarid, the Great Chancellery, and the 100-acre chivalric land grant belonging to Sir Luis Govea.

ARTICLE II: THE VICEROYALTY OF YUCATAN
The former territories of the historic Republic of Yucatan—encompassing the five grand provincial sectors of Campeche, Yucatan, Quintana Roo, Orange Walk, and Corozal—are formally annexed as a

constituent country into the Empire. This jurisdiction stands protected under Viceroy Grand Duke Sir Walker to promote the local security, trade, and traditional interests of all indigenous Mayan peoples and peninsula residents.

ARTICLE III: THE NORTH AMERICAN MARITIME ENCLAVES

Our sovereign North American jurisdictions are anchored by the Hereditary Dukedom of Machias Seal Island within the Gulf of Maine, held for eternity by Duke Justan Cola I and the House of Cola. This theme is further expanded by the Northwest Consular Enclave located securely at 748 Summerset Way, Sedro-Woolley, WA 98284, alongside our registered state land tracts in Tennessee and New Mexico.

ARTICLE IV: THE POLAR THEME AND PACIFIC DEPENDENCIES

Our southern polar territory, the Fiefdom of Jinsland, stands firmly plotted alongside contemporary polar states on the Antarctic ice shelf. This sector is balanced in the Pacific Ocean by the maritime dependencies of the Naboo Chain, the Submerged Reef of Bermeja (22°33'N, 91°22'W), and our standalone enclaves within the Northern Mariana Islands.

ARTICLE V: THE CELESTIAL REACH

The Empire maintains a preemptive extraplanetary claim encompassing 300 square miles surrounding Olympus Mons on the planet Mars, establishing the outermost boundaries of the Exploration Corps.

DOCUMENT 4: THE ANNEXATION AND EXPANSION OF THE MARITIME PROVINCE OF NEW BYZANTIUM

FROM THE DESK OF HIS IMPERIAL MAJESTY,
EMPEROR BRYCE L.S.P. IVREA I, Basileus and
Autokrator, Commander of the Legions,
Captain of the Molossian Navy, Lord of
Sealand, Lord of Glencoe, and Defender of
the Faith.

WE HEREBY DECREE AND DECLARE that in
absolute accordance with our continuous
Constitution operating without lapse since
2020, and modeling our path upon the
historic Sealand precedent of 1967, the
physical offshore artificial territory
located within the international waters of
the Gulf of Mexico is formally annexed into
the realm. This structure stands
permanently codified as the sovereign naval
seat and physical home base for the Crown,
titled henceforth as: THE MARITIME PROVINCE
OF NEW BYZANTIUM.

ARTICLE I: THE BOUNDARIES OF THE MARITIME BASELINE

The geographic center of this theme rests
upon the physical platform structure
located beyond the 12-nautical-mile
territorial sea limits of all neighboring
macro-national states. The jurisdiction
incorporates the platform's steel jackets,
its cellar and main helicopter decks, and
asserts an exclusive 500-meter maritime
safety zone surrounding its support pilings

to safeguard our borders against unauthorized corporate or foreign state intrusion.

ARTICLE II: THE PRESERVATION OF HISTORICAL OPERATIONS

The Province of New Byzantium shall serve as the central headquarters for the Ministry of Admiralty and the Ministry of Exploration, honoring the maritime cartography originally charted by our late, trusted friend, Marquis Aron Kalaii. The platform is designated as a regional depot for the Imperial Mail Service and a primary garrison station for the Imperial Exploration and Defensive Corps.

ARTICLE III: THE MARITIME BORDER VISITATION ACT

In absolute alignment with our organic civil laws, all foreign vessels, exploration craft, or corporate observers approaching the platform are bound to our non-partisan jurisdiction. Boarding our territorial decks without an official Class A Passport or a verified, Chancellery-issued Sovereign Entry Visa is strictly prohibited. DOCUMENT 5: THE GOLDEN BULL OF
ANSCARID-IVREA DYNASTIC LEGITIMACY

FROM THE DESK OF HIS IMPERIAL MAJESTY,
EMPEROR BRYCE L.S.P. IVREA I, Basileus and
Autokrator, Commander of the Legions,
Captain of the Molossian Navy, Lord of
Sealand, Lord of Glencoe, and Defender of
the Faith.

WE HEREBY DECREE AND DECLARE that to
establish the eternal legitimacy,
historical depth, and right of rule for the
reigning Imperial Household, this Golden
Bull formally codifies, seals, and
proclaims our complete multi-century
dynastic pedigree. Operating under the
continuous authority of the Imperial
Constitution since 2020, this instrument
binds the modern Crown directly to the
ancient sovereigns of Western Europe and
the ancestral chiefs of Great Britain:

ARTICLE I: THE SCRIPTURAL AND GENEALOGICAL
ANCHORS

The Imperial Chancellery registers that the
bloodline of the Sovereign, Bryce L.S.
Provance, known regally as HIM Emperor
Bryce L.S.P. Ivrea I, is the sole legal and
biological fountain of honors for this
realm. This lineage stands independently
verified by public historical archives and
the active Ancestry.com State Ledger,

tracking an unbroken 36-generation chain through the following foundational royal houses:

1. THE HOUSE OF IVREA (BURGUNDY & ITALY): Descending from the 9th-century Counts of Oscheret, Anscar I, Margrave of Ivrea (860 AD), and the early Anscarid Kings of Italy, establishing the core name and title of our imperial dynasty.
2. THE ROYAL CROWNS OF CASTILE, LEÓN, AND ARAGON: Tracing through Alfonso VII ("The Emperor"), Fernando III, Alfonso X "El Sabio" (The Wise), and Empress Joan of Ponthieu, historically codified as "Empress of All the Romans."
3. THE HOUSE OF PLANTAGENET AND YORK: Descending through Richard Plantagenet, 3rd Duke of York, Cecily Neville, and Agnes Plantagenet, embedding the martial lineage of the White Rose of York into the Crown.
4. THE ROYAL HOUSE OF TUDOR (ENGLAND): Tracing directly to Margaret Tudor, Queen of Scots, daughter of King Henry VII of England and sister to King Henry VIII, structurally securing our right to bear the Eastern Orthodox Imperial Crown.
5. THE HIGH PEERAGE OF SCOTLAND (BOYD & MAXWELL): Connecting through the hereditary Earls of Kilmarnock (House of Boyd), the Earls of Dirlet (House of Maxwell), and the ancient Wardens of the Scottish Marches.
6. THE SEPTEMBER 2020 CLAN BUCHANAN ACCORD: Formally linking the maternal Gibson

frontier lineage of East Tennessee to the Gibson Sept of Clan Buchanan, verified by official dispatches with the Chiefly House of Buchanan, cementing our right to display the golden-tongued black Rampant Lion upon the Great Seal.

ARTICLE II: THE ELEVATION OF THE IMPERIAL HEIRS AND ROYAL PRINCES

To secure the permanent continuity of the Throne under absolute primogeniture, We hereby decree the formal elevation, title protection, and ranking of our beloved children within the Imperial Roll of Nobility:

1. HER IMPERIAL HIGHNESS, RAELYNN MIRIAM KORTHUIS PROVANCE: Formally re-affirmed, designated, and codified as IMPERIAL PRINCESS AND HEIR APPARENT to the Throne of the Empire. She stands as the sole legal successor to the Imperial Crown.
2. HIS IMPERIAL HIGHNESS, WILLIAM PROVANCE: Formally elevated, registered, and codified under the supreme rank, title, and dignity of IMPERIAL PRINCE of the Confederated Empire and Peer of the Synkletos.
3. HIS IMPERIAL HIGHNESS, EMMANUEL PROVANCE: Formally elevated, registered, and codified under the supreme rank, title, and dignity of IMPERIAL PRINCE of the Confederated Empire and Peer of the Synkletos.

ARTICLE III: THE EXTENDED SANTILLANES
LINEAGE SUCCESSION

In accordance with the extended laws of continuity, We do hereby legally decree that should the primary line of the House of Ivrea end without direct direct heirs, the absolute right of succession to the Imperial Crown shall pass seamlessly and directly to the chivalric Santillanes lineage. We permanently elevate our trusty and well-beloved supporters, PHILLIP SANTILLANES AND HIS WIFE MOUNYA SANTILLANES, to the ranks of IMPERIAL DUKE AND DUCHESS, granting them a hereditary seat within our upper legislative house, the House of Lords (The Synkletos).

TO ALL MEMBERS OF PARLIAMENT, NOBLE PEERS,
AND SUBJECTS OF THE REALM, GREETINGS:

WE HEREBY DECREE AND DIRECT that to ensure
absolute logistical efficiency, border
defense, and elite civil organization, the
executive branches of the Empire are

formally reorganized. All prior cabinet frameworks are permanently dissolved. The administration of our global themes, enclaves, and maritime dependencies shall be conducted through the eight specialized ministries established herein:

ARTICLE I: THE EXTENDED PORTFOLIOS AND MINISTERIAL OFFICES

1. THE MINISTRY OF FOREIGN RELATIONS:
Governed under the title of The Grand Logothete of Foreign Relations (Held by Duke Phillip Santillanes). Responsible for the Diplomatic Corps and international treaties.
2. THE MINISTRY OF ADMIRALTY: Governed under the title of The Lord High Admiral of the Sovereign Fleet. Responsible for maritime platform acquisitions and defense zones.
3. THE MINISTRY OF MILITARY AFFAIRS:
Governed under the title of The High Marshal of the Legions. Responsible for regular defensive corps deployments, weapons registries, and dueling protocols.
4. THE MINISTRY OF EXPLORATION: Governed under the title of The Grand Cartographer of the Empire. Responsible for mapping global, polar, and extraterrestrial land claims.
5. THE MINISTRY OF SCIENCE: Governed under the title of The High Logothete of Technology and Innovation. Responsible for

alternative energy grids and satellite arrays.

6. THE MINISTRY OF EDUCATION: Governed under the title of The Grand Chancellor of Academic Standards. Enforces the mandatory Abide University and Institute (AUI) qualification filtering.

7. THE MINISTRY OF CITIZENSHIP: Governed under the title of The Registrar-General of the Realm. Custodian of the population census registries and passport tracking lines.

8. THE MINISTRY OF HEALTH: Governed under the title of The Grand Marshal of Health and Public Safety. Manages public emergency manuals and remote enclave sanitation guidelines.

ARTICLE II: ADMINISTRATIVE EXECUTION

All ministries shall host their independent digital data registries securely upon our paid GoDaddy web network to preserve an accessible trail of administrative governance. Factionalism and political parties are permanently barred. Every minister is legally bound by their sacred Oath of Continuity to serve the Crown and the Constitution under our battle-cry: Vae Victis.
