Official Decrees of the Continuous Imperial Chancellery

IMPERIAL DECREE: THE GOLDEN COMPILATION OF
CEREMONIAL RITUAL AND COURT PROCEDURES

FROM THE DESK OF HIS IMPERIAL MAJESTY,
EMPEROR BRYCE L.S.P. IVREA I, Basileus and
Autokrator, Commander of the Legions, Captain of the
10th TN Regiment, Captain of the Molossian Navy, Lord
of Sealand, and Lord of Glencoe, Defender of the Faith.

TO THE SYN KLETOS, HIGH DEPUTIES OF
PARLIAMENT, MINISTERIAL OFFICERS, AND
CITIZENS, GREETINGS:

WE HEREBY DECREE AND DIRECT that to ensure
absolute majesty, systemic civic reverence, and ancient
visual grandeur within our central chambers, the
operational procedures of the Imperial Court are
permanently codified. This tactical charter adapts the
10th-century Byzantine Court protocols of Constantine
VII's "De Ceremoniis" to guide our modern enclaves,
maritime platform dependencies, and digital portals.

ARTICLE I: THE MODES OF IMPERIAL SILENCE AND
ENTRANCE

1. THE SILENTIA: The Supreme Power of the Emperor
rests upon the preservation of executive dignity. No
subject, noble, or foreign diplomat may address the

Basileus directly during an open session of the Court unless spoken to first. All petitions, land claims, and citizen applications must be formatted in English text and passed directly to the appropriate ministerial logothete.

2. THE RHYTHMIC AKKLAMATION: Upon the formal opening of the court gates, the audience shall remain standing in absolute silence. The entrance of the Sovereign shall be accompanied by the sounding of the official National Anthem—the sovereign music the Imperial March from the Dracul video. Upon its conclusion, all present shall execute a formal bow of honor to acknowledge the unbroken constitutional continuity of the Crown since 2020.

ARTICLE II: THE MANDATORY VESTIARION CODES

To preserve the distinct multi-generational lines of our 36-generation lineage and frontier martial heritage, the vestments of the Emperor are legally restricted to two distinct operational formats:

1. THE CASUAL AND FRONTIER VESTMENTS: During regional travel, enclave inspections, or tactical movements with the Imperial Exploration and Defensive Corps, the Emperor shall wear a structured grey coat in the style of a CSA General, supplemented by the traditional Clan Buchanan Tartan Kilt or suit pants, or the summer imperial legions uniform.

2. THE COURT VESTMENTS: During formal audiences, the signing of international treaties, or the issuance of patents of nobility, the Emperor shall be arrayed exclusively in Imperial Purple. All present in the

chamber must wear their certified physical Decrees of Nobilitas or corresponding Medals of Valor.

ARTICLE III: THE AUDIENCE PROTOCOLS AND THE 35-MINUTE LIMIT

1. DIPLOMATIC EMBASSIES: All foreign envoys, international observers, or micro-national representatives entering our capital district of Imperial Anscarid or our offshore platform province of New Byzantium must submit their credentials to the Grand Logothete of Foreign Relations to receive a standard Sovereign Entry Visa.

2. THE EXCLUSION CEILING: In strict accordance with our organic civil codes, all diplomatic visitation windows, petitions, and non-serialized baseline audits are capped at an absolute ceiling of thirty-five (35) minutes. At the tolling of the 35th minute, the Marshal shall clear the audience chamber to protect national security.

ARTICLE IV: PENAL ENFORCEMENT AND SECURITY

The Imperial Court is an unassailable sanctuary of non-partisan governance. Any individual who introduces foreign political parties, partisan debate, or divisive factionalism into the court shall be immediately stripped of their titles, removed from the chamber, and face a legal trial by combat or up to 25 years of hard labor inside our designated penal lands for violating imperial security.
