WHEREAS, TribarLP6, a Texas limited partnership, as Declarant, caused the "Master Declaration of Covenants, Conditions, and Restrictions Tesoro" ("**Master Declaration**") to be recorded under Clerk's File No. 2018034948 in the Official Public Records of Real Property of Williamson County, Texas, which Master Declaration imposes various covenants, conditions, restrictions, easements, liens and charges on the Property (as defined in the Master Declaration); and

WHEREAS, the Master Declaration was corrected by instrument entitled "Correction Affidavit as to Master Declaration of Covenants, Conditions and Restrictions" recorded under Clerk's File No. 2021087304 in the Official Public Records of Real Property of Williamson County, Texas; and

WHEREAS, the Master Declaration was amended by instrument entitled "First Amendment to Master Declaration of Covenants, Conditions, and Restrictions Tesoro" recorded under Clerk's File No. 2021093921 in the Official Public Records of Real Property of Williamson County, Texas; and

WHEREAS, Article XI, Section 11.2, of the Master Declaration, entitled "Amendment/Extinguishment" provides the Master Declaration may be amended by an instrument executed by the President and Secretary of Tesoro Subdivision Liberty Hill Property Owners Association (the "**Association**") certifying that such amendment has been approved by Owners entitled to cast at least ninety percent (90%) of the number of votes entitled to be cast pursuant to Section 7.3 hereof for the first twenty (20) years from the date hereof, and by seventy-five percent (75%) of said Owners thereafter; and

WHEREAS, Section 209.0041(h) of the Texas Property Code provides that a declaration may be amended only by a vote of sixty-seven percent (67%) of the total votes allocated to property owners entitled to vote on the amendment of the declaration, unless the declaration contains a lower percentage, in which event the percentage in the declaration controls; and

WHEREAS, the Master Declaration provides for amendment by the approval of a higher percentage of owners than the percentage set forth in Section 209.0041 of the Texas Property Code; therefore, Section 209.0041 controls with respect to the percentage of votes necessary to effect an amendment to the Master Declaration; and

WHEREAS, Owners subject to the Master Declaration representing not less than sixty-seven percent (67%) of the total votes entitled to be cast under the Master Declaration desire to

amend the Master Declaration.

NOW, THEREFORE, the following provisions of the Master Declaration are amended as set forth below:

Article I, Section 1.20, of the Master Declaration, entitled "**Master Articles**", is amended and restated to read as follows:

1.20 Master Articles. "Master Articles" means the Articles of Incorporation of Tesoro Subdivision Liberty Hill Property Owners Association, which are filed in the office of the Secretary of State of Texas, as the same are from time to time amended.

Article I, Section 1.21, of the Master Declaration, entitled "**Master Association**", is amended and restated to read as follows:

1.21 Master Association. "Master Association" means and refers to Tesoro Subdivision Liberty Hill Property Owners Association, a Texas non-profit corporation created pursuant to the Master Declaration and the Master Articles.

Article III, Section 3.6, of the Master Declaration, entitled "**Animals - Household Pets**", is amended and restated to read as follows:

3.6 Animals - Household Pets. No animals, including pigs, pot-bellied pigs, hogs, swine, poultry, fowl, emus, ostriches, wild or dangerous animals, horses, cattle, sheep, goats, or any type of animal not considered to be a domestic household pet within the ordinary meaning and interpretation of such words may be kept, maintained, or cared for on any Lot. No animal shall be allowed to make an unreasonable amount of noise, or to become a nuisance. No animal may be stabled, maintained, kept, cared for, or boarded for hire or remuneration on the Property, and no kennels or breeding operation will be allowed.

The Board has the authority to determine, in its sole and absolute discretion, whether, for the purposes of this Section, a particular animal is a generally recognized house or yard pet, a dangerous animal, or a nuisance, and the Board's determination will be conclusive and binding on all parties.

Except as amended herein, all provisions in the Master Declaration, as amended previously, remain in full force and effect. Capitalized terms used herein have the same meanings as ascribed to them in the Master Declaration, unless otherwise indicated.

IN WITNESS WHEREOF, the President and Secretary of Tesoro Subdivision Liberty Hill Property Owners Association hereby executes this instrument to certify that Owners representing not less than sixty-seven percent (67%) of the votes entitled to be cast under the Master Declaration have approved the amendment set forth in this instrument in accordance with Section 209.0041(h) of the Code. A copy of the ballots evidencing such approval is attached to the Amendment as Exhibit "A". This Amendment will be effective upon recording in the Official Public Records of Real Property of Williamson County, Texas.
