At our national convention this year, we had another successful rally supporting the protection of our mail carriers as well as standing in unity against the privatization of the post office. It was held in front of city hall in Orlando, Florida. It was quite well attended. We had Florida Congressman Darren Soto and Maxwell Frost speak to the body and encouraged our fight. Our own union president Don Maston as well as Mark Dimondstein (president of the APWU rallied with us and spoke to the body. We also had several carriers speak up and tell their stories. We had members from our rural craft as well as city carriers, mail handlers and clerks. A representation included the entire postal service and was a sign of unity to stand in the way of privatization of the post office. I would like to encourage everybody to call your own congressman to let them know we stand against privatization and we want to see our letter carriers protected. I've written about how you can CREATE CHANGE through the union in past newsletters. Again the only way I have found this is getting involved, reading the newsletters, going to the state and national conventions. The physical way we can influence policy is through submitting "Binding Resolutions" first through our state process, then it heads to national to be on the list for the room of over 1600 delegates at the convention to vote on. If voted in, it is "Binding" that our National Officers negotiate them with the USPS towards our contract or policy. The forms can be found on our local website azrlca.com and national nrlca.org. Ask one of us for help! So, if you want change, be part of the process!

# Words from your District Representative:

There still seems to be confusion about what to do if your informed that you are having an investigative interview and how to file a grievance. So, I am going to cover some of the basics to remember.

Investigative Interview: When management approaches you stating that they want to have an investigative interview or fact finding, you should be asking, "could this lead to discipline?". If they answer "yes", that is when you ask for your Union steward to be present. Management does not have to ask you if you want representation. Then it is your responsibility to contact your Union steward and collectively they will schedule a meeting date and time. Your steward is there to document exactly what is said, stop the interview if certain issues arise, and make sure your rights are not violated.

<u>Grievance</u>: A grievance is not filed until you have brought up your issue with your direct supervisor and attempt to come to a resolution. This is an important step that is often overlooked. It is only when you have not resolved that issue that you inform your direct supervisor that you would like to file a grievance. Your grievance Form 8191 should be printed out by management and lines 1 thru 4 are then filled out. Your direct supervisor that you had the discussion with will initial and date on line 3b indicating that you had a discussion. The original copy of your grievance form is then given to your local steward or mailed to your assigned steward. Make sure to keep a copy for yourself and if mailed, let your steward know it is on its way.

There are A LOT of offices that do not have a local steward. That doesn't mean you are not represented. We have Area Stewards, Assistant District Representative's, and myself that cover any office that does not have a local steward assigned. If you would like to explore what it would take to be a local steward in your office, please contact me. Being a local steward doesn't mean you are always processing grievances. You are the eyes and ears in the office and if an issue arises, it can usually be resolved with the right documentation and through discussion. If you have an office with 50 rural employees or more, there can be 2 local stewards. I will be happy to answer any questions you may have if this may be of interest to you.

If there is any topic you would like to know more about as a Rural Carrier you can email me or notify your State President of what you would like to see in the next publication. Have a safe and happy holiday season!

I wanted to remind everyone about the insurance benefits that are available to NRLCA Regular, PTF, and RCA members. Through Symetra there is Term Life Insurance, Short-term Disability, and Long-term Disability. Hartford offers Accident, Critical Illness, and Hospital Indemnity Insurance. Ameritas offers Dental Insurance, and VSP offers Vision. All these options are available through Greater Insurance service Corp.

As a member of the NRLCA, you can also enroll in the Rural Carrier Benefit Program for health insurance, which is provided through Aetna. Some of the Benefits that they provide is Wellness incentives, they also cover a percentage of qualifying massages through out the year. The big benefit is 100% coverage for cancer coverage.

When open enrollment happens later this year, you may want to compare the RCBP to your current insurance coverage.


