## V. Discussion: New proposed committees -

Welcome Wagon Committee: We have had a gracious offer from Beverly Goddies to help with a welcome wagon committee, but we need more help. We are looking for people to help collect items from businesses to include in the bags, help assemble, and help deliver.

- VI. **SESHCA email list via MailChimp:** We previously had a mailing list. Unfortunately, there was an ability to REPLY ALL on that list. We will now have an email list via MailChimp. This gives the ability to get updates on the neighborhood, and most importantly- gives you the ability to unsubscribe. Anyone who pays dues will be automatically enrolled, as well as anyone who signs up at our meetings. You may also email the association to be added- our email is on the website at the top of the agenda, as well as the footer on the agenda. If there's something that relates to the entire neighborhood you would like added, please email the association and the board will review it for inclusion. Again, if it gets too much, go ahead and unsubscribe.

#### VII. Current Issues:

- Giddens Park— we've gotten reports of boatloads of trash at Giddens Park, as well as criminal activity- the board has been in contact with our TPD liaison who has indicated TPD has increased their presence in the area. Please keep in mind this park is for everyone- it's for all neighbors to enjoy and play in. That being said, if you see clear illegal activity, please call TPD. If it's something that does not need immediate attention, call non-emergency- the number is at the bottom of this agenda. If you or someone else feel endangered, call 911. For those of you who attended our annual Halloween event, Giddens and Ghouls, you may have noticed there was a lot of trash on the ground, as well as poorly kept bathrooms and broken lighting. The trash cans were overflowing and hadn't been emptied in a while. We were able to contact the city to have the trash picked up, cans regularly emptied, and lighting in the pavilion repaired. We're asking the neighbors to help us keep up with this. If you're at the park and you see the trash building up again, please reach out and let us know, so we can contact Parks and Rec and solid waste for assistance. Giddens Park is a treasure for this neighborhood, and we want everyone to enjoy using this beautiful space. If you see an issue, just let us know, we have the contacts and can get it done.
- Construction has rearranged its construction schedule to focus on Central Avenue south of Hillsborough, Crest Avenue and the Hillsborough River outfall. The revised schedule means crews will be working on East Hanna Avenue near Seminole Heights Elementary School in spring of 2023 instead of 2022. This will help the project team reduce impacts to the neighborhoods where crews are currently working, particularly near Hillsborough High School. Construction on Central Avenue is exacerbating traffic congestion near the high school which is impeding residents' access to homes. This schedule change will help us complete work on Central before the start of the next school year, barring unforeseen conditions. Work will begin on or about Jan. 24, 2022, to install a stormwater pipe under I-275 from North Taliaferro Avenue west to Caracas Street. This work continues through April, barring unforeseen conditions. The pipeline will be installed under I-275 by microtunnel, a trenchless construction technique. Crews will work from 7 a.m. to 7 p.m. Monday through Saturday until tunneling is complete. Crews will install the 72-inch diameter stormwater pipeline on Caracas as the tunnel operation is completed. Residents should expect to hear construction noise and possibly feel some vibration during tunneling and pipeline installation. Taliferro north of Ellicott and south of Wilder will be closed until the project is completed.

VIII. **City of Tampa Neighborhood Grants**- the City of Tampa regularly has grants where they award neighborhoods who submit ideas and supports for those ideas. The awards can be up to \$5,000. We've had some great suggestions on how this money could be used, particularly a wonderful suggestion from neighbor Michael about getting sun shades installed at the splash pad. In order to do this, we will have to update our Federal Tax Exempt Status. Trevor speaks about Federal Tax process. As a NFP organization we want to ensure federal tax up to date especially if accepting grants.

## IX. Update to Good Neighbor Announcements

- a. Will be announced via Facebook, NextDoor, website, and email list
- b. We currently have two notices that are the most significant: 1108-1109 E Osborne Ave, for which we have the developers here tonight to talk about the project.
- c. The second is 810 E Ida St; The lot backs up to the advance auto store on MLK at Nebraska, with the great bbq place in the parking lot. It's called Alana Flats. There are 8 proposed units of multi-family attached housing (townhouse), 3 bed/ 2.5 baths, 2 parking spaces per unit built by Showtime Construction. The rendering shows a driveway in the center, and 4 townhouses on either side. We're working on getting the developer to schedule a meeting with the neighborhood to discuss further, so please follow the Facebook page and the emails for updates.

## X. Taste of the Heights - November 6, 2022

Taste of the Heights is the main fundraiser for SESHCA. We will be having a volunteer committee. We ask for 2 hours of time in exchange for a free all-access ticket worth \$55. We will be announcing information on the taste Volunteer committee at our July 19th meeting! By paying dues in January or February, paid members are entitled to early access to Taste tickets.

## XII. Resident Forum (1 minute per association member)

- Giddens Dog Park- need for more sod/ mulch. Association will reach out to the City of Tampa Parks and Rec team about improving the dog park lot, which is full of dirt.
- Resident inquired on cost of dues. Dues are \$12 and decrease based on month when paid.
- Resident inquired about sidewalks on Taliaferro- will follow up with SESH Flooding Plan to see if sidewalks are to be installed.

- XIII. **Presentation from Onyx & East; re: development at 1108-1109 E Osborne Ave.** We'd like to thank the developers for attending and presenting plans, and for taking questions from residents. This is the first presentation, but developer expects there will be more presentations for neighbors to give feedback. The following are bullet-point notes based on the presentation by the developer:
  - Above typical standard suburban price and below custom builder pricing
  - Like to be walking distance to things
  - Blend architect to neighborhood and do a twist
  - · 1102 E Curtis St. (church and parking across)
  - Currently working on rezoning There is a hearing at City Council on May 12<sup>th</sup> 2022
  - · 2.71 acres, 48
  - Single homes facing Nebraska, detached garages
  - Front door have to face streets
  - · Quarter acre courtyard
  - · 2 car garages and 13 guest spots
  - Land development 4Q 2022, sales Q2 2023, and construction Q2 2023
  - · 15/50 and 20/20 2 car garage
  - Aesthetics/traffic discussion on May 12<sup>th</sup>
  - Homes will be 10ft back on 12<sup>th</sup> street
  - 10 ft back we have porches and then the house, your houses start at 10ft and we would be open for 3 stories not 4.
  - · No rentals, all for sale
  - Addt'l 201 south Armenia, Oak avenue in tampa heights, midtown and cypress street
  - 2 single family homes parking lot across street
  - 2 grand oaks and preserve 2 trees (what is coming in to replace going out
