FARM DOG CERTIFICATION TEST

The basic test requirements are designed to demonstrate the dog's trainability, self-control, confidence and trust when working in partnership with their owner. The test is a non-competitive pass/fail evaluation designed to assess the overall conduct of a dog. The dog must demonstrate self-control when exposed to livestock and other unique sights, sounds and scents. The dog should exhibit confidence and a willingness to comply with instructions when confronted with a variety of situations within farm type surroundings.

TEST ELEMENTS:

Test elements may be arranged in any order with the exception of the first and last element (#1 & #12).

- Greet Judge initial Dog appraisal
- 2. Perform a walking pattern around farm environment/passive stranger
- 3. Jump on hay/straw bale
- 4. Walk by farm animals
- 5. Walk over or through unusual surfaces
- 6. Supervised Separation
- 7. Pass through a gate
- 8. Handler feels livestock
- 9. Reaction to another dog
- 10. Reaction to noise distraction
- 11. Dog approaches livestock
- 12. Physical Examination

From the East: Take I-70 to US 43 Exit

Get off of the Finleyville Exit. Make left. Go over Railroad tracks. Make left at the stop sign. Go through the small town of Gastonville. Make right onto Rt. 88. Go through the light; Pass Trax Farms; stay right on 88. Go through the light passing Clifton Road which is on your left. Keep going on 88 until you reach Logan Road. Make a left. Follow Logan all the way staying right at the stop sign. You will pass Brookside Lumber. At the light make a right on to South Park Road. Stay on that road until the intersection of Industrial Boulevard. Make a right at the light. Make the 2nd left onto Progress Boulevard. The building is on the corner of Progress and Transit on the corner. It is blue and white signage and red brick building.

From the North

Take I-70 South to Bridgeville Exit

Stay on Washington Pike until Boyce Road. Go straight through intersection. Make left at stop sign. Follow Johnston Road until light. Make right onto McMurray Road.
