Personal Statement: Medicolegal practice

I have been working as a psychiatrist since 1998 and as a general adult Consultant Psychiatrist since 2008. I have worked in the NHS and independent sector, in both substantive and locum roles. I thus have broad experience in psychiatry in different settings. My main areas of expertise are psychosis, ADHD, autism, neuropsychiatric disorders, personality disorders, challenging behaviors and substance misuse. Over the years, I have also helped improve services and CQC ratings for independent sector hospitals.

I currently work in a private rehabilitation hospital (1day/week in Blackpool), and have my own private practice (1day/week in Greater Manchester), along with medicolegal work (3days/week) throughout England and Wales (online, and clinics in various locations).

I have been providing expert medicolegal reports for civil, criminal, family and Court of Protection cases for over a decade with excellent feedback from my clients and the courts. I am a member of a CPD group for medicolegal experts, and have CUBS (Cardiff University Bond Solon) certification as a civil expert. I regularly deliver medicolegal training and have recently published a chapter on 'Medical Malpractice: Psychiatry' in Enyclopedia of Forensic and Legal Medicine, Third edition.

My turnaround time for reports in the last year was 3.5 days (range 2-16 days) with over 100 reports submitted annually. Some of the common cases I receive instructions for are:
