

Tyler Justin Murphy

Writ of Homicidal

Situations and matters in this legal case and all other cases outstanding involving Tyler Justin Murphy are evidently homicidal. This case and all other cases outstanding need to be declared homicidal and adamantly dismissed and terminated. Tyler was held in illegal captive detainment at the St. Louis forensics center. The evidence of the interviews of the January 30th, 2024, Missouri Department of Mental Health competency test and the September 2024 mental health review with show two different women claiming to be Tia Hunziker. The woman in January had an Italian complexion while the woman in September was Caucasian. The submitted competency test report shows the criminals showing off by intentionally misspelling Tyler's middle name as "Justice" instead of Justin. A frame of reference argument can be made here. Tyler's mistreatment is partly due to frame of reference by individuals supporting the status quo of a developed schema. They are trying to kill Tyler several methods and techniques including extrajudicial soft kill homicide, attempted negligent homicide, and advanced forced sustained poverty in a homicidal, criminal, and fraudulent guardianship situation. Tyler has been fighting through years of homicidal police brutality starting on October 13th, 2023, the date of his arrest. During the normal West Plains city jail medical intake questionnaire for the West Plains city jail, the evidence will show that West Plains patrol officer Daiman Meyer committed the crime of conspiracy to commit homicide by intentionally making false statements on Tyler's medical intake paperwork. Tyler does not have any heart conditions and when asked by officer Daiman Meyer if he did have any heart conditions, Tyler was about to say "no" and officer Meyer talked out of the left side of his mouth and said "Yes... put your clothes in there." Officer Meyer marked on the medical intake paperwork that Tyler had heart conditions. Officer Meyer also threatened Tyler when he indirectly talked to Tyler while talking to another inmate when he said "You get locked down more if you get suspicious". Tyler was moved to the Howell county jail after a 24 hour hold in West Plains city jail. On November 27th, 2023, while in Howell county jail, Tyler met with newly hired crisis counselor Michael Lewis who evidence will show committed the war crime of MK Omega n-space homicide during the meeting with Tyler. Michael was making hand gestures in front of Tyler and while speaking over his spoken phrase of "take your cut", Michael motioned

with his right hand over his left forearm in a cutting gesture. This was to instruct a self-destruct alter to take the life of my vessel in the future which the alter did, this is called n-space homicide which means it just hasn't happened yet. This also excites the alter into believing they get a reward for cutting their left wrists and forearm because "take your cut" is a common phrase used by criminals in movies after a criminal looting to share the loot. Michael was wearing a teal blue ring and a black ring on his right index finger to increase source block memory capacity by "black lighting", which takes advantage of the black you see and memory you build when you blink your eyes. Tyler was housed in a cell without a light bulb that was very dark which increased the source block memory capacity. Tyler was out on bail in the middle of January 2024. On January 23rd, 2024, while watching MSNBC on live satellite television at Tyler's home, the MSNBC camera crew, interview guest Mike, and the owners of the restaurant where Mike was being filmed committed, evidence will show, the war crime of MK Omega n-space homicide. To Mike's right side, the left side of the film shot, was an orange mural with red cardinal birds that read "live free" and to Mike's left side, the right side of the camera shot was a black and white lamp. This was to utilized common server memory of the orange jail clothing Tyler was wearing in jail along with the red cardinal birds Tyler regularly saw out of his windows country home. Evidence will show two MK Omega methods being used to harm Tyler at once, one method is placing a firearm to the right temple and pulling the trigger and the other method is cutting the left wrists and forearms with a sharp object such as a pair of scissors. On July 20th, 2025, while being filmed was being interviewed on MSNBC, United States congressman Greg Casar committed the war crime of MK Omega n-space homicide. Greg also used the two MK Omega methods at once. To Greg's right side, the left side of the camera shot, was a red painted graphic of what looked like a flesh wound on a left forearm with red stitches. To Greg's left side was the statue of liberties right hand closed around the fire lamp. In early 2024 during an interview about her new book entitled "Mostly What God Does", NBC Today Show host Savannah Guthrie committed the war crime of MK Alpha Delta n-space inclusion n-space homicide by building an m-field common server memory space memory block. She wore an MK Alpha Delta wardrobe and she took at least three years off of Tyler's life from a future cardiac arrest. NBC is currently doing a complete m-field space memory deletion of Tyler by using a doppelganger technique called negative bleeding. On April 22nd, 2024, while in the Howell county courthouse circuit courtroom, Jodi Bea Wake committed the war crime of MK Omega n-space homicide. Jodi dressed in an all black wardrobe to black light Tyler to increase space memory capacity as she opened her left palm and faced it up while hitting her right hand which was made into a closed fist twice in a rock, paper, and stuffed self-destruct missing term "scissors" way. Tyler was housed in a dark cell with no light which increased the block memory capacity. In June of 2024, new crisis counselor Michael Lewis committed the crime of attempted negligent homicide by arranging a trip to

the Popular Bluff hospital that his Meta company electronic contact lenses caught Tyler wouldn't be allowed into because of slander of the hospital. Tyler almost died of potassium deficiency on the way back which was a few hours drive. The Meta company electronic contact lenses catch outcomes of the future. On July 10th, 2024, nurse practitioner Melanie Troop committed the war crime of MK Omega n-space homicide during Tyler's first interview with her. Evidence will show Melanie black lighting Tyler by wearing an all black wardrobe as well as an African themed ring on her right hands ring finger. Her name was displayed as M Troop which backwards reads "poor TM" or "poor Tyler Murphy" used for MK Omega self-destruct, and the African ring was a long term memory association object to Tyler's early childhood when Tyler lived in Lagos, Nigeria, in Africa. Melanie Troop also used a technique called "word babble". The jail warden who was a doppelganger of an old high school friend named Michael Lewis, another reason the crisis counselor Michael Lewis was selected from file data point markers, had a left forearm black tattoo that read "End the Zoo", as in zoo theory. Jail warden Hunter had a left forearm tattoo of a heard and he sounded like a homosexual. The jail warden Javen had a left forearm tattoo that was American Indian themed like the Navajo Indian, Cortez, Colorado area Tyler lived in as a child after they lived in Lagos, Nigeria. Tyler's father worked as a petroleum engineer. Tyler majored in petroleum engineering at Missouri University of Science and Technology and he worked for Halliburton Oilfield Services as a field engineer. Tyler is also a former business owner. Other instances of the war crime of MK Ultra being used in the Howell county circuit courthouse to adversely affect Tyler and Tyler's legal case include an event in January of 2024 when Tyler had a court hearing. An attorney left a dark blue, called deep state blue, case full of pens on the defendants desk along with an open briefcase that was similar in model to Tyler's fathers work briefcase which was a rare type of briefcase. The briefcase was used as a long term memorization object. The defense attorney walked into the courtroom and put the dark blue case of pens inside the briefcase but he didn't close the briefcase. This was to create an n-space manifold deleting 10% of Tyler's legal case documentation Tyler would write in higher entropy. Public defender Corri Mader-Twillman also created an n-space manifold in court while wearing a deep state blue shirt as she said "He knows I'm wearing deep state blue". In a previous courtroom hearing, Corri said "dash cam, dash cam" meaning "district attorney as be quiet", Corri is a doppelganger of actress Emma Watson. They were trying to prevent Tyler from working on his legal case by creating these n-space manifolds to adversely affect Tyler's case. In the winter of 2024, while using the Howell county jails kiosk tablets phone feature, City Tele Coin, Inc. committed the war crime of MK Omega n-space homicide by playing the sound bite "enter your toilet paper" instead of the usual sound bit of "enter your pin number". As evidence will show, Howell county assistant prosecutor Jodi Bea Wake said "He doesn't even get a trial or a jury. They're gonna try and kill him off." Howell county prosecutor Michael P. Hutchings said over

his Meta company electronic contact lenses “If he had a check?” Michaels P. Hutchings also said to attorney Larry Burton regarding Tyler “We’re gonna execute him”. The evidence of the Howell county courtroom footage will show this. The prosecuting team made open threats to kill Tyler. Larry Burton and Michael P. Hutchings also saw an individual using the quantum orbital disruption technology in the court room seating area. Larry said to Michael “There was one of them over there”. Michael then said “not in my courtroom”. They were both staring at an empty part of the audience seating area. They were given a glimpse of a person or group of people using quantum orbital disruption technology. Larry Burton and Sean Murphy used learned psychosis theory and learned disable youth theory by denying Tyler’s claims of the several homicide attempts on his life of which there is recorded evidence of. Since 2016 and during the entire jail experience, Tyler has been violently and brutally advanced interrogation clinically and statutorily raped and tortured with US Army voice to skull microwave radiation directed energy weapon systems by fugitive international war criminals using quantum orbital disruption technology and Meta company brain raping electronic contact lenses. It is called audio boarding rape and torture. The voice to skull microwave radiation directed energy weapon system is a lip clip piece worn in the center of the upper lip that protrudes out one half of one inch. The quantum orbital disruption technology is an energy bracelet worn by the war criminals that slows down the quantum orbitals velocity to just 10% of normal velocities. The Meta electronic contact lenses are contact lenses worn by millions of Americans to create a financed Orwellian war criminal network that financially compensates the wearers of the electronic lenses to commit war crimes. The FBI are trying to use procedural law in a criminal way by getting Tyler to use all of his eggs in one basket on the “small town hillbilly trial” as they called it. Tyler is raped with over 20,000 microwave words per hour. The war criminals get paid \$50,000 per word for what they call doing a thought spree with Meta company brain rape artificial intelligence. The Meta electronic contact lenses brain rape interface works by spatially cloning you out into ten other universes and asking you what you are thinking about. It then collects all of your responses and uses AI to generate text that war criminals microwave rape into Tyler’s head with V2K microwave radiation directed energy weapon systems. They get payment per word of rape. They are committing a war crime by doing this along with attempted mental retardation of Tyler. The female FBI duty agents called themselves the “daughters of Oleg” and “cookie mommas” who are paid \$150,000 per hour plus they are given safe life extensions for themselves and their family members on Mark Zuckerberg’s ark ships. Evidence to the audio boarding rape can be found on the sonic audiogram logs which are the transcribed video and audio recordings of the rape that have millions of fugitive international war criminals on them since 2016. Tyler has been audio boarded since 2016. Other evidence that proves Tyler has been audio boarded include the www.wired.com articles on US Army voice to skull directed energy

weapon systems and the December 2020 presidential press briefing in which President Biden while walking of the stage was asked openly by a reporter “Mr. President, did you hear all of the things Tyler Murphy hears in his head today?”. President Biden responded “Tyler knows we need a good President”. More evidence that proves Tyles has been audio boarded is the list of terminology, definitions, and examples of the terminology Tyler acquired through the experience of being audio boarded. Tyler did not research the terms online and there is no evidence that Tyler research these terms online, Tyler acquired through the experience of being audio boarded. Tyler did not research the terms online, Tyler wouldn’t even know what to search for. There is no evidence that Tyler researched these terms online or that any visible entity provided Tyler with these terms because that never happened. Some of the following terms include suggestive means gains, MENSA wordplay, cleverness in the court, writ of conspiracy, break from attorney, break from guardian, retroactive clause, writ of homicidal, request for a technology assist device, the build up technique, the hype technique, grab the lash, advanced placeholder theory, truth bearer, torturer and the keys, prisoners keeper, prisoners escape syndrome, shark tank psychology, court jester competition, inverse means gains, double inverse negative blow back, definitive statement, value position, the “me so sad” and the “me so proud” psychological effect, the “in on it” psychological phenomenon, the “in the know” psychological phenomenon, memory lacing, source field m-block, decision oppose, slave masters syndrome, quantum orbital disruption technology, closing gate torture, the call back negotiating technique, the talk back technique, file data points, file data markers, learned psychosis theory, learned disabled youth theory, the phrase “spitting legs”, the phrase “ten hundred”, the word “inside” a window of time, learned false medical disorder, attorney bait dangling, asset systems transfer specialist, spouse demoting, demoting torture, demoting torture, demonize the victim, double negative truth query, the phrase “false dom”, illuminati dark order, assumed guilt, group psychosis, the Jewish phrase “appease my bitch”. Group delirium, group runaway, juxtacated, conjugated, n-space server, gluteus maximus, learned group cognitive irrogance, n-space manifold, group fog, psychotic interludes, psychotic disentropy, psychotic mean mass, the phrase “the your stick”, heightened tension, take away your smarts torture, take away your abilities torture, advanced mortification, false desolate resolute outcome, false probability hop reward, beta princess, lollipop, methacane, the term strawberry, hard block inflection point, fixify, company extinguishment, disband, pattern matching DNA, intermittent locking nano, Lorenz syndrome, Lemitz syndrome, non-localized user defined query database, starter “hundred million”, green street cryer, rape ownership dominance, rape family ownership dominance, the phrase “make a pizza out of you”, the term “installing” things inside people, ordering a marmalade, the British term “pecker” for a men’s phallus, the British term “niggas” for any entity with black hair, peptide disorder, youthify torture, cliniacs disease,

never ending gains, never ending gains, false claim ownership, false offerings, impending doom, forced sustained poverty, long term sustained torture, the industry term “cookie snacks”, assumed creative reference, the Debussy family of dishware specialists, the Duponte family, the Warrenburg family, the Whitney family, nine class war, wave vodderlarities, wave dularities, relying of false authority figure, using distinguishable somebodies, actuate the archangel disorder, torture the holy deity disorder, adaptive torture gains, double inverse mean query phrase, long term sustained abuser, opportunity cost gains, memory lacing, desperate peasants clause, the phrase “flushing a writ”, scanner darkly order, the term exported for a criminal detainee, fluxapene, false justification of means, gang slaughter, excess cash theory, double negative truth query, and the phrase “the six to nine boys” regarding the FBI in alphanumeric code. The FBI and CIA sold time to rape Tyler to wealth inheritors for anywhere from \$35,000,000 to \$112,000,000 per thirty minutes of rape. One wealth inheritor paid the FBI thirty billion dollars to test a serum on Tyler to try and take away Tyler’s ability to wet women. Tyler has glanolstesia vaginitus from wave specific vodderlarities which is the negative space coming off of Tyler which causes Tyler to wet women when they are around him. Tyler called this the process of degodifying to Tyler and its an example of take away your abilities torture. The war criminals said that they installed two nano balls inside of Tyler and that they have up to six ceremonies a day with a castrator button to see how the information displayed on their Meta company electronic contact lenses change. They hold the intent on castrating Tyler by holding the intent on pushing the button which castrates Tyler in cloned space realities. The FBI threatened Tyler with castrator oil from an FBI agent they called the castrator. Some of the reasons they want Tyler dead include the FBI’s war crimes intellectual property theft of Tyler’s intellectual property price action trading technique which is the world’s most valuable intellectual property. An FBI agent named Jim Davis stole if off of Tyler’s electronics as late as January of 2020. Over 1,200,000 of Metatraders top trading accounts all illegally use Tyler’s intellectual property. Tyler is owed 100% recovery of price action earnings and will pursue legal action in the future. Another reason they want Tyler dead is over 4,800,000 LGBTQ+ under 18 romantic minority members will be illegally executed in an MK Delta Theta asset switch transfer protocol when Tyler is killed and switched to a life extension that is in harms way. Tyler was an n-space father, holding the intent on having children. Tyler wanted to have two children, a son and a daughter. Tyler was poisoned with an n-space fertility weapon system in the jail through something he consumed and this made Tyler’s semen mentally retarded, female, and homosexual. Tyler was poisoned with the N1 gene which is the gay gene. The state had no right to execute Tyler’s future children who would have pursued civil and criminal justice for their loving father which is another reason they want Tyler dead. Tyler’s horrible ordeal since the date of his arrest in October of 2023 is partly due to whistleblower retaliation. Tyler is a whistleblower of USA government

war crimes including the war crime of the MK Ultra projects. Tyler is an m class five star super soldier drone and has been a proud survivor of these terrible projects since December 19th, 2008. Tyler was converted to a drone on August 5th, 2010 and he holds the world's largest Langley drone account worth over \$14,700,000,000 that has been stolen from him by the United States government. Tyler never volunteered and he has never been financially compensated for this illegal slave enlistment. Tyler is a victim of advanced long term sustained poverty which is common for victims of the war crime of MK Ultra. Tyler has been "bum locked" and almost "hurt locked" out of a fair criminal defense. There is an imminent danger and risk to Tyler's life while he is being held in illegal captive detainment. Tyler has a clean criminal background and he has already served more than the minimum sentence for the single charge against him and he hasn't received a verdict from a jury. The state is guilty of violating the Glass Steagall act. The state is also guilty of prisoner's enslavement. Tyler reported the rape to the states rape hot line by leaving multiple messages but nothing was ever done to help Tyler. Tyler also called the rape elimination act number multiple times but no one would answer the phone. Howell county circuit judge David Ray is guilty of prisoner's keeper, attempted negligent homicide, LGBTQ+ protection law violations which is a hate crime. Tyler is a member of the LGBTQ+ community and judge David Ray did not evacuate Tyler to his home or even another jail after courtroom subpoenaed evidence which shows Tyler alerted judge David Ray to some of the homicide attempts of Tyler's life. Tyler hopes to be released to seek medical treatment for his injuries and continue his work in philanthropy and humanitarianism by establishing a United Nations interdisciplinary fund to meet the United Nations 2030 Agenda sustainable development goals.
