

# Church Update

## Guidelines for COVID-19 Amendments as of March 25, 2021

St. Luke's Church Council and Jess McLard, Board of Elders Chair held a meeting on Thursday, March 25<sup>th</sup>, 2021 to discuss amendments to the St. Luke's Safety Protocol Guidelines and how to safely implement amendments. It was determined that St. Luke's is a hybrid of Phase 3 through Phase 5 based upon the Missouri Mid-South Conference outline. In reviewing the Re-opening plan set forth on June 19, 2020, below are the areas that were discussed in detail along with amendments approved:

**Worship Service Reservations** - Reservations are still required at this time due to only having one usher each Sunday and making sure we are properly prepared for attendance, each week. These reservations can be made by calling, texting or emailing Tricia, our church secretary or by using the newly developed Signup Genius link that is sent out and available on the Church's website.

**Worship Entrance / Restroom Use** – We ask that everyone continue to use the handicapped access door to enter the Sanctuary. The Sanctuary doors will be unlocked solely for safety reasons, in case of an emergency. The Educational building restroom use only for Fellowship hall attendees is amended to allow use for Sunday school. The upstairs restroom remains open for Sanctuary attendees.

**Social Distancing** – The 6ft social distancing request and recommendation to stay and sit with only anyone in your family group has been revised. We realized that many family groups may or may not reside in the same home. The guideline has been revised to accommodate those attending that wish to have their family sit with others if all agree to be together.

**Mask Mandate & Sanitizer** – Our mask mandate remains the same. Masks must be worn at all times. Sanitizer remains available for your use upon entry and exit of the Sanctuary.

**Seating** – The pews in the Sanctuary were setup to every third pew open to ensure social distancing. The pew use has been amended to allow more seating. Looking from the altar (the side of the church closest to the driveway) RIGHT, the use of pews 1,3,5,7,9 with added folding chairs at the back wall when needed will be available. On the Parsonage/handicap entrance side of the Sanctuary (LEFT), the use of pews will remain the original setup use of 1, 4, 7, 10.

**Communion Sunday** – If it is a Communion Sunday, we will continue with “BYO” (bring your own) communion elements. We now have cups sitting on the piano that you may take for communion or you may still bring your own if you wish.

**Offering** – This remains the same. The offering plate will be at the entrance to receive your offering.

**Use of Books / Singing** – This remains the same, No Hymnals, bibles, friendship registry in place. In regard to singing, this was amended several months ago to allow CHOIR ONLY and will remain the same as it has been for several months now, NO congregational singing yet.

**Service Length** – The previous thirty (30) minute time limit on services has been amended to “not exceed one (1) hour, pending special services such as Easter, Confirmation, holidays”.

**Sunday School** - This restriction to not hold Sunday School has been amended to allow the reopen of Sunday School on April 11<sup>th</sup>, 2021 after Service with guidelines as follow: reservations, assigned seats, attendance list, mask, social distancing, 30 min time limit, teachers clean after, private art box, limit them to the Fellowship Hall and Fellowship Hall restrooms. Confirmation class has moved to Chrissy's classroom.

# Church Council

## Meeting Minutes from March 16, 2021

The Church Council met on Tuesday, March 16<sup>th</sup> for their regularly scheduled meeting. Minutes from the February 16<sup>th</sup> meeting were reviewed and approved.

**Executive Committee:** Linda Schrepel has agreed to learn the Zoom setup for Worship services.

**Pastor's Report:** Pastor Pittman announced he has received his first vaccination shot and should be in-person by Mother's Day.

**Amendment to Re-Open Plan:** Jess McLard joined, representing BOE and discussion over line items and how Elders felt regarding amending re-open plan. Motions were made to amend current guidelines.

**Endowment Committee:** Meeting to be held in May.

**Building and Grounds Committee:** Lighting has been ordered for the Sanctuary. Dwight will follow up with the electrician for install once the supplies arrive. Dwight has had two appointments with the Sanctuary door contractor but was "stood up" both times.

**Cemetery Committee:** Warren has been talking with Garry Dale and Derek Ehlers. He is looking to setup a meeting with Becky/Tim and Treasurer so that more than one person knows what is going on with the cemetery.

**Worship:** Reviewed how worship services are going every Sunday. The Zoom meeting/hybrid in-person worship services are going well.

**Sunday School:** Sarah Saputo submitted letter to Church Council requesting that Sunday School be reopened, was discussed at an All-Board Meeting held at the beginning of March. Linda Schrepel motioned to approve resuming Sunday School on Sunday 4/11/21 after service. The motion was seconded by Gary Hartmann and majority was in favor. This re-open will follow protocols. (see BOCE minutes).

**Resignation:** Dave Pippin announced his resignation in effect immediately March 16, 2021 from Church Council as Treasurer. Church Council will be working to fill this position in the coming months.

# Board of Elders

## Meeting Minutes from March 9, 2021

The Board of Elders held their regularly scheduled meeting on Tuesday, March 9, 2021. Minutes from the February 21<sup>st</sup> meeting were reviewed and approved.

**Worship:** In-person worship is going well. Altar cloths were changed from violet to white for communion on Sunday, March 7<sup>th</sup> and then back to violet for Lent. The altar flowers have been updated to a more spring color theme. Pastor Pittman is trying to keep service to a max of 30 minutes so we can stay within COVID protocol and restrictions.

**Ushers:** Things are going smoothly with in-person worship services. Need to clarify with ushers that they are responsible for lighting the altar candles at the beginning of the service and extinguishing them at the end of the service.

**Nursery care:** At this time, no nursery care is being provided.

**Communion:** A resupply of the pre-filled communion elements has been ordered.

**Confirmation Class:** Confirmation has been set for Sunday, May 16<sup>th</sup> during the regular 9 a.m. service. The 2021 class is: Kaylin Hollerbach, Olivia Raebel and Elizabeth Skaggs.

**Funerals/Memorial Services:** At this time, it is preferred funerals be held at a funeral home.

**Weddings:** May 21, 2022 Justin Stuckmeyer and Courtney Merli

**Old Business:** The Elders started their food drive on March 7<sup>th</sup>. There is a drop off box in the room just inside the handicap entrance. Don Dankel plans to pick up and deliver the food to the food bank. The drive ends on Easter Sunday. Audio quality for members attending Sunday services virtually has improved thanks to Rev. Pittman.

**2021 Lenten Mission:** The BOE 2021 Lenten Mission will be PonyBird. Lenten envelopes will be placed in the Sunday bulletin for the three Sundays prior to Easter.

**Easter Season:** In coordination with Rev. Pittman, times have been set for Palm Sunday, Good Friday and Easter Sunday.

**Member Care:** Member Care strategies discussed, and Rev. Pittman said member care should be Elder's priority. Much discussion how to reach out and contact members who have not been attending church.

**Bylaws:** Elders would like to address what the Bylaws state about membership and present a recommendation at a later date. Membership roles need to be updated before a new Pastor is hired.

**Other:** The "flower room" just inside the handicap entrance has been cleaned up and refreshed.

# Board of Christian Education

## Meeting Minutes from March 2, 2021

The Board of Christian Education met on Tuesday, March 2<sup>nd</sup> for their regularly scheduled meeting. Minutes the December 1, 2020 meeting were reviewed and approved.

**Sunday School:** Connie continues recording the Children's Message, which are archived on our website, as well as being used during the Sunday Worship Service. Sarah presented at an All Board Meeting held March 1, 2021 and the plan to re-open in-person Sunday School will be reviewed and discussed at the next Church Council meeting. Pending approval, the target date for re-open is April 11<sup>th</sup>. A magnet will be handed out with information at the Easter trunk hunt and announcements will be made in worship services and notices will be posted on social media. The classrooms will be divided into three groups in Fellowship Hall, meeting for 30 minutes following Sunday service. The most recent safety protocols will be followed. Each child will have an assigned seat and an individual supply box. Teachers will be asked to wipe down areas with antibacterial wipes and usher children to "parent pick up".

**Confirmation:** Confirmands are being invited to make palm crosses on Saturday, March 27<sup>th</sup>. Confirmation Sunday is planned for May 16<sup>th</sup>, 2021 and will be held during Sunday Service. Items needed for Confirmation includes white robe rental, red corsages, engraved leather bibles, engraved chalice/communion cups and U.C.C necklaces. We will ask Tricia for previous year's contact information or old invoices to order the above items.

**Voyagers / Youth Group:** Remains on hold.

**Missions:** Designated mission for each quarter: PonyBird, Crisis Nursery, Brenden's Backpack and Camp Mo-Val. Chrissy will provide a donation jar for PonyBird collections to be placed on the piano at the entry. This will be updated to reflect the respective mission as it changes. Sarah has contacted someone regarding sponsoring a local family in need.

**Canned Food Drive:** 400 canned food items were collected or bought with donations. \$200 went to Brenden's Backpack plus additional food items. Note: Aldi's and Amazon Wish List are both places this mission uses for purchasing items. Remaining food items went to Jefferson County Rescue Mission.

**Sunday School Classrooms:** Terry Kohler agreed to paint the three upstairs Sunday School classrooms. Dwight will meet with Gail to over the details and look at paint swatches. Board members interested in the color choices will meet at 11 a.m. on 03/27/21 at the church.

**Calendar of Events 2021:** Committee is looking into the upcoming months and possibility of a family VBS event, an all-church picnic, trunk or treat, hayride/bonfire, Santa breakfast and Christmas program.

*"The message below was distributed in Aug of 2020 ... recently, the Church received a bequest from Reverend Marge Swacker's estate, and it has been committed to "future projects" for the Church. I thought it appropriate that this message be published in our Beacon newsletter as a tribute to Marge and her "thoughts and prayers" for all of us."*

"Hi! I want to share with all our St. Luke's friends that Reverend Marjorie Swacker has passed away, sometime last night (August 8<sup>th</sup>.) For the last month or so, she had been in a health care center, where she had preliminarily been diagnosed with dementia. I had spoken with her approximately two weeks ago and she was very confused, and it was one of the few times where she did not end her conversation with "Tell everyone at St. Luke's I said hello, and they are in my thoughts and prayers."

Pastor Marge was our first assigned Interim Pastor and I sat on the Board when she was interviewed for the position. She and I often reminisced about Garry Kraus (SR.) asking her what it was like to be a woman "in ministry". Her answer was close to "... well, I've never been a man in ministry, so I think it's fine!" She was our first woman in the pulpit at St. Luke's.

She and I had remained friends over the many years, as most of you know, having traveled to Europe and on big cruise ships together. Her home was in Oceanside, CA, and Carl & Carolyn Kraus and Gary & I had visited her there, a few years ago. (My sister & her family reside nearby in Mission Viejo, CA.)

Marge was an only child, so in some ways, she may have been lonely near the end. But she always cared about her St. Luke's family and valued her time here. Just thought I could share."
