What is this document and where is information from

This advisory shows where client device deals truly happen, who buys and when, using analytics turn your sales motions into higher probability and stop sales effort on low-probability pursuits. Every year, hundreds of millions of dollars in notebooks, desktops, monitors, and client devices are purchased through Government of Canada standing offers. While the rules are public, real buying behavior - who buys, how often, at what size, and through which partners - is not obvious.

Purpose of this document is to provide an independent overview of the procurements that were processed by the government of Canada through the department of Shared Services Canada client devices standing offer. This is specific to the notebook, desktop, monitor and associated accessories that are part of National Master Standing Offer [NMSO] E60EJ11000C. The time frame for this review is Canadian federal government fiscal year 2022. Specifically, the date range is April 1, 2021, to March 31, 2022.

The values that are presented here are derived from data mining an open-source government of Canada dataset. This data is part of the government of Canada's open government initiative to enhance accountability and transparency. Under this program government entities report procurements greater than \$XXX,XXX Canadian. This dataset informs the following.

Sales organizations would benefit from the information contained in this advisory to perform health checks, competitive analysis and develop sales motions.



Overview of GoC FY20XX Procurement Cycle and Transaction Type

For GoC fiscal 2022 departments procured \$XXX,XXX,XX worth of client device technology through standing offer E60EJ11000C.



Under SO E60EJ-11000C there are three main procurement transaction types.

- 1.) Call-up
- 2.) Elevated Call-up
- 3.) R.V.D

A call-up is a transaction at the NMSO offeror set price, typically small quantity buys. No margin erosion at this transaction level. Authorized public sector entities may handle these contracts themselves, between them and the NMSO offeror's authorized VAR. Sales motions and relationships are important part of this level.

An elevated call-up is the next level of transaction for greater quantities. This level of transaction considers a formula set by Shared Services Canada that calculates a score for pricing segments of an Offeror's standing offer. A rank is then set based on that score; ranks are from XX to XX. The higher a rank the larger the size of a transaction may be conducted. All elevated call-ups are handled between Shared Services Canada and the NMSO Offeror along with their NMSO authorized VAR where applicable. At the elevated call-up level there is margin erosion. Depending on the rank, and the size of the transaction, the NMSO offer set price must be reduced by XX%, XX% or XX%. Sales motions and relationships are important part of this level.

A R.V.D. or Request for Volume Discount is significant margin erosion, it is where Shared Services Canada releases a large volume requirement, those interested in bidding may do so and should expect significant competition to get to a best and final price, and lowest priced both administratively and technically compliant bid to the GoC wins the bid.

The table below demonstrates the different levels of transactions, the number of transactions in the range and associated total dollar procurement values in that range.

Eligible public sector entities procured the most from Dell, Dynabook and Northern Micro, in that order. Dell had the greatest market share with XX.X% of total procurements, over \$XXX,XXX. Dynabook came in second with XX.X% market share and Northern Micro at XX.X% market share. You will see from the following chart that there were transactions that could not be attributed to one vendor or another and labeled as “undeclared”. This is due to the way that the GoC employee coded the transaction, and not applying the full code to the entry. This represented XX.X% of total procurement dollars recorded.

It is important to note that the dataset shows that in GoC FY20XX IBM standing offer had transactions. This is believed to be a clerical error by GoC in the dataset as IBM has not transacted business in an SO such as E60EJ-11000C since prior to 2008 for client devices.
