Lessee agrees to keep the inflatables, games and or concession equipment in his/her custody and not to sublease, rent, sell, remove from the Delivery Address, or otherwise transfer such inflatable(s), game(s) and/or concession equipment. The inflatable(s), game(s) and/or concession equipment will remain the property of the Lessor and may be removed by Lessor at any time after the termination of this Rental Contract.

**AGREEMENT & GENERAL RULES TO FOLLOW DURING USE OF Monkey Giggles, LLC UNIT ARE:**

Lessee is responsible for safety of all users of inflatable(s) /game(s) /concession equipment. Lessee will be responsible for providing an attendant for all equipment unless a Monkey Giggles, LLC employee has been hired to do so.

**IF THERE'S A PROBLEM WITH THE UNIT ON SITE THAT CANNOT BE CORRECTED, CALL:

**ABSOLUTLY NO SPRAY STRING OR SILLY STRING TO COME INTO CONTACT WITH INFLATABLE!!  
OR YOU WILL BE CHARGED CLEANING/REPAIR/REPLACEMENT COSTS. (IT MELTS VINYL)**

**PLEASE NO: GUM, CANDY, FOOD, DRINKS, ICE CREAM, INK, PAINT, CONFETTI, ETC ALLOWED INTO INFLATABLE. ALLOW ALL FACE PAINTINGS/TATTOOS/ETC. TO DRY PRIOR TO ENTRY INTO UNIT. If additional cleaning is required due to food, beverage, blood or any other contaminants , lessee agrees to pay a MINIMUM \$75.00 cleaning fee. PLEASE - DO NOT ALLOW EATING OR DRINKING IN THE INFLATABLE.**

**SAFE OPERATION & DAMAGE RESPONSIBILITY ACKNOWLEDGMENT:**

Lessee acknowledges that he/she has been instructed about and fully understands the safe operation of the inflatable(s), game(s) and/or concession equipment that is/are the subject of this rental agreement AND that weather related safety issues have been discussed and Lessee has received a copy of "be aware of inclement weather" document. Lessee agrees to observe all safety precautions. Lessee also represents and warrants the safe return of the inflatable(s), game(s) and/or concession equipment and hereby agrees to pay five thousand dollars (\$5,000) per inflatable(s), game(s) and/or concession equipment if it/they is/are not returned. There is a minimum charge of \$100 per game for any repair to the game(s) due to the lessee's negligence. A charge of \$50.00 per hour per game plus materials will be imposed for repairs. Lessee agrees to pay for loss or damage caused by negligence of lessee, employees or persons to whom the equipment is entrusted. Lessee further agrees to pay for loss or damage caused by the use of the equipment in violation of any terms of this agreement, and/or any accompanied agreement(s) and/or addendums. If Lessee has insurance covering such loss or damage, Lessee agrees to exercise all rights available to him under said insurance, take all action necessary to process said claim, and assign said claim and any and all proceeds from said insurance to Lessor. Upon request of Lessor, Lessee shall furnish the name of his insurance agent, insurance company and complete information concerning coverage carried.

**RELEASE OF LIABILITY:**

The Lessee shall be in charge of the inflatable game's operation and any other rental equipment, and is fully responsible for its operation as well as return of all equipment including the inflatable(s), game(s) and/or concession equipment and all other rental equipment in good working order. Lessor and its officers, employees and agents is/are not responsible for injury occurring to the Lessee or to any other person using the inflatable(s), game(s), concession equipment, generators, or other rental equipment and the Lessee further agrees to hold Monkey Giggles, LLC and its officers, employees and agents free and harmless against any injury or claims. The Lessee shall indemnify the Lessor and its officers, employees and agents from/against any costs incurred due to claims from anyone and for attorney's fees and related costs involving the use and return of the inflatable(s), game(s), concession equipment, or any other rental equipment (including but not limited to: generators, boxing gloves, blowers) should legal action become necessary. Lessee agrees to grant Lessor or Lessor's representatives the right to enter premises of customer at anytime to repossess said equipment. Lessee agrees to reimburse Lessor for any and all attorney fees, court cost and expenses incurred to enforce collection or to preserve or enforce rights under this contract. I have received and reviewed the "inclement weather" and "inflatable safety" notification and understand correct operating procedures in case of weather.

Overnight rentals: Lessee understands and acknowledges that the blower is to be removed from the inflatable device and secured so as it cannot be used..

## **BE AWARE OF INCLEMENT WEATHER**

*ONCE THERE IS A THREAT OF INCLEMENT WEATHER,  
STRONG WINDS (AT OR IN EXCESS OF 10 MPH),  
THUNDERSTORMS, DARK CLOUDS, CHANGE OF WIND  
DIRECTION OR WEATHER ALERTS*

*ANYONE INSIDE THE INFLATABLE SHOULD IMMEDIATELY EXIT .  
THE BLOWER SHOULD THEREAFTER BE SWITCHED OFF AND  
REMOVED, AND THE UNIT ALLOWED TO DEFLATE UNTIL THE  
THREAT HAS PASSED.*

### **! INFLATABLE SAFETY !**

It is lessee's responsibility to limited number of participants on each ride to a safe number.  
**ALL SLIDES:** are limited to 3 individuals at any one time on ride. ONLY 1 (one) person should be allowed to slide completely down and exit the ride before the next person be allowed to begin to slide.

**ALL BOUNCERS:** Limited to a safe number based on the size of the riders and the size of the ride. Generally, each rider should be able to maintain a three foot radius between other riders. Larger(heavier) riders SHOULD NOT be mixed with smaller (lighter) riders.

**OBSTACLE COURSES:** are limited to not more than 8 individuals based on the size and complexity of the ride. Individuals should be spaced in such a manner as 1 (one) rider exits while another enters.

**CONCESSIONS:** Only adults may operate concessions. Please keep in mind concessions have moving parts and may be hot.

### **WATER SLIDES MUST BE SUPERVISED AT ALL TIMES!!**

**DURING NON-USE OR UNSUPERVISED TIMES THE SLIDE MUST BE DEFLATED ALLOWING ALL WATER TO DRAIN.**

- KEEP KIDS TOGETHER BY SIZE NOT AGE.
- ADULT SUPERVISION IS REQUIRED AT **ALL TIMES**.
- NO FLIPS, NO ACROBATICS
- REMOVE SHOES, EYEGLASSES OR LOOSE JEWELRY
- PLEASE KEEP FOOD, DRINKS, TOYS OUTSIDE UNIT.
- ***ABSOLUTELY NO SILLY STRING! (IT WILL MELT THE VINYL AND YOU WILL BE CHARGED FOR REPAIRS.)***
- OVERNIGHT RENTALS - YOU MUST DETACH BLOWER AND KEEP IN A SECURE LOCATION OVERNIGHT.
