<p>What is the SRCS F-1 Student Health Insurance Requirement? 남부개혁은 유학생들에게 건강보험을 들도록 요구하나요?</p>	<p>Southern Reformed College and Seminary (SRCS) requires that all F-1 visa international students, with an SRCS issued I-20, maintain health insurance coverage as a condition of enrollment. 남부개혁 대학/신대원에서는 모든 F-1 비자를 소지한 유학생들에게 건강보험을 등록시 꼭 들도록 요구합니다.</p>
<p>Does Southern Reformed provide student group insurance? 남부개혁에 학생들이 단체로 드는 보험이 있나요?</p>	<p>Southern Reformed currently does not provide student group health insurance. Each student is responsible for finding an international student health insurance. 현재 남부개혁에서 단체 학생 건강보험이 없습니다. 각 개인이 국제 건강보험을 들어야 합니다.</p>
<p>Who is subject to the insurance requirement? 누가 건강보험을 들어야 하나요?</p>	<p>All F-1 visa students and his/her family (already have F-1 status) with a Southern Reformed College and Seminary Form I-20. F-1 비자를 소지한 모든 학생들과 가족입니다.</p>
<p>What evidence must I submit to the ISO/DSO to satisfy the insurance requirement each semester? 어떤 보험가입 증명서를 제출해야 하나요?</p>	<p>A current insurance policy must be submitted. 건강보험 계약서 (Insurance Policy)를 제출합니다.</p>
<p>Who do I submit my evidence to? 누구에게 증명서를 제출하나요?</p>	<p>The ISO/DSO who issued your Form I-20. I-20를 발급한 유학생 담당 사무실/ 담당자입니다.</p>
<p>How often must evidence be submitted to the ISA/DSO to satisfy the insurance requirement? 보험 증명서를 얼마나 자주 제출해야 하나요?</p>	<p>Every semester before course registration. 매 학기마다 등록 전에 제출합니다.</p>
<p>If I am a new student, do I have to wait until I am in the United States to purchase the insurance from the college-approved</p>	<p>No, you do not have to have arrived in the U.S. to purchase the insurance. However, you should wait until after you have received your visa/Change of Status decision and know the address in the U.S. where you will be staying before doing so.</p>

<p>provider? 신입생일 경우, 미국에 도착한 후 학교에서 지정한 보험회사에서만 가입해야 하나요?</p>	<p>We encourage you to satisfy this requirement as soon as possible before arrival on campus to avoid registration delays. 아닙니다. 꼭 그럴 필요는 없습니다. 하지만 비자를 확실히 받은 후, 미국에 머무를 주소가 생긴 후 가입하는 게 좋습니다. 또한, 미국 입국 후 되도록 빨리 보험에 가입하셔야 매 학기 등록에 문제가 없습니다.</p>
<p>What are the deadlines for satisfying the insurance requirement? 언제까지 보험에 가입해야 하나요?</p>	<p>Students must satisfy the insurance requirement before they will be allowed to register for any classes for the semester. 각 학기, 등록하기 전에 보험가입 증명서를 제출해야 합니다.</p>
<p>What happens if I do not satisfy the insurance requirement? 보험가입 요구사항을 지키지 않으면 어떻게 되나요?</p>	<p>If you do not satisfy the insurance requirement for a particular semester, you will not be allowed to register for classes for that semester. Failure to enroll in classes may lead to a loss of F-1 status. 보험가입 증명이 되지 않을 경우, 그 학기에는 등록 할 수 없으며, 그로 인해 유학생 신분이 없어질 수 있습니다.</p>
<p>Who can I contact with questions? 질문이 있을 경우 누구에게 하나요?</p>	<p>The International Student Advisor/DSO at the campus where your immigration record is located. 남부개혁의 유학담당자에게 합니다.</p>
