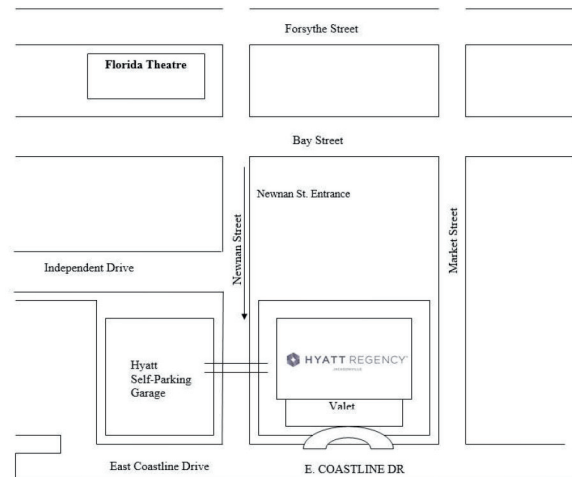

Parking

Self-parking is available in the parking garage, located through the Newnan Street entrance on the ground level. When entering, the gate will automatically lift up after reading your license plate. Attendees will receive a discount voucher during registration/check-in on the day of the event. Please be sure to use this parking voucher, for \$15 + tax, when exiting the garage. Overnight Self-parking is \$34 + tax per day / per vehicle and will be posted to guestroom folio.
