## Annual Accounts - Year Ending March 2023

The following documents relate to the accounts for the year ending 31st March, 2023 and are published in accordance with the current legislation. The council qualifies for Exemption from a formal External Audit and the certificate for this has been forwarded to the external auditor.

### Public Inspection

In the meantime, residents have the right to apply to the clerk for an opportunity to inspect the financial records and associated documents for the year and to ask questions. For these purposes, the period of inspection commences on Monday, 5th June, 2023 and closes on Friday, 14th July, 2023. Contact details are given below and on the notice later in these documents.

As regards the total balance stated at the end of the year, it should be remembered that this includes funds reserved for specified uses - a total of £11,797, as well as the general fund for all regular purposes of £4,465. Details are shown following the Bank Reconciliation sheet.





## Annual Return - March 2023

With reference to Section 1 - Statement of Accounts:-

Some of the year-on-year differences are within the 15% threshold so do not require comment. The only exceptions are detailed below.

**Box 3 - Income** - This saw an overall increase of **£1,585**. It was largely due to a grant of £1,000 for the purchase of a Jubilee Clock and Donations of £1,180 towards the other Platinum Celebrations. There has also been a further £100 for the Coronation event on 7th May.

Donations and fund-raising for the Play Area brought an extra £211, while the recent installation of a clothing bank has, so far, raised £29 to support the Village Hall.

The County grass-cutting payment had increased by £35, the annual collection at the Remembrance Service was up by £25, the compensation for the trouble of resolving a banking error brought £36 and other smaller receipts came to a further £22 giving a **total increase, in all areas, of £2,638**.

This was offset by reductions of £21 in the contributions to the work of the countryside committee and £1,032 in the VAT refund, a **total decrease of £1,053**, leaving the balance at the stated year-on-year increase of **£1,585**.

**Box 6 - Expenditure** - There has been a marked increase in this year's total from £3,002 to £15,239, an overall **increase of £12,337**. This is accounted for in the following categories.

The Clerk's travel costs increased by **£49** for the additional journeys in relation to arrangements for the Jubilee Celebrations and for the forthcoming Elections.

Office and Administration costs had increased by £587 for the new lap-top, plus £30 across all other expenses in this section, giving a total of **£617**.

Meetings at the Village Hall had returned to the regular frequency, resulting in an increase of £60 for the year, while work sponsored by the council amounted to £319 towards the replacement of the hot water tank, taken from a previous grant, plus £66 for the rewiring needed for an external outlet, bringing the total increase in this section to **£445**.

In the Play Area, the treatment of the safety surfaces required an extra £36, the replacements for the swing seats and chains cost £662 and there were marginal adjustments in other costs, bringing the total rise here to **£700**.

## East & West Barkwith Parish Council

Countryside matters saw the largest increase, mainly due to the cost of the new tractor mower at £5,333, for which the council had been accumulating a reserve over the past few years. Fuel costs had increased as previous donations were no longer available but there was no need for more litter-picking equipment and no winter planting at the War Memorial as the soil needed to rest. The overall increase for these factors amounted to £62, giving a total rise here of **£5,395**.

There were no Special Events in the last financial year but this year's Jubilee was celebrated with the purchase of a Commemorative Clock and the organisation of a Community Gathering at a total cost of £2,906 (much of which was covered by a grant and other donations). Early expenditure for the coming Coronation event has amounted to £340, giving a total, in this section, of **£3,246**.

Donations were higher this year as they included an increase of £25 in the Remembrance Sunday collection for the Royal British Legion, while the local First Responders group were given £60 in appreciation for running a defibrillator training day and a later sum of £80 in response to their special appeal. This brings the total increase for these to **£165**.

The various purchases over the year, resulted in an increase in this year's VAT charges of **£1,720**.

These increases give a **total increase of £12,337**, whilst for the History Group, last year's payment for photograph frames was not repeated and there were no other expenses, resulting in a **decrease of £99**.

From these figures the overall increase in expenditure would total **£12,238**, the extra £1 resulting from the rounding of the outgoings in each section.

## LOCAL AUTHORITY ACCOUNTS: A SUMMARY OF YOUR RIGHTS

**Please note that this summary applies to all relevant smaller authorities, including local councils, internal drainage boards and 'other' smaller authorities.**

### **The basic position**

The [Local Audit and Accountability Act 2014](#) (the Act) governs the work of auditors appointed to smaller authorities. This summary explains the provisions contained in Sections 26 and 27 of the Act. The Act and the [Accounts and Audit Regulations 2015](#) also cover the duties, responsibilities and rights of smaller authorities, other organisations and the public concerning the accounts being audited.

As a local elector, or an interested person, you have certain legal rights in respect of the accounting records of smaller authorities. As an interested person you can inspect accounting records and related documents. If you are a local government elector for the area to which the accounts relate you can also ask questions about the accounts and object to them. You do not have to pay directly for exercising your rights. However, any resulting costs incurred by the smaller authority form part of its running costs. Therefore, indirectly, local residents pay for the cost of you exercising your rights through their council tax.

### **The right to inspect the accounting records**

Any interested person can inspect the accounting records, which includes but is not limited to local electors. You can inspect the accounting records for the financial year to which the audit relates and all books, deeds, contracts, bills, vouchers, receipts and other documents relating to those records. You can copy all, or part, of these records or documents. Your inspection must be about the accounts, or relate to an item in the accounts. You cannot, for example, inspect or copy documents unrelated to the accounts, or that include personal information (Section 26 (6) – (10) of the Act explains what is meant by personal information). You cannot inspect information which is protected by commercial confidentiality. This is information which would prejudice commercial confidentiality if it was released to the public and there is not, set against this, a very strong reason in the public interest why it should nevertheless be disclosed.

When smaller authorities have finished preparing accounts for the financial year and approved them, they must publish them (including on a website). There must be a 30 working day period, called the 'period for the exercise of public rights', during which you can exercise your statutory right to inspect the accounting records. Smaller authorities must tell the public, including advertising this on their website, that the accounting records and related documents are available to inspect. By arrangement you will then have 30 working days to inspect and make copies of the accounting records. You may have to pay a copying charge. The 30 working day period must include a common period of inspection during which all smaller authorities' accounting records are available to inspect. This will be 1-12 July 2019 for 2018/19 accounts. The advertisement must set out the dates of the period for the exercise of public rights, how you can communicate to the smaller authority that you wish to inspect the accounting records and related documents, the name and address of the auditor, and the relevant legislation that governs the inspection of accounts and objections.

### **The right to ask the auditor questions about the accounting records**

**You should first ask your smaller authority** about the accounting records, since they hold all the details. If you are a local elector, your right to ask questions of the external auditor is enshrined in law. However, while the auditor will answer your questions where possible, they are not always obliged to do so. For example, the question might be better answered by another organisation, require investigation beyond the auditor's remit, or involve disproportionate cost (which is borne by the local taxpayer). Give your smaller authority the opportunity first to explain anything in the accounting records that you are unsure about. If you are not satisfied with their explanation, you can question the external auditor about the accounting records.

The law limits the time available for you formally to ask questions. This must be done in the period for the exercise of public rights, so let the external auditor know your concern as soon as possible. The

advertisement or notice that tells you the accounting records are available to inspect will also give the period for the exercise of public rights during which you may ask the auditor questions, which here means formally asking questions under the Act. You can ask someone to represent you when asking the external auditor questions.

Before you ask the external auditor any questions, inspect the accounting records fully, so you know what they contain. Please remember that you cannot formally ask questions, under the Act, after the end of the period for the exercise of public rights. You may ask your smaller authority other questions about their accounts for any year, at any time. But these are not questions under the Act.

You can ask the external auditor questions about an item in the accounting records for the financial year being audited. However, your right to ask the external auditor questions is limited. The external auditor can only answer 'what' questions, not 'why' questions. The external auditor cannot answer questions about policies, finances, procedures or anything else unless it is directly relevant to an item in the accounting records. Remember that your questions must always be about facts, not opinions. To avoid misunderstanding, we recommend that you always put your questions in writing.

### **The right to make objections at audit**

You have inspected the accounting records and asked your questions of the smaller authority. Now you may wish to object to the accounts on the basis that an item in them is in your view unlawful or there are matters of wider concern arising from the smaller authority's finances. A local government elector can ask the external auditor to apply to the High Court for a declaration that an item of account is unlawful, or to issue a report on matters which are in the public interest. You must tell the external auditor which specific item in the accounts you object to and why you think the item is unlawful, or why you think that a public interest report should be made about it. You must provide the external auditor with the evidence you have to support your objection. Disagreeing with income or spending does not make it unlawful. To object to the accounts you must write to the external auditor stating you want to make an objection, including the information and evidence below and you must send a copy to the smaller authority. The notice must include:

- confirmation that you are an elector in the smaller authority's area;
- why you are objecting to the accounts and the facts on which you rely;
- details of any item in the accounts that you think is unlawful; and
- details of any matter about which you think the external auditor should make a public interest report.

Other than it must be in writing, there is no set format for objecting. You can only ask the external auditor to act within the powers available under the [Local Audit and Accountability Act 2014](#).

### **A final word**

You may not use this 'right to object' to make a personal complaint or claim against your smaller authority. You should take such complaints to your local Citizens' Advice Bureau, local Law Centre or to your solicitor. Smaller authorities, and so local taxpayers, meet the costs of dealing with questions and objections. In deciding whether to take your objection forward, one of a series of factors the auditor must take into account is the cost that will be involved, they will only continue with the objection if it is in the public interest to do so. They may also decide not to consider an objection if they think that it is frivolous or vexatious, or if it repeats an objection already considered. If you appeal to the courts against an auditor's decision not to apply to the courts for a declaration that an item of account is unlawful, you will have to pay for the action yourself.
