Establishing Your Business in the United States as a Platform for Global Reach Conference

Our Soft Landing client, Mauricio Toro from TECHFIT Digital Surgery, is part of a Colombian entity that helps small and large companies to scale. The name of this entity is RutaN Medellin. RutaN Medellin's president reached out to us and asked if we could host five of his clients who are going to be on a mission to select sites in the U.S. Establishing a business in the United States of America could be a difficult challenge that affects every department of any given company. This challenge represents an obstacle for global expansion. Our goal is to introduce them to our Soft Landing program which will help them through this process, as well as help them to understand how to establish their operations and create a platform for global reach.

The three-day conference, "Establishing a Business in the United States as a Platform for Global Reach," will be held November 13 - November 15 and it is going to be sponsored by Team Volusia. This conference will have multiple speakers throughout these days including Gordon Hogan on behalf of the Soft Landing program, Rob Ehrhardt representing Volusia County, Jorge Arce from the U.S. Commercial Service office and many more. The CEOs will learn and experience the American culture, the immigration process, as well as gain insights of the American market and how to reach out to it. In addition, they will learn how to analyze markets and become familiar with legal, regulatory, and ethics compliance issues for foreign businesses entering the U.S. Market. Finally, everyone will have the opportunity to become familiar with the local businesses community by going on a tour around Volusia County. By the end of the program, company leaders will have a better understanding of how to "Establish a Business in the United States as a Platform for Global Reach." We may open the conference to other Soft Landing companies located in other UCF Business Incubators around Central Florida.

This annual event is set to take place on February 28, 2019 at the ATC Daytona State College. The deadline for the submission of applications is January 30, 2019.




Technology Meetup:

Technology Education for Kids:


