

SCHOLARSHIP APPLICATION AND GENERAL RULES

ELIGIBILITY:

YOUTH SCHOLARSHIP APPLICANTS MUST BE 17-20 YEARS OLD, RESIDE IN ADAMS COUNTY, AND INTEND TO ENTER A TRADES-BASED FIELD. PARTICIPATION IN THE LOGGERS JUBILEE IS PREFERRED, AS IS A HISTORY OF COMMUNITY SERVICE/VOLUNTEERISM.

COMMUNITY SCHOLARSHIP APPLICANTS MUST BE A LOCALLY OWNED BUSINESS, OPERATING IN ADAMS COUNTY. PARTICIPATION IN THE LOGGERS JUBILEE IS PREFERRED, AS IS A RECORD OF SERVICE TO THE COMMUNITY.

INTERESTED APPLICANTS MUST SUBMIT A COMPLETE APPLICATION TO THE COUNCIL LOGGERS JUBILEE BOARD VIA HARD COPY OR EMAIL (COUNCILLOGGERSJUBILEE@YAHOO.COM) BY JULY 4TH TO BE ELIGIBLE TO RECEIVE A SCHOLARSHIP. ALL APPLICATIONS WILL BE REVIEWED BY A COMMITTEE OF LOGGERS JUBILEE BOARD MEMBERS. PREFERENCE WILL BE GIVEN TO INDIVIDUALS AND ORGANIZATIONS WHO PARTICIPATE IN THE LOGGERS JUBILEE. AWARD RECIPIENTS WILL BE ANNOUNCED BY JULY 30TH FUNDS WILL BE ISSUED DIRECTLY TO AWARD RECIPIENTS. PROOF OF APPROPRIATE USE OF FUNDS MUST BE SUBMITTED TO THE LOGGERS JUBILEE BOARD WITHIN 30 DAYS OF RECEIPT OF FUNDS.
