- ❖ Stihl 500i chainsaws are ONLY allowed in the Large Saw Competition.
- ❖ Stihl 500i chainsaws are NOT permitted in the Medium Saw Competition.
- ❖ Contest judges have final authority regarding saw eligibility.
- ❖ A signed Liability Waiver is required for all participants.
- ❖ Participants under 18 years of age must have a parent or legal guardian sign the waiver.
- ❖ Personal Protective Equipment (PPE) is strongly encouraged, including eye and hearing protection.
- ❖ No open-toed shoes allowed.

- ❖ Full-length pants are required for all contestants.
