Slate elected unanimously.

Jenn took over the meeting at this point.

Year End Awards Dinner: Discussion was held around dates and locations. Consensus was to return to the Bomoseen Lodge. Food was good, location was central. Lindsy will make the reservations again for January 25th at 5:00 PM. Snow date to be 2/1. Deb will send out a flyer to receive the RSVPs for attendance.

Amount to spend on awards up for discussion. Last few years we have spent \$30/\$15 for awards. The treasury is up compared to last year. This triggered a discussion around membership and point fees. It was determined, we would leave the fees as is for now. Bernie did some math and if we leave the award amounts at 30/15 the total would be \sim \$900, if we increase the amounts to 40/20 the cost would be \sim \$1200.

Patricia/Bernie made a motion to increase the amounts spent on year end awards to \$40/\$20. Opened up for discussion. Bernie/Jan amended the motion to \$35/\$18. Motion passed. We will spend \$35/champion and \$18/reserve for 2025. Everyone winning awards should get their award requests to Deb. If it is something like a belt buckle that requires customization, she will need to know ASAP.

Jenn suggested that for 2026 we consider expanding the number of places we award for year end, with declining values. Potentially increasing the point fees per horse to cover the additional awards.

2025 Show discussion:

Changes to make – show secretary; simplify the entry form by taking off the stalls, campers and shavings. The holding area at the end of the ring for the pattern classes worked well, but not for the rail classes. Gate needs to be closed for safety. Good things – Patricia's two daughters were great to run

cards up the hill. Raffle still is a fun addition to make a little more money and get exhibitors together. Overall our group of workers works well together. The weather this year was great.

2026 ideas – Ask Lori Wunderlich to come back as secretary. Her expertise and credibility are invaluable. More syrup awards, bring back goodie bags, all Ranch events on Friday, all games events on one day, maybe showmanship on Saturday with regular trail on Sunday AM. Send out a survey or post asking for exhibitor's feedback. More changes to be discussed at the board level.
