

## McMullin Expansion Project Plans Set to Go Out to Bid in Early 2023

Plans for the McMullin On-Farm Flood Expansion Project are set to go out to construction companies for bid during the spring of 2023.

The McMullin Expansion Project design phase is nearly complete. The design engineers, Provost & Pritchard, are working with the NRCS and other permitting agencies to address minor design comments. A draft National Environmental Policy Act (NEPA) document is expected to be available for public review and comment during winter 2022.

The McMullin Area Groundwater Sustainability Agency (MAGSA) is coordinating meetings between appraisers and landowners to assess sections of their land where a canal might be constructed as part of the Expansion Project. MAGSA will use this information to offer landowners a fair price for the entire range of costs associated with the construction of an easement on those sections of their properties.



The grant-funded McMullin Expansion Project will more than double the existing surface water conveyance capacity in the region and increase the potential farmland acreage capable of receiving flood and storm water flows for on-farm recharge to about 15,000 acres. **Learn more about the McMullin Expansion Project and view a larger version of the map above at:** www.mcmullinarea.org/ofr.

## RCWD Considers New Projects in Coordination with Aquaterra Water Bank

Over the next few months, the RCWD Board will consider potential projects in the District that could work in conjunction with MAGSA's plans for the Aquaterra Water Bank. Such projects could include on-farm distribution systems and additional recharge basins.

#### About the Aquaterra Water Bank: The

Aquaterra Water Bank will include a system of pumping stations, canals, recharge sites, and extraction wells designed to convey water to groundwater banking and recharge sites. Like a financial bank, water can be "deposited" into Aquaterra in wet years for storage and "withdrawn" in drier years. Learn more at: www.aquaterrabank.org.
