CRYSTAL TOWNSHIP BOARD MONTCALM COUNTY, MICHIGAN Resolution No. 24-017

At a Regular meeting of the Crystal Township Board ("Township Board") held at the Township offices on July 10, 2024, beginning at 7:00 p.m., the following Resolution was offered for adoption by Township Board Member Baker-Marek and was seconded by Township Board Member Little:

A RESOLUTION TO INCREASE SEWER SYSTEM SERVICE RATES

- (1) The Crystal Township Sewer System ("CTSS") is a public sewer system owned and operated by Crystal Township ("the Township").
- (2) The Township Board previously established sewer rates for the CTSS and increased the rates in or about 2011.
- (3) The Township Board is authorized by law to increase sewer rates from time-to-time to cover the administration, operation, and maintenance of the CTSS.
- (4) At a June 2024 meeting, the Township Board approved a motion to increase the sewer rates to \$30.00 per month effective July 1, 2024.
- (5) The Township Board finds it necessary to annually increase the sewer rates by 3% to provide for payment of the expenses of administration, operation, and maintenance of the CTSS.

NOW, THEREFORE, BE IT HEREBY RESOLVED AS FOLLOWS:

(1) The rates for the CTSS sanitary sewer services shall be as follows:

Monthly Usage Charge: \$30.00 per user.

Effective Date: July 1, 2024

- (2) Commencing July 1, 2025, the above rates shall increase by 3% per year every calendar year over and above the preceding calendar year on and after the effective date of this Resolution, and such increases shall take effect on July 1 of every year.
- (3) All prior resolutions, parts of resolutions, or motions insofar as they are in conflict with the provisions of this Resolution are hereby rescinded to the extent of any conflicts.
- (4) This Resolution shall become effective immediately.

The vote on the motion to adopt this Resolution was as follows:
