POOL PASS INFORMATION:

To get a pool pass you must prove residency with a photo id and fill out a **RESIDENT INFORMATION CARD**. You can obtain a resident information card at the office. Pool passes for **NEW** residents are free.

To obtain a pass you must prove residency in Woodlyn Crossing for each member of your household. Some forms of proof include a driver's license, a school transcript with an address, birth certificates for children with their parent's id, or Passport/immigration papers.

RETURNING RESIDENTS: Each Woodlyn Crossing resident will be able to use their pool passes from last year. Please take the time to look for your pool pass and store it in a safe place for use throughout the year and the following years.

NANNY PASSES: Pool passes for children's caretakers are available for the season for a fee of \$125.00. Homeowners are required to accompany the caretaker, with an acceptable id for the pass to be issued. The nanny pass is for a specific person and is non-transferable. These passes are good for the season issued and must be updated and renewed on a yearly basis. These will allow an adult other than the resident parent to accompany a child to the pool.

POOL SECURITY: A staff member will be sitting at the entrance podium checking the pool passes of all residents coming into the pool. They will also be collecting completed/signed release forms. The resident must sign in and give an emergency phone number. It will be the lifeguard's responsibility, as well, to reprimand anyone who breaks any rules or behaves in a manner not suited for the swimming pool. All parents should expect a telephone call from the pool staff if their child misbehaves and is asked to leave the premises. The lifeguards are there for swimmer's safety, they are not babysitters. **Children 12 and under must be accompanied by an adult age 18 and over. Children age 13 and up can utilize the pool unaccompanied.** If you bring your child(ren) to the pool and leave, you will be told to come back and pick him/her up and this behavior will result in the loss of your pool privileges.

SWIMWEAR: All individuals using the pool must wear appropriate swim attire. All female children and adults must wear their bathing suit top at all times. There is no changing into your bathing suit or out of your bathing suit on the pool deck; there are restrooms for your use. All adults must wear appropriate (family friendly) swimwear. Anyone who does not adhere to these regulations will be asked to leave immediately.

SMOKING: The pool is a non-smoking facility. The Board voted to designate a smoking area near the front steps on driveway. The pool staff has the authority to enforce this rule and the right to eject people from the pool for not complying. The Board reserves the right to revoke this designated smoking area if we encounter too many problems.

POOL PARKING: Please be aware that occasionally there is a parking problem at the Pool. Walk to the pool whenever possible. **PLEASE DO NOT USE WOODBRIDGE COURT NORTH & SOUTH PARKING LOTS FOR POOL PARKING!!** Only residents of Woodbridge Courts, North and South may park on those streets during pool hours. There is absolutely **NO PARKING** allowed in the pool/office driveway or on Valley Stream Circle in front of the pool, **NO EXCEPTIONS**. Handicap parking is reserved for those with Handicap tags or placard **ONLY**. Failure to adhere to these rules may result in the loss of pool privileges.

INCLEMENT WEATHER: *It is at the discretion of the Woodlyn Crossing Homeowners Association Staff as to whether the pool will be closed because of inclement weather. If it closes mid-day, there is the likelihood that it will not reopen until the next day. The pool staff will post a sign on the fence indicating the time that the pool will re-open or you can check information on Facebook at Woodlyn Crossing HOA Pool.*

- 8. Children under 12 years of age must be accompanied by an adult age 18 and over. Children age 13 and up can utilize the pool unaccompanied. Please do not bring your children under the age of 13 to the pool and then go home. You will be told to come back and pick him/her up and this behavior will result in the loss of your pool privileges.***
- 9. "Non-swimmers" using the big pool must be accompanied by an adult and that adult must stay with-in arm's reach of the "non-swimmer".***
- 10. Pool passes must be shown at each admittance. Residents must sign in with their address and emergency contact info upon entering the pool area.***
- 11. Homeowners are responsible for their families (& guests) and their actions. All radios must be played at a tolerable noise level so as not to interfere with other resident's peaceful enjoyment of the pool. If reasonable complaints are made guests will be requested to lower the volume. Foul language, spitting, or unruly behavior is prohibited. Guest tags are not transferable and may be revoked for any infraction of the rules. Please clean up after yourselves!!***
- 12. No inappropriate bathing attire will be tolerated during normal pool hours and the person will be asked to leave or change.***
- 13. No one is permitted in the pool with open sores or rashes.***
- 14. Members are responsible for their own chairs. (They may be left against fence.) Chairs around the pool must be 4 ft. from the pool's edge. This is for better visibility by the lifeguards and others.***
- 15. The Baby Pool is for children five (5) years of age and under. The children in the Baby Pool must be accompanied by an adult. There is no guard posted at the Baby Pool.***
- 16. All children WEARING DIAPERS (i.e. not potty trained) MUST wear elastic pants with snug elastic legs and tops or Little Swimmers© (diapers available for the water). The child may not swim in just a diaper. NO EXCEPTIONS! There will be a fine* levied against anyone defecating in the pool.***
- 17. The lifeguards are on duty for water safety purposes. They have not been hired to babysit. Please remember that all parents/guardians are responsible for their children and their behavior.***
- 18. Woodlyn Crossing HOA will not be responsible for loss by any cause whatsoever of clothing, jewelry, valuables or any personal property. Please leave your valuables at home.***

NANNY PASSES: Pool passes for children's caretakers are available for the season for a fee of \$125.00. Homeowners are required to accompany the caretaker, with an acceptable id for the pass to be issued. The nanny pass is for a specific person and is non-transferable. These passes are good for the season issued and must be updated and renewed on a yearly basis. These will allow an adult other than the resident parent to accompany a child to the pool.

POOL SECURITY: A staff member will be sitting at the entrance podium checking the pool passes of all residents coming into the pool. They will also be collecting completed/signed release forms. The resident must sign in and give an emergency phone number. It will be the lifeguard's responsibility, as well, to reprimand anyone who breaks any rules or behaves in a manner not suited for the swimming pool. All parents should expect a telephone call from the pool staff if their child misbehaves and is asked to leave the premises. The lifeguards are there for swimmer's safety, they are not babysitters. **Children 12 and under must be accompanied by an adult age 18 and over. Children age 13 and up can utilize the pool unaccompanied.** If you bring your child(ren) to the pool and leave, you will be told to come back and pick him/her up and this behavior will result in the loss of your pool privileges.

SWIMWEAR: All individuals using the pool must wear appropriate swim attire. All female children and adults must wear their bathing suit top at all times. There is no changing into your bathing suit or out of your bathing suit on the pool deck; there are restrooms for your use. All adults must wear appropriate (family friendly) swimwear.
