Then, they've coordinated with BATV and scheduled three candidate forums.

On September 30, 2024, we will host forums for: Kane County Auditor Coroner; 5 County Board Districts (2,10,12,14,18) and the Kane County Board Chair.

The October 1, 2024, candidate forum will include: Kane County Recorder Circuit Clerk, Kane County State's Attorney, Illinois House District 65, and Illinois House District 70.

Finally, on October 9, 2024, our forum will include: the 11th Congressional; the 25th State Senate seat, the 49th State Representative position and the Sandra Parga v. David Kliment for Kane County Judge.

At least 10 clean-energy advocates in St. Charles made public statements against early renewal of the IMEA contract at the August 19 St. Charles City Council meeting.



They were supported by the presence of another 30 or so advocates, including Naperville and Winnetka advocates, and over 300 signatures on a petition.

The St. Charles advocates are making an impact on St. Charles' decision about the IMEA renewal contract. Following the August 19 City Council meeting, the City posted on its Facebook page that City Council has postponed making a decision about the contract until Spring 2025!!!

Of course, there is still work to do--advocates need to make sure that the City is making constructive efforts between now and Spring 2025 to consider realistic alternatives to IMEA. More information about future action plans will be coming soon!

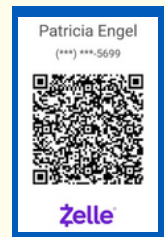
