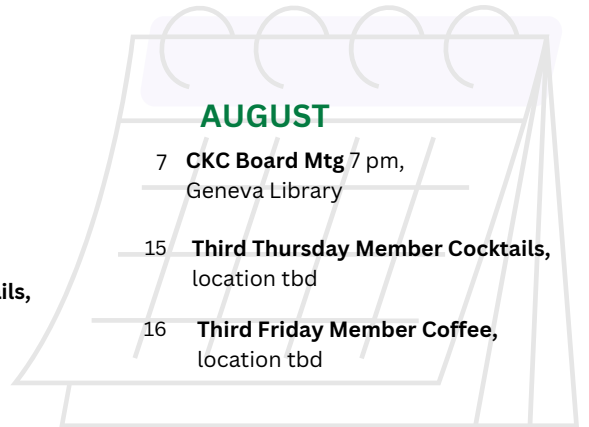

Legislative Wrap Up In Springfield:

The IL General Assembly wrap the 2024 Session with some good wins which included a balance budget; increasing the Child Tax Credit and providing much needed funding for immigrant services.

However, there still remains unaddressed legislation that the League considers crucial:

- Senate Bill 2633 (Karina's Bill) addressing the safety concerns of domestic abuse victims by removing firearms from their abuser.
- House Bill 5386 along with SBo771 protecting the state's wetlands.

Our hope is to see the GA revisit these bills (and a few others) during the Fall Veto Session. Visit ILGA.gov to keep track of what's going on, and remember these bill numbers are only associated with the current 103 GA.
