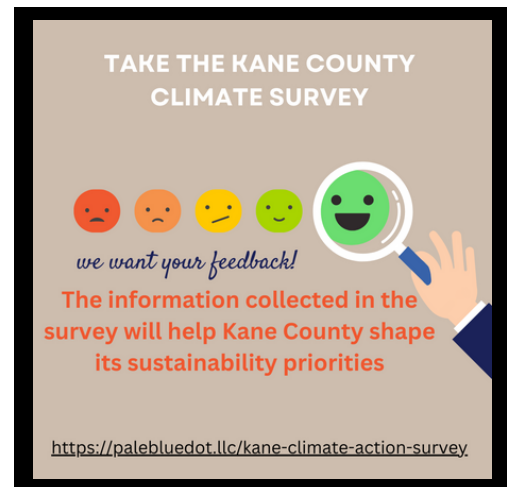

A federal judge temporarily blocked enforcement of portions of Florida’s anti-voter law, SB 7050. Specifically, the preliminary injunction prevents Florida from penalizing nonpartisan civic organizations like LWVFL if any of their volunteers who help register voters are not US citizens.
