Twelve dogs received heartworm treatment, 29 dogs were spayed/neutered, 68 dogs and 2 cats received medical treatment, and 5 dogs received sponsored training. These activities, as well as providing support for the hike and run groups, providing Kongs, chew toys, and healing hearts packs for canine enrichment, improvements and expansion of outdoor kennels and dog play yards, and providing adoption program support such as collars, leashes, harnesses, and other supplies, contributed to preparing dogs to enter their forever homes. In addition, our dog transport van traveled over 2,000 miles taking 33 dogs to rescue partners.
