Heartworm treatments were provided to 42 dogs, 159 dogs were spayed/neutered, 169 dogs received medical treatment, and 22 dogs received sponsored training. These activities, as well as providing support for the hike and run groups, providing Kongs, chew toys, and healing hearts packs for canine enrichment, improvements and expansion of outdoor kennels and dog play yards, and providing adoption program support such as collars, leashes, harnesses, and other supplies, contributed to preparing dogs to enter their forever homes. In addition, our dog transport van traveled over 7,400 miles transferring 68 dogs to rescue partners.
