\*Cut when ball is out of the zone...illegal

\*Wingback...cut is illegal. He was not in the FBZ @ the snap it's illegal

\*Focus on Center....took a step back, then went low. Illegal MUST BE IMMEDIATE. 3 steps is NOT immediate

\*D End CANNOT low cut outside the FBZ. ILLEGAL
