## Makeup Services Agreement

This agreement ("Agreement") is entered into between the undersigned makeup artist ("Artist"), 3 Deep Rituals, and the client ("Client") on this day of [date].

#### 1. Event Details:

The makeup services will be provided for the following event: [event description]. The event will take place on [date] at [time] at the location specified below.

# 2. Date, Time, and Place:

The makeup services will be provided on [date] at [time] at the following location: [venue/address].

#### 3. Services:

The Client agrees to pay the Artist the total amount of [total amount] for the makeup services provided. A deposit of 25% is due at the time of booking and is nonrefundable. The remaining balance is due on the day of the service, prior to the rendering of services.

### 8. Service Modifications and Full Payment:

Once this contract is signed, no additional services may be added, and all listed services must be paid in full. The agreed-upon funds are due whether all listed services are received or not.

## 9. Deposit Refund:

In the event that the Artist is unable to complete the job, the deposit will be refunded within 15 days.

# 10. Booking Process and Intellectual Property:

All bookings must be made official by booking online at 3deeprituals.com. By agreeing to this contract, the Client allows 3 Deep Rituals to advertise using their intellectual property (photos, videos, etc.) from the provided makeup services.

#### 11. Late Fee:

If the Client is more than 15 minutes late for the scheduled appointment, a late fee of one dollar per minute will be charged.

# 12. Client's Responsibilities:

The Client agrees to come with a clean face, freshly washed, and teeth brushed before the makeup application.

## 13. Additional Artist Fee:

If an additional artist is needed for the job, the Client agrees to pay an additional fee associated with the party and its travel.

### 14. Governing Law:

This Agreement shall be governed by and construed in accordance with the laws of [state/country]. Any disputes arising out of or in connection with this Agreement shall be resolved through amicable negotiations between the parties.
