





## **Collection Care Notes**



Nomex in a collection storage space, 2020

Have you heard of meta-aramid? It is most commonly recognized by its brand name "Nomex". This material has fire-resistant qualities and is often used in fire fighting equipment. For collections, it is a great tool to use if storage is

undergoing renovations or fire suppression system is down, just in case. The material can be ordered by the yard and draped over high risk collections.
