

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to myyellowjersey.com and My Yellow Jersey and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to My Yellow Jersey include myyellowjersey.com. The My Yellow Jersey website is a News and Information site. By using the My Yellow Jersey website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered on our Site, My Yellow Jersey may collect personally identifiable information, such as your:

- First and Last Name
