## Article 9

Be courteous to everyone, show empathy and concern for people in need.

When issues of disrespect and matters requiring disciplinary action arise due to the abuse of these Articles and the intentional mis-speaking of the meanings and intent as a weapon against each other, they will be brought to the attention to the proper Branch of the Government of The United States of America. If said issues are not resolved by the proper Branch, they will be brought to the attention of the general post office for The United States of America and the various branches of the reign of the heavens.

YOUR COMPLAINT IN AFFIDAVIT FORM WILL BE REVIEWED BY THE REGISTRAR TO DECIDE WHICH DEPARTMENT WILL ARBITRATE THE DISPUTE.
