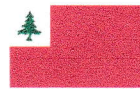

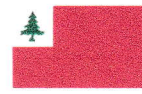

Statement of Facts:

1. On or about July 22nd, 2025, a Public Records Request in the nature of Discovery and Disclosure (Instrument #: MPK2025PRR2207) was sent to the County Treasurer, specifically addressing Gerard T. Yost, Kyle Stone, Alexander Zumbar, and Chryssa N. Hartnett, rightfully demanding the production of their public official surety bonds. This request was made pursuant to the Freedom of Information Act (5 U.S.C. § 552) and the Ohio Public Records Act.
2. All public officials are required by federal, state, and municipal law to provide the name, address, and telephone number of their public hazard and malpractice bonding company and the policy number of the bond, and if required, a copy of the policy describing the bonding coverage of their specific job performance. Failure to provide this information constitutes corporate and limited liability insurance fraud (15 USC) and is prima-facie evidence and grounds to impose a lien upon the official personally to secure their public oath and service of office.
3. The Ohio Revised Code explicitly states bond requirements for county officials. Specifically, the Stark County Treasurer is bound by Ohio Revised Code Section 321.02, requiring such bond, along with the Oath of Office, to be deposited with the County Auditor's office before entering upon the discharge of official duties. The Stark County Prosecutor (Kyle Stone) is bound by Ohio Revised Code Section 309.03, requiring his bond, with court approval and oath of office, to be deposited with the County Treasurer before entering upon official duties. A bond is required for a county official to protect the public from financial harm if the official commits fraud, neglects their duties, or otherwise violates the terms of their office.
4. Gerard T. Yost, Kyle Stone, Alexander Zumbar, and Chryssa N. Hartnett have failed to produce the demanded surety bonds for the public record. The Chief Deputy Treasurer responded with Alexander Zumbar's Oath of Office but omitted his surety bond, implying that Kyle Stone and Gerard T. Yost's surety bonds were not deposited with the Treasurer's office. Gerard T. Yost also responded with his and Kyle Stone's Oaths of Office, omitting their surety bonds.
5. This failure to produce required surety bonds constitutes a default to the Public Records Request and signifies a dereliction of duty and failure to honor their bond.
6. The aforementioned individuals, Kyle Stone, Gerard T. Yost, Alan Harold, Alexander Zumbar, and Chryssa N. Hartnett, are identified as "Wrongdoers" and Lien Debtors. They are in violation of many Constitution, Bill of Rights, and Treaties violations by invoking an unlawful foreclosure (Libels/Case#: 2024CV01949) without having or producing a bond and neglected to provide lawful jurisdiction and delegation of authority.
7. Their actions are considered to be unlawful under the color of law, as public officials operating without proper commercial bonds lack commercial reality and the power of official signature. When officials operate without bonding, it means no responsibility, no power of official signature, and no real corporate political power.
8. Such actions, including the failure to produce bonds and the continuation of unlawful proceedings, are considered criminal acts without exception. These actions have been described as impersonating officers or being in dereliction of duty, and are connected to allegations of conspiracy against rights, extortion, fraud, false statements, and racketeering (18 USC 241, 872, 1001, 1961).



9. By failing to respond to the demands for surety bonds, the named individuals are in contractual default and have admitted to and acquiesced to the claims made against them. Their continuing on with these wrongful actions constitute knowledgeable and willful criminal assaults and breach of contract.

FURTHER AFFIANT SAITH NOT. Please be advised that your failure to respond, within the stated (**CLEAR DAYS**) of the date of **July 22nd, 2025**, has been deemed by this Affiant to invoke the doctrine of acquiescence and admission. Your silence, where there is a legal or moral duty to speak, will be equated with fraud, and everything in this Notice will stand as true, correct, legal, lawful, and binding upon you, without protest or objection. A commercial lien will allow for the recovery of lost or damaged properties, plus damages, penalties, and costs in commerce.
