2. Indigenous peoples have the right to own, use, develop and control the lands, territories and resources that they possess by reason of traditional ownership or other traditional occupation or use, as well as those which they have otherwise acquired.
3. States shall give legal recognition and protection to these lands, territories and resources. Such recognition shall be conducted with due respect to the customs, traditions and land tenure systems of the indigenous peoples concerned.

Cujus est solum eus est usque ad coelum et ad inferos

Principle 1

The authors of the Charter of the United Nations had in mind that “**Chapter XI**” should be applicable to territories which were then **known to be of the colonial type**. An obligation exists to transmit information under Article 73 e of the Charter in respect of such territories whose people have not yet attained a **full measure of self-government**.

B. to develop self-government, to take due account of the political aspirations of the peoples, and to assist them in the progressive development of their free political institutions, according to the particular circumstances of each territory and its peoples and their varying stages of advancement;

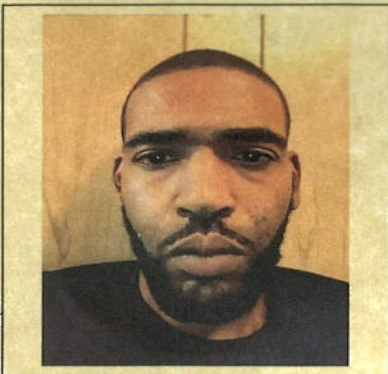
