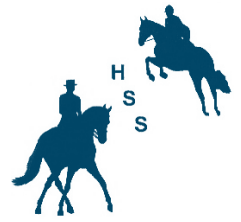


High Standard Stables

Dressage and Combined Test Show

Saturday, June 27, 2026 (rain date July 11, 2026)



Close Date: June 9, 2026 (late entries accepted if space allows. Late fee will apply)

Entry Dressage: \$35/ individual test

Entry Combined Test: \$75/test

Extra Stadium round: \$15/class

Day Stall: \$35 very limited 10'x10' outdoor pens. Please clean before leaving.

Non Showing Horse Fee \$35

Tentative Schedule:

Starting with Novice level Combined test at 8:00am. Individual dressage tests will begin after Combined Tests finish. This show will run as efficiently as possible so please be ready at your scheduled time and listen to announcements if we are running ahead of schedule.

Bad Weather:

In case of bad weather or too much rain prior to the show, the rain date will be July 11.

Ride Times:

Will be posted on www.HighStandardStables.com/shows and a link on our Facebook page the Tuesday before the show. Ride times will also be emailed so please write legibly on entry form.

Dressage Tests:

Links to tests will be on our website www.HighStandardStables.com/shows

Extra Stadium Round:

If you want a little extra practice with the stadium round you can add an extra stadium round and ride it at the conclusion of that division. If adding day of show please go to secretary to pay the \$15 (exact change, or check made out to Amy Becker) for the extra ride.

Schooling:

There is an 80'x135' arena for dressage warm up and a grass area for stadium warm up. Jump arena will be open for schooling from sunrise til 7:15am day of show. Please do not adjust the heights of the jumps. No schooling permitted in the dressage arena. You may ride around the outside of the dressage arena from sunrise til 7:15am. If you need to lunge your horse, please use the roundpen.

Awards:

Combined Tests: Prize for 1st place and 1st-8th place ribbons per division

Individual Dressage Tests: 1st-8th place ribbons for each test. There will also be a Champion/Reserve for In Hand division, USDF Intro division, & USDF Training Level division. You must compete in at least 2 tests in one of the divisions to qualify.

Show Attire:

All riders must wear a fastened well fitted ASTM SEI approved helmet at all times while mounted on a horse. Riders may wear a polo shirt instead of a show jacket if they choose to. Boots with half chaps will be acceptable.

Non Showing Horses:

Must still submit entry, release form, coggins, and rhino/flu vaccine record.

Dogs:

If you absolutely have to bring your dog, it must remain on a leash at all times and please submit rabbies vaccination record with entry.

Facilities:

120'x220' jump arena, 20mx40m dressage arena, 80'x135' warm up sand arena, 2 outdoor wash stalls with cold water only, 1 wash stall with hot/cold water, roundpen to use for lunging, limited outdoor 10'x10' pens.

Refund:

If you scratch before close date, you get your money back less the \$35 office fee. Scratching after closing date, no refund unless letter from vet stating your horse is lame. You must email

Send Entry Form, Release Form, (Check made out to Amy Becker), Copy of original coggins dated within one year of show, copy of rhino/flu vaccine record given by a vet within 6 months of show date.

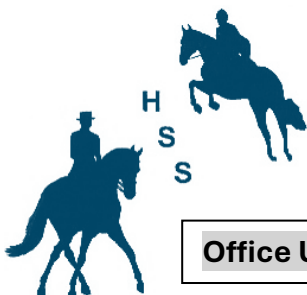

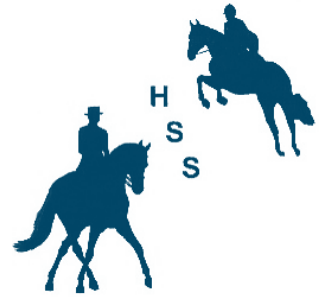
